
LCSO Narcotics Nabs Madisonville LC Meth Maker

The report states, Sqt. Billy Hall, LCSO. Narcotics Division. responded to a domestic dispute in the parking lot of the · Food Lion in Tellico Village, Sgt. Hall made contact with Michael Ritchey, sitting in the driver's seat of his white Dodge truck, parked in front of Food Lion. After a brief investigation, Ritchey was placed into custody for assault by domes-

tic violence. While searching him, Investigator Shane Ezell, LCSO, located a bag, on Ritchey's person, containing suspected methamphetamine and a straw used to snort the drug. A search of Ritchey's truck, turned up several items used to manufacture methamphetamine in the passenger compartment. The items consisted of a water

iar that contained unknown chemicals along with fertilizer and small pieces of lithium metal strips, a plastic bag with fertilizer and several loose coffee filters. . The jar with the unknown chemicals, mixed with fertilizer and lithium strips is known as a "mother Jar" used in the one pot manufacturing method. Fertilizer and cooler with a glass lithium metal along with other chemicals are mixed in the mother jar to convert pseudo ephedrine or ephedrine into methamphetamine. While reviewing the video surveillance from the store, Sgt. Hall observed Michael Ritchey drive into the parking lot and his wife jumping out of the passenger side of the truck while the truck was still in motion. Then Michael Ritchey exited the

was able to escape. LCSO Patrol Division charged Ritchey with assault by domestic violence and after further investigation and interviews with his wife, it was discovered that she had apparently been kidnapped from the city of Vonore. Vonore Police Investigators are expected to obtain warrants on Ritchey for that offense. Sqt. Billy Hall, LCSO-ND, made the arrest. Investigator Shane Ezell, LCSO, was also on scene.
