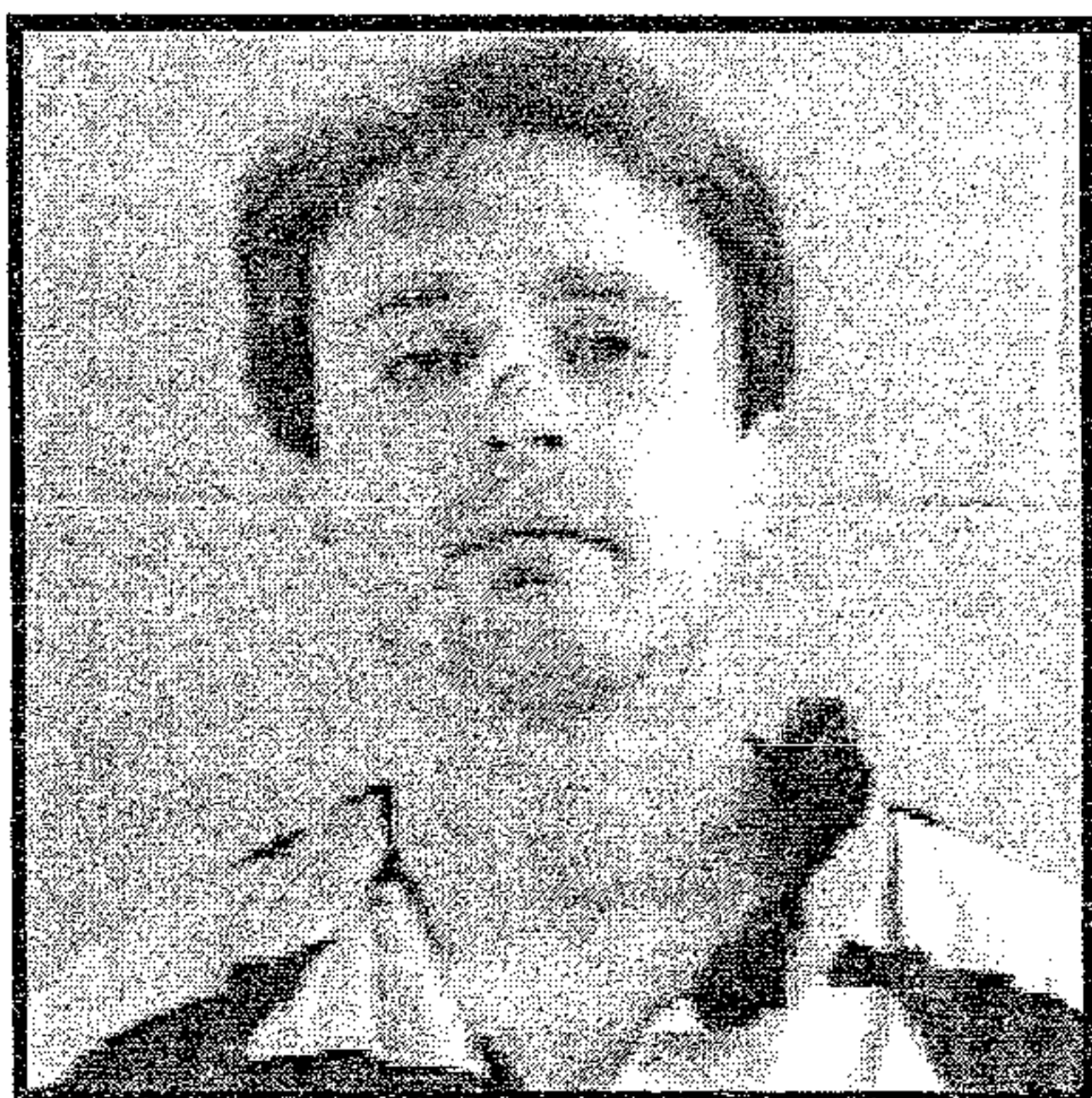

Tonia Sharon Johnston, 36, Johnston Lane, Kingston was charged with reck-

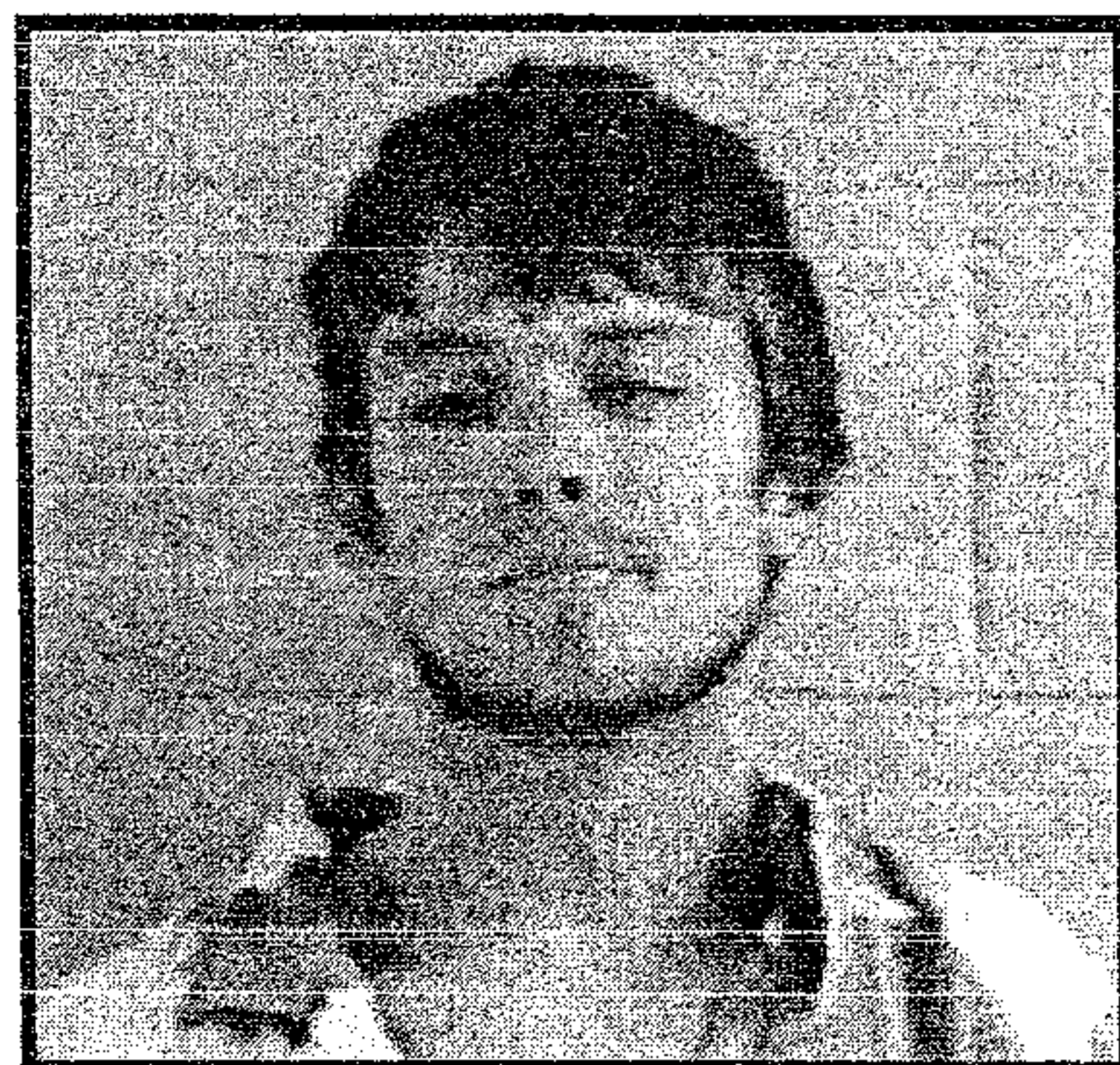

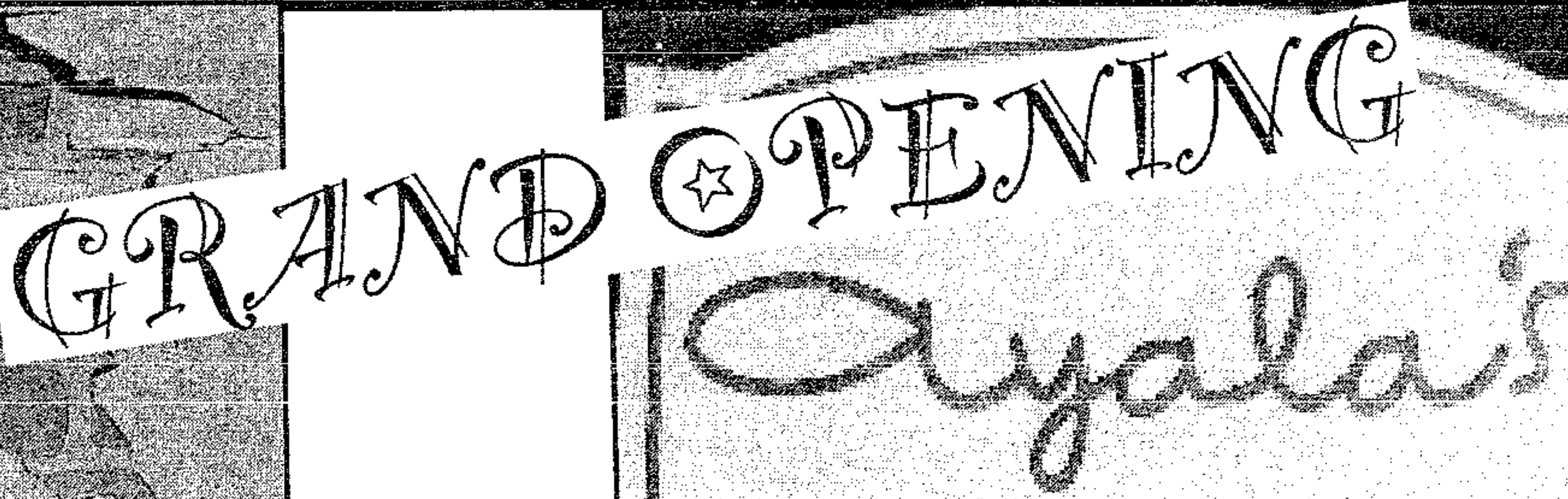

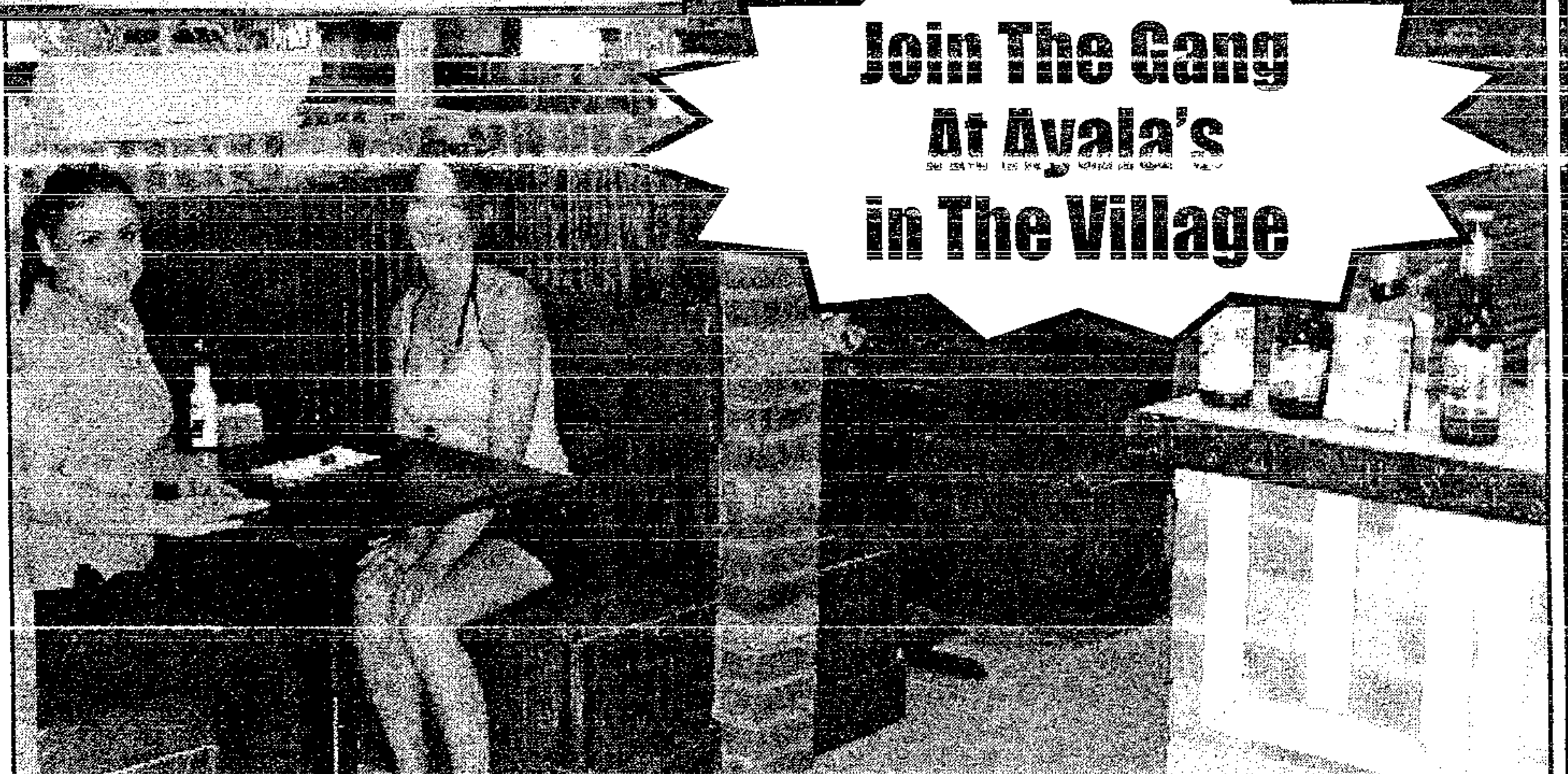

According to reports, Sunday, at approximately 8:45 pm, Deputy James Rowman, LCSO responded to Big Hill Road in reference to a physical domestic involving a firearm. One of the victims, Mrs. King stated she and her son Samuel were in a verbal argument and she ended up going to her bedroom and locking herself in. When Samuel followed her towards the bedroom and began beating on the door, telling her to open the door, she called her husband, the other victim, and told him she needed help inside with their son.

Mr. King stated he came in the front door and found his son in the living room cleaning up some books. When he asked him what was going on, Samuel charged him in an aggressive manner to the point where he was in such fear he picked up a iron fire stick to defend himself with. Samuel

took the iron stick away from his father and engaged in a physical fight with Mr. King causing visible injury to Mr. King's forehead and his left hand.

Mr. King then pinned Samuel on the floor of the living room, under a piano. Mrs. King came in the front door armed with a firearm in her hand due to the fact Samuel put her in such fear.

Mr. King asked his wife to help him get their son under control and call 911, and she retrieved a power cord and gave it to her husband and he tied Samuel's legs together with the cord in order to restrain him from injuring anyone else any further.

Deputy Rowman determined Samuel King to be the primary aggressor and took him into custody. All parties refused medical treatment.

**Rates**

for September 2010 was unchanged at 9.6 percent.

County non-seasonally adjusted unemployment rates for September 2010, released today, show that the rate decreased in 85 counties, increased in seven counties and remained the same in three counties.

Lincoln County registered the state's lowest county unemployment rate at 6.0 percent, down from the August rate of 6.3 percent. Scott County had the state's highest unemployment rate at 19.9 percent, up from 19.8 percent in the previous month, followed by Marshall County at 15.6 percent, down from the August rate of 15.9 percent.

Knox County had the state's lowest major metropolitan rate of 7.1 percent, down from 7.6 percent in August. Hamilton County was 7.8 percent, down from 8.7 from the previous month. Davidson County was 9.1 percent, down from 9.5 percent, and Shelby County was 9.8 percent, down one-tenth of a percentage point from August.
