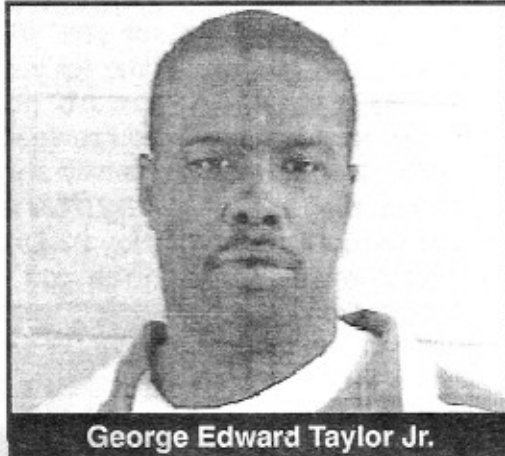

will not be accepted after 11:59 p.m. on Wednesday, Feb. 10. Mailed applications will not be accepted. The application period has been underway since Dec. 16, 2009.

The areas available for the hunts are listed on the instruction sheets. Hunters have up to 12 choices, but will be drawn for only one. Applicants may not use the same hunt code more than once. There are a total of 19 hunts listed. No person may apply more than once.

A permit fee will not be charged to Annual Sportsman (Type 004), Lifetime Sportsman (Types 402-405) license holders or Senior Citizen Hunters (Type 166) with an

Annual Senior Citizen Permit (Type 167), TWRA will pay the agent fee for these transactions.

For all other license holders, the cost is \$20 per permit, plus the agent fee. When applying at a license agent, hunters must remain at the location while the application is processed. Hunters will receive a receipt with a confirmation number when the application is complete.

Hunters can click on Buy a License On-Line. Once the Internet site has been accessed, hunters can follow the on-screen directions.

**Jack Lee Huff** of Loudon County, passed through transition on Wednesday, February 3, 2010 after a lengthy illness. He is survived by his wife, Sandra, daughter and son-in-law, Anne and Kyle Haight, and his mother, Rachel Treadway Robinette. He is also survived by his half-sister, Sandra Poffenberger and step-sisters, Cheryl Pruitt and Margaret Wesley. Jack was the son of the late Herbert Lee Huff of Oak Ridge. Jack was born 25 July 1937 in Crossville, Tennessee. He grew up in Rockwood, Tennessee, attended Rockwood schools, and graduated from Tennessee Technological University with a BSME in mechanical engineering. After graduation, Jack worked in Oak Ridge at

Union Carbide Nuclear Division's Y-12 plant. Leaving Oak Ridge in 1979, he and his family moved to California where Jack worked at Advanced Cardiovascular Systems, which later became Guidant Corp. At Guidant, Jack was part of a team of engineers who designed and developed the first heart catheters for the medical procedure of angioplasty. Jack personally built Guidant's first successful prototype machine to manufacture heart catheters. He was always proud to have been part of this revolutionary new frontier in medicine. An avid marksman, Jack was a semi-finalist in the try-outs for the US Olympic High Power Rifle Team in the 1960's. He was also in charge of the Junior Rifle Club at

Oak Ridge Sportsmen's Association for many years. Being a former Boy Scout, he especially enjoyed working with the Boy and Girl Scouts earning their marksmanship badges. Jack's other major interests were archeology and ancient history, particularly the Ancient Egyptian and Sumerian archeology and cultures. He gave many lectures to museums and philosophical groups, and he and his wife visited Egypt to study the archeology and culture as often as they could. Upon retirement in 2003, Jack and Sandra returned to Tennessee to live in Loudon. A memorial service will be held at a later date at Rockwood Presbyterian Church. Click Funeral Home and Cremations' Tellico Village Chapel is serving the family of Jack Huff.

school zone.

According to the affidavit; on February 2nd, 2010, at approximately 9:20 PM, Investigator Jason Butler, LCPD observed George E. Taylor Jr.

driving a blue Honda Van on Highway 321 near Highway 70 and noted it was traveling 62 mph in a 55 mph zone.

Upon stopping Taylor for a speeding violation, he was asked to exit the vehicle,

at which point Taylor fled on foot for approximately 500 feet and was subsequently taken into custody.

K-9 Officer Jeremy Dishner, LCPD deployed K-9 Sting in the area where Taylor was arrested and located 3 separate clear plastic bags containing a total of approximately 2 1/2 ounces of a white powder substance believed to be cocaine hydrochloride.

The location of Tay-

lor's arrest was within 1000 feet of Eaton Elementary School and North Middle School.
