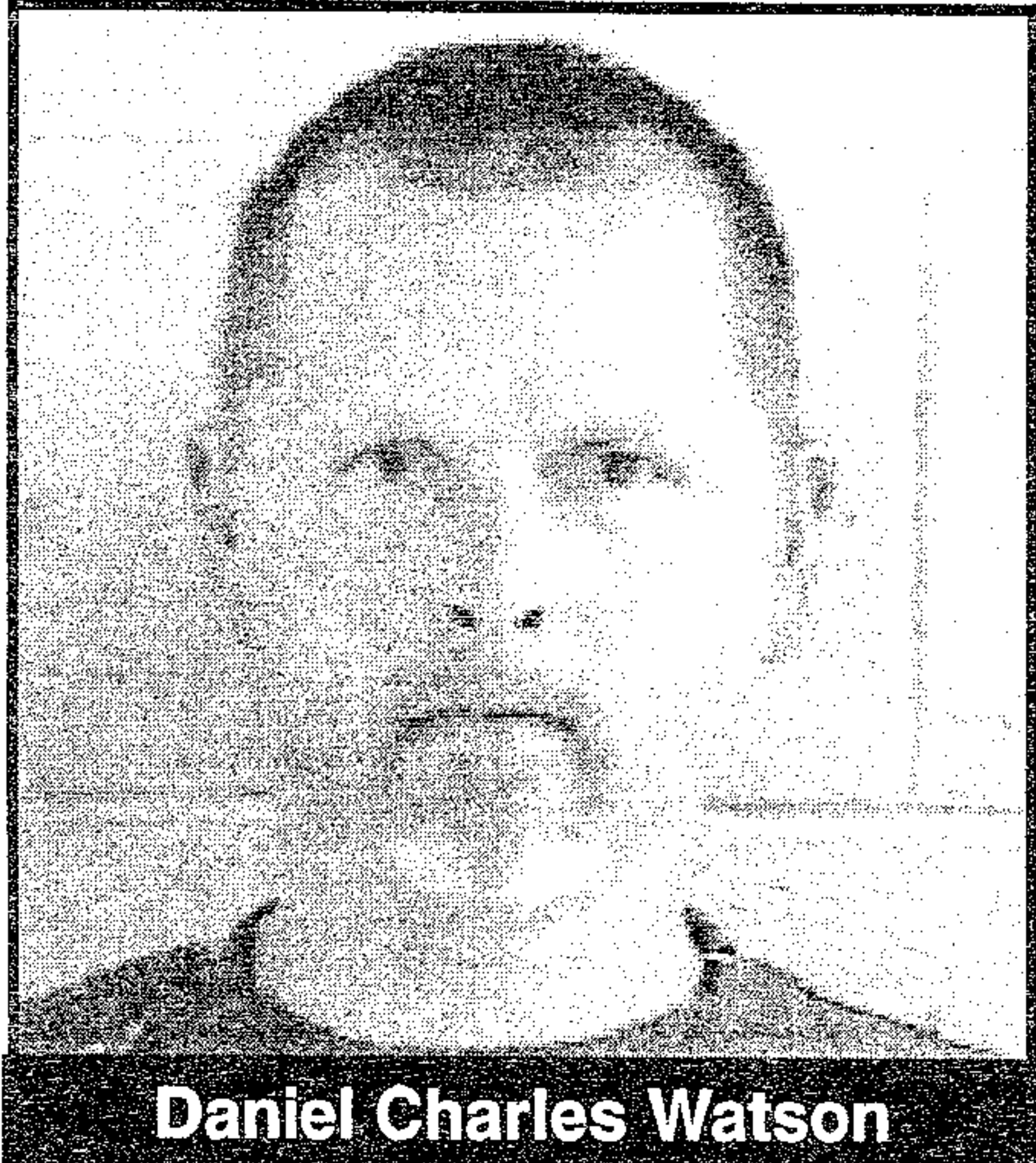

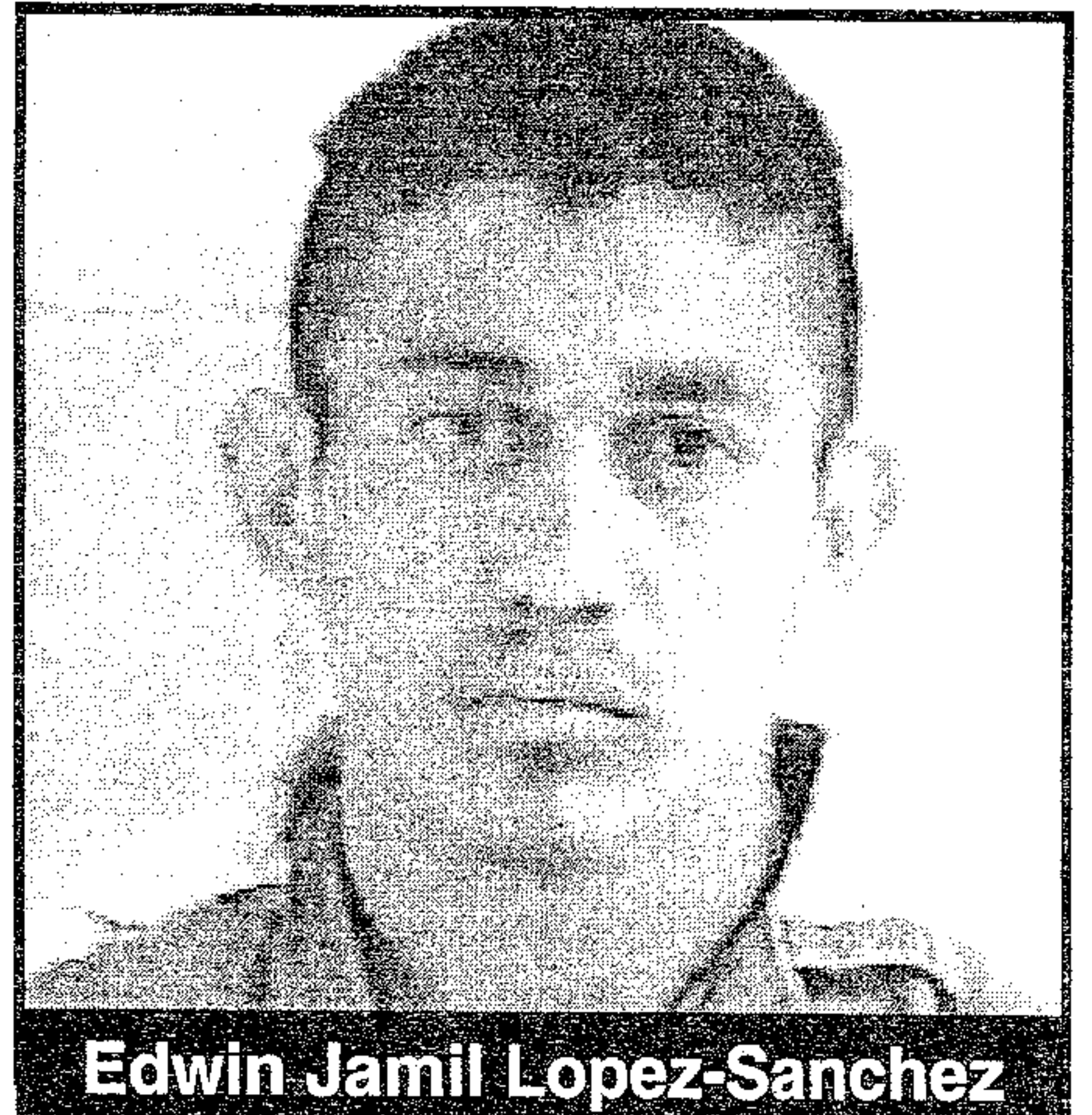

unknown, was charged Saturday with driving on suspended license, possession of schedule II for resale and possession of schedule IV x 2.

The report states Deputy Rondel Branam, LCSO observed a white Ford pickup truck traveling on Muddy Creek Road towards Martel Road in Lenoir City. The truck

was moving at a high rate of speed. Radar verified the vehicle was traveling 50 mph in a posted 35 mph zone.

Deputy Branam stopped the truck in a driveway on Martel Road. The driver, Daniel C. Watson produced a Tennessee ID card. His license plate had also expired as of March 2010 and he could not provide proof of insurance.

A check of Watson's

license number through NCIC came back suspended for failure to satisfy a citation out of Knox County.

An inventory of the truck produced a small metal container with 29 small, round, blue pills believed to be 30 mg oxycodone, a prescription bottle for 30 mg oxycodone containing 47 small, green pills believed to be 15 mg oxycodone, 20 small, blue pills be-

lieved to be 30 mg oxycodone, 5 small, oval, blue pills believed to be 1 mg alprazolam, and 2 pieces of white totem pole shaped pills believed to be 2 mg alprazolam.

Also found was a prescription bottle for 15 mg oxycodone containing 9 small, round, light blue pills believed to be 30 mg oxycodone and 45 small, round, blue pills believed to be 30 mg oxycodone.

Mr. Daniel C. Watson was also charged with possession of schedule II (oxycodone) for resale and

two counts of possession of schedule IV (alprazolam). Watson was issued citations for speeding, financial responsibility and registration violation.

numerous items of drug paraphernalia at the location.

Robert Eugene "Robbie" Lanter, 25, Christian Street, Philadelphia was charged Thursday with simple possession schedule VI (marijuana), possession drug paraphernalia and illegal possession of a weapon by a convicted felon.

According to records, the Loudon County Sheriff's Office Patrol Division was assisting Child Protective Services on Christian Street. While at the residence, Deputy Ron Deland observed in plain view what appeared to be a marijuana "bud." Mr. Lanter told the deputy the marijuana was his.

Investigator Shane Ezell was called to the scene. Upon arrival of the investigator, Lanter

er reportedly told him the same thing, the marijuana belonged to him. Mr. Lanter was charged with simple possession and taken to the Loudon County Jail.

While retrieving the marijuana from a bedroom accompanied by a female who also lives at the residence, Investigator Ezell asked if there was anymore marijuana or any other type of narcotics or paraphernalia in the bedroom and she said no, at which time she gave verbal and written consent to search the bedroom.

During the search, a small plate was discovered with what appeared to be pill residue on it. Also on the plate was a razor blade and half of an empty adderall capsule, along with a short piece of straw commonly used to snort crushed pills.

Beside the plate were two straight pieces of hose clamps, which are commonly used to grind and crush pills. A Hawes Firearms .25 caliber semi-auto handgun was found in a drawer and there was a box containing forty-nine .22 caliber "CB" rounds laying under the handgun.

Other items found in the bedroom during the search were a combination pill cutter and grinder, other pieces of cut straws with residue on them, a metal pill crusher and a silver marijuana grinder.

Records indicate Mr. Lanter, being a convicted felon, is prohibited from owning or having any firearm or ammunition in his possession.

Grants

the preservation of historic and archaeological sites, dis-

tricts and structures and Monroe County has received on eof them.

The grants awarded come from federal funds allocated by the Department of Interior under the provisions of the National Historic Preservation Act. The programs authorized by this Act are administered by the Tennessee Historical Commission. The grants pay for up to 60 percent of the costs of approved project work and the grant recipient must provide the remaining 40 percent of the costs as matching funds.

This year's selection process emphasized projects conducting architectural, archaeological and historic site surveys. Such projects are designed to identify and to record historic districts, sites, buildings, structures and objects built before 1960 that are significant to Tennessee's history. Surveys could be for a specific geographic area or for sites associated with themes or events significant in the state's history. Priorities for

funding survey projects included areas experiencing rapid growth and development, other threats to cultural resources, areas where there are serious gaps in knowledge regarding cultural resources, and thematic surveys based upon existing historic study units produced by the State Historic Preservation Office.

Assistance also was made available for other types of historic preservation projects, including preservation planning studies for towns, neighborhoods and historic districts; the preparation of nominations to the National Register of Historic Places; planning or pre-development work necessary to undertake restoration of a historic property; and restoration of historic properties. For restoration or restoration pre-planning, properties must be listed in the National Register of Historic Places.

Monroe County received \$17,000 for the cleaning and re-pointing of brickwork on the south and west elevations of the Monroe County Courthouse.

the influence, implied consent, leaving the scene of an accident and driving without a license.

According to records, Saturday at approximately 11:03 PM, Officer Frank Donth, LCPD responded to a hit and run accident in front of a residence on Finley Drive in Lenoir City.

The officer originally responded to Finley Drive and met with two victims; one, a driver of a vehicle struck head-on and side-swiped and the second victim, a homeowner that had damage from Sanchez driving into their yard.

The vehicle, a green

Ford Explorer with heavy front driver side damage was found inside the Rambling Acres Trailer Park and Sanchez was found at lot 27.

Officer Brandon Gentry, LCPD saw Sanchez get out of his Explorer and get into another vehicle driven by Mayron Noel Mendez Montoya. The officer followed them to lot 27 where Lopez-Sanchez was apprehended.

Lopez-Sanchez admitted he was the driver of the Explorer and a matching shoe belonging to him was found on scene next to the wrecked vehicle.

The officer noted Lopez-Sanchez had been driving the vehicle on a public roadway without a valid drivers license and was very intoxicated. He also fled the scene without contacting law enforcement or rendering aid to the victims.

Paint transfer marks matched each vehicle and parts of Sanchez's vehicle were left at the scene.
