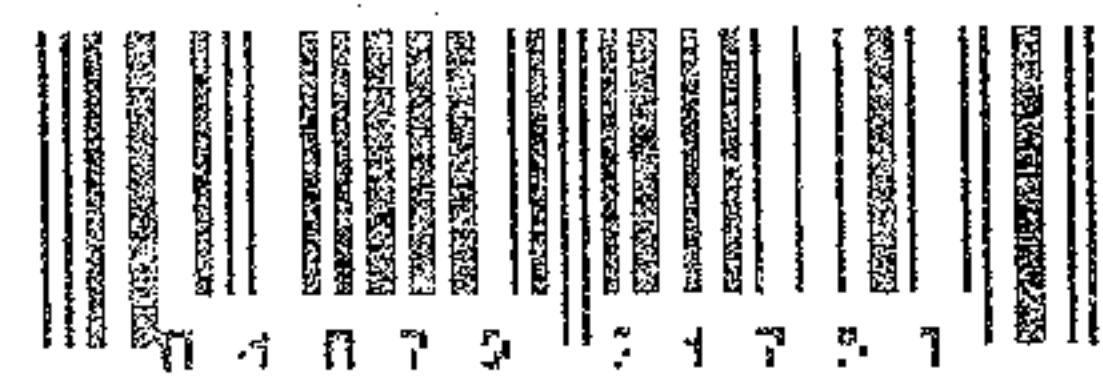

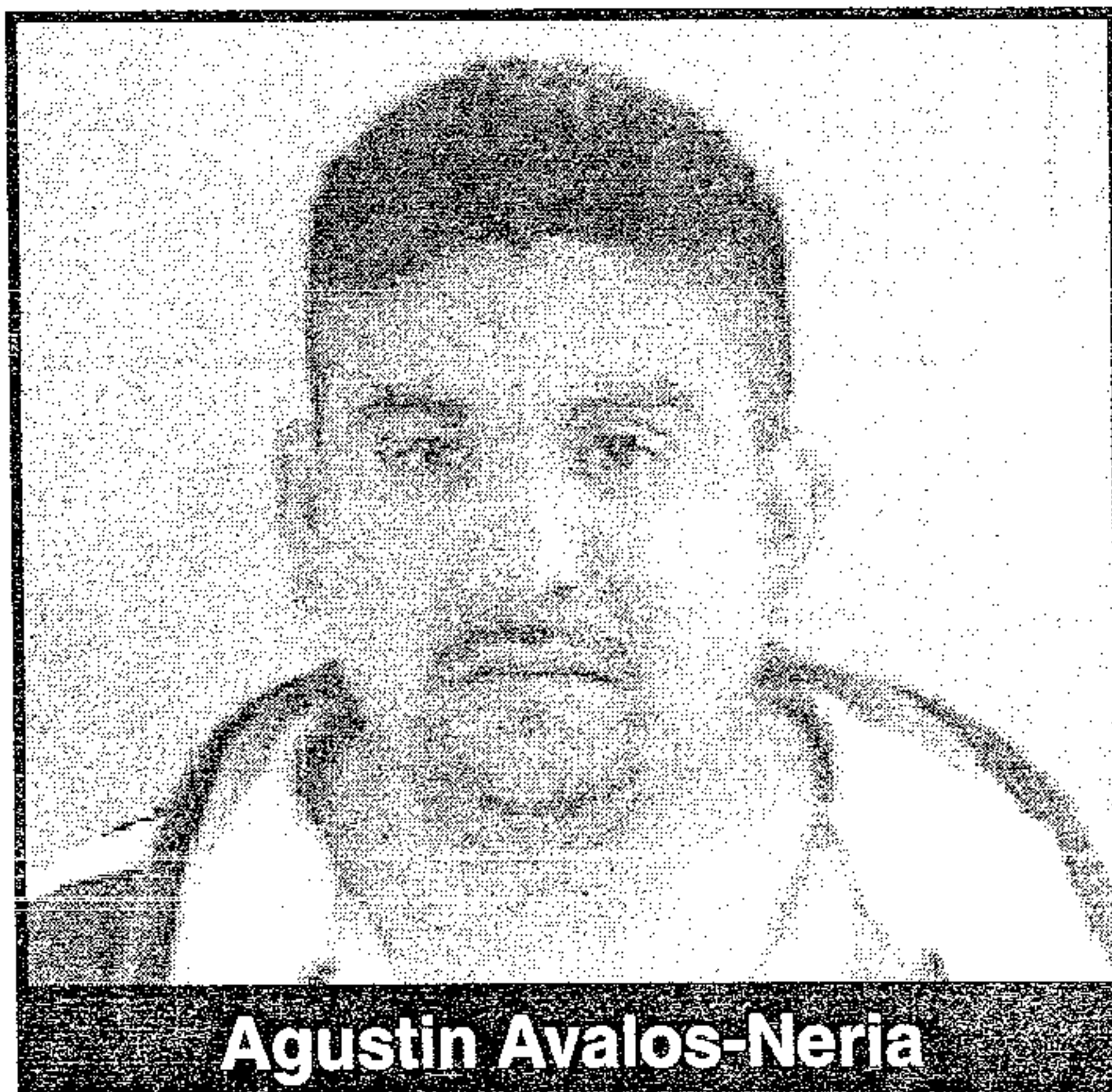

There was no sign of forced entry on the front or the back doors. Ms. Crowder also advised her xBox 360 was off when she left, but it was on with a game in it when she returned home.

The case is being investigated.

Boat gas stolen

A local man called authorities to report the larceny of his boat gas when he discovered over \$300 worth had been taken out of his boat.

According to records, Deputy Deland, LCSO was dispatched Saturday to a residence on Kiyuga Way in Loudon to make a report on a theft. The complainant, an 81 year old man, stated sometime over the winter months, someone stole all the fuel from his boat. The

boat was parked in his dock, hoisted up and was covered up, all winter long.

The man advised someone stole gas from his neighbor's boat last winter, but his neighbor never reported it.

The total loss was about 65 gallons of gasoline valued at \$315.

Roof damaged after pole struck

A local man's roof reportedly was damaged when the driver of a vehicle struck a utility pole and when the lines sagged, they pulled the weather head away from his roof.

According to reports, Monday, Deputy Rondel Branam, LCSO was dispatched to a residence on Stevens Lane in Lenoir City to take a report of a past hit and run where the complainant, Mr. Virgil Reynolds, told him he owns his home and on Saturday at approximately 2:15 AM, a silver Corvette came down Stevens Lane at a high rate of speed, lost control and struck a utility pole across the street from his residence, then drove away. Then on Monday, he found his roof was damaged where the power lines were pulled tight and pulled the weather head away from the roof.

There was minor damage to the roof and shingles as well as the weather main and the pole leading to the meter were all bent. The total estimated value of the roof and shingles was estimated at \$100.

The case is under investigation.

33,764 birds have been harvested. The 2009 spring season total was 32,081.

Maury County has the top county harvest thus far with 919. Montgomery has the second highest county total with 862 followed by Greene (794), Henry (791), Dickson (775), Sumner (767), Giles (719), Hawkins (690), Rutherford (680), Marshall (648), Harde- man (611), Robertson

(609), and Cheatham (603).

Tennessee sports- men are on trek to pass the highest mark since 2007 when the total har- vest was 34,256. The record harvest was the previous season in 2006 when more than 38,000 birds were harvested.

All Tennessee counties are open to wild turkey hunt- ing including Wildlife Management Areas and refuges unless specifically listed. 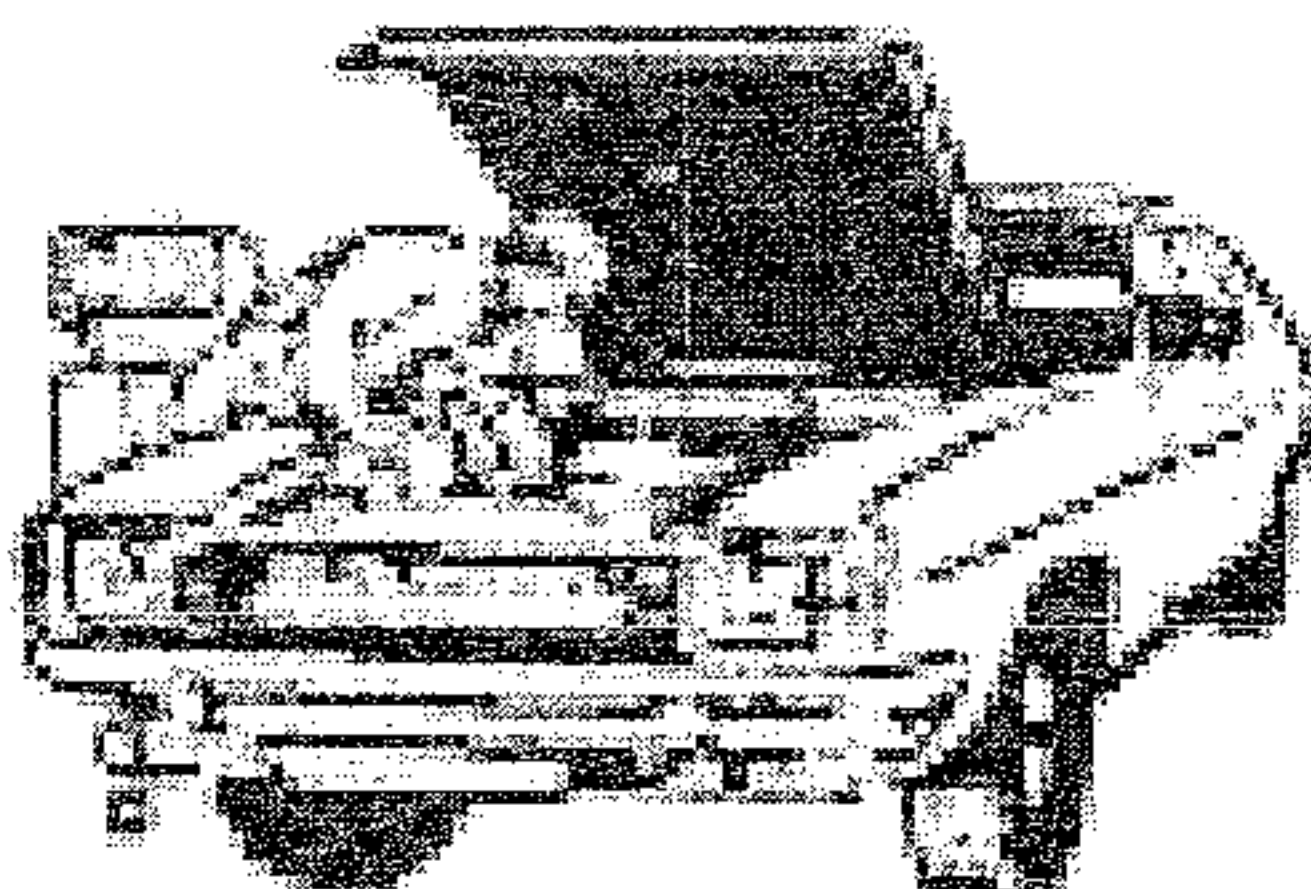

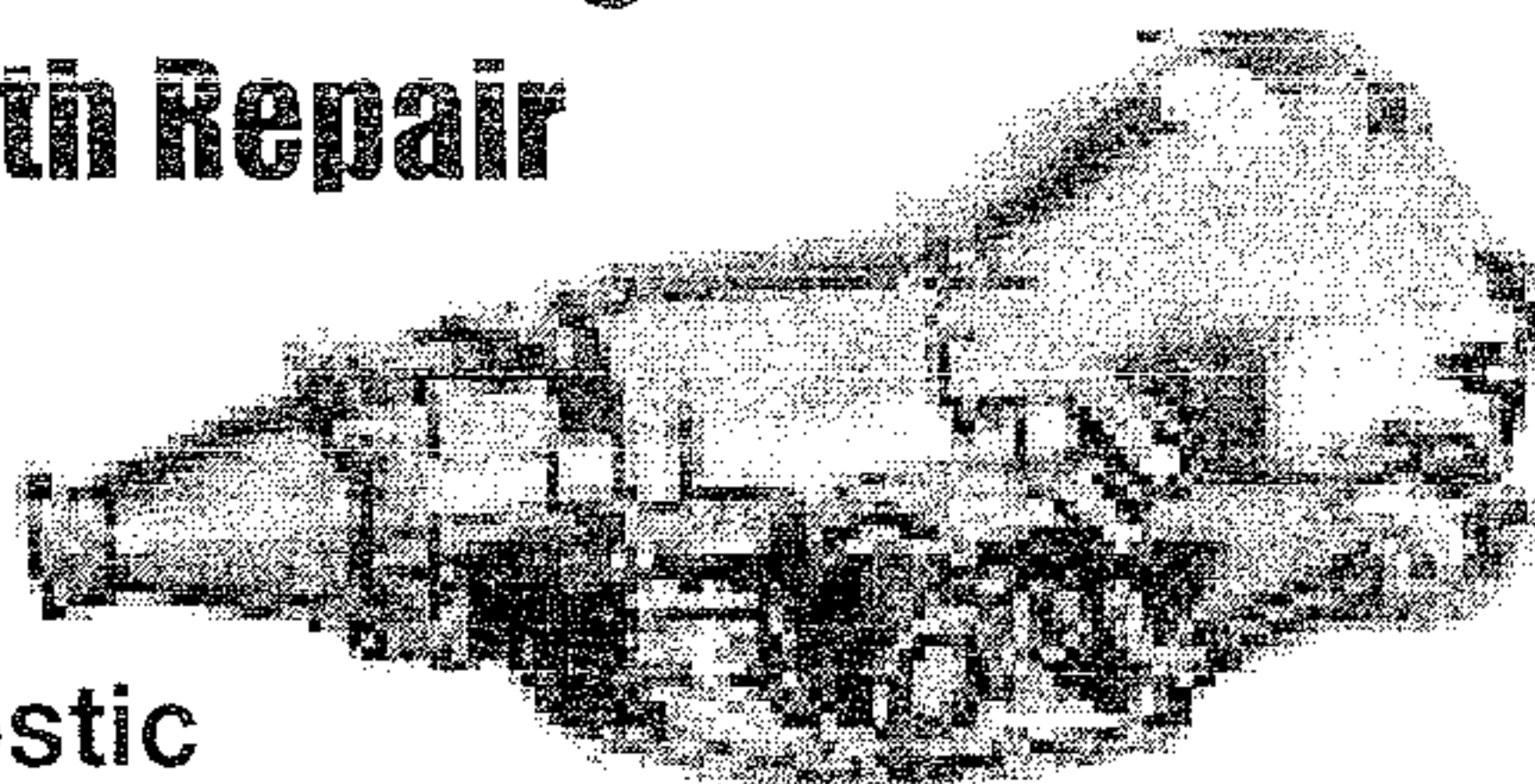

A suspect was identified to police.

The value of the loss was estimated at \$400. The case is under investigation.

Mr. Johnson had an odor of an alcoholic beverage about his person, bloodshot eyes, constricted pupils and appeared to be unsteady on his feet. He admitted to drinking beer about one hour prior to contact with law enforcement.

Johnson performed poorly on field sobriety tasks and according to the officer's report, Mr. Johnson was very talkative during the arrest but seemed to be confused and had trouble carrying on basic conversation.

According to records, Mr. Ray B. Scams

Common scams include asphalt paving, landscaping, and roof repair. Common business practice is to make around a 10-15% down payment on a contract, with the rest to be paid upon completion. He advises citizens to be aware of any contractor that asks for half or the

entire amount before doing any work or purchasing any materials. Many contractors attempt to get money up front then never show back up to do the work, which is considered theft; others give the story that they have materials left over from the last job and can make you a quick deal.

Some helpful hints

include:

Having a written contract;

Discussion of terms of payment up front;

Get at least three quotes from different contractors;

Ask contractors for references, copies of their business license, and proof of insurance.

Do not make any quick decisions no matter how great the deal sounds or what kind of pressure is being used to try to make you decide.

Any door-to-door solicitors in the county are required to be registered daily with the Loudon County Sheriff's Office. Solicitor registration can be verified, as can any contractor you may be suspicious of, by calling the Sheriff's Office at 986-4823 to check registration or on-going investigations.

Police Beat

Tonya Michelle Amburn, 33, Highway 72 South, Loudon was charged with assault by domestic violence.

According to records, Tuesday around 7:20 PM, Deputy Steve Helm, LCSO was dispatched to a 2nd domestic incident at a residence on Highway 72 South where a physical assault reportedly occurred and upon arrival, the victim and witness's advised a verbal altercation/argument between him and Tonya Amburn began and escalated into a physical assault.

Ms. Amburn allegedly hit and scratched the man about his face, head

and neck.

Records indicate a prior call was answered at about 6:34 PM where officers were called to the residence due to a domestic argument between the man and Ms. Amburn. There were no marks on the victim during the first call, but witness's stated Tonya Amburn hit the man in that argument. The man, however, he denied being hit.

It was noted there was probable cause to believe during the second call that, by the victim and witness's statements, Tonya Amburn did assault the man and she was arrested by probable cause for assault by domestic violence.

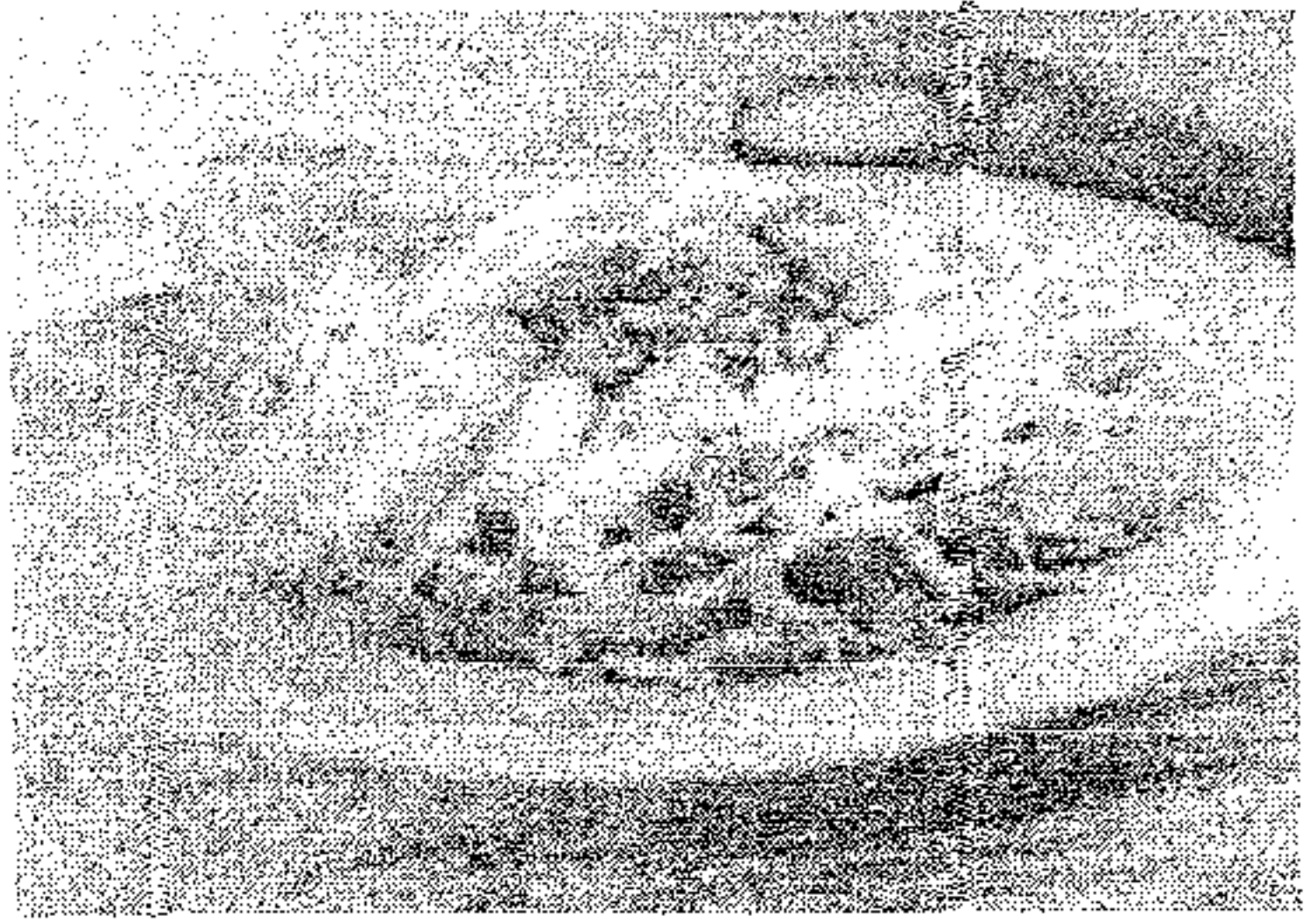

Viars

Street, Loudon was charged Tuesday with possession of drug paraphernalia, possession of schedule V (xanax) for resale, possession of schedule II (oxycodone) for resale and simple possession schedule VI (marijuana).

According to an affidavit, Officer Brendan DeBoer, LPD-9th DTF conducted a search warrant at a residence on Grove Street in Loudon. The target of the search warrant was Becky Viars.

During the execution of the warrant numerous oxycodone pills (2 different types of milligrams), numer-

ous alprazolam pills (xanax) and a small amount of a green leafy substance believed to be marijuana was located specifically in the bedroom of Becky Viars.

As a result of the evidence recovery at the time of the search warrant, as well as the investigation leading up to these actions, it is believed that Becky Viars is a drug dealer who sells oxycodone and xanax from her residence.

Officer Jonathan Yates DTF/LPD and April Farmer, LPD, were also on scene.

Becky Viars was also served warrants on Tuesday for violation check law x 4.

Neria

Drive, Lenoir City, was charged with violation of order of protection x 2 and aggravated domestic violence assault.

According to reports, Thursday, at approximately 1:11 AM, LCPD Officers Shane Tilley and David Flynn were dispatched to a residence on Church Drive on a physical domestic. Avalos-Neria committed aggravated assault by knowingly placing the victim in imminent fear of serious bodily injury.

Avalos-Neria entered the residence through an open window while the female victim was asleep. He obtained a knife from the kitchen and threatened to kill

himself. There was a two month old baby in the residence at the time.

When law enforcement arrived, Avalos-Neria was seen trying to exit the home out a side window. He had a no contact order of protection on him and violated the order by coming around the victim placing her in imminent fear.

Avalos-Neria also violated a previous

order of protection. He and the victim have a two month old child in common.

Officer Tilley made the arrest. LCPD Officer Mark Maxwell was also on the scene.






