

# Fraud charges filed Woman caught holding after debit card used the bag


Fraud charges were filed against an area man after he allegedly used a woman's debit card without her knowledge or permission earlier this month.



Ms. Romines stated the objects were used to cut and smoke crack cocaine, an iliegal substance.


Deputy Nick Lawson, LCSO was also on scene.

As the officer approached her Stinnett was very shaky. Stinnett did poorly on field sobriety tasks.


