A young homeless man was jailed after he was found in McGhee Square property despite being barred from the premises.

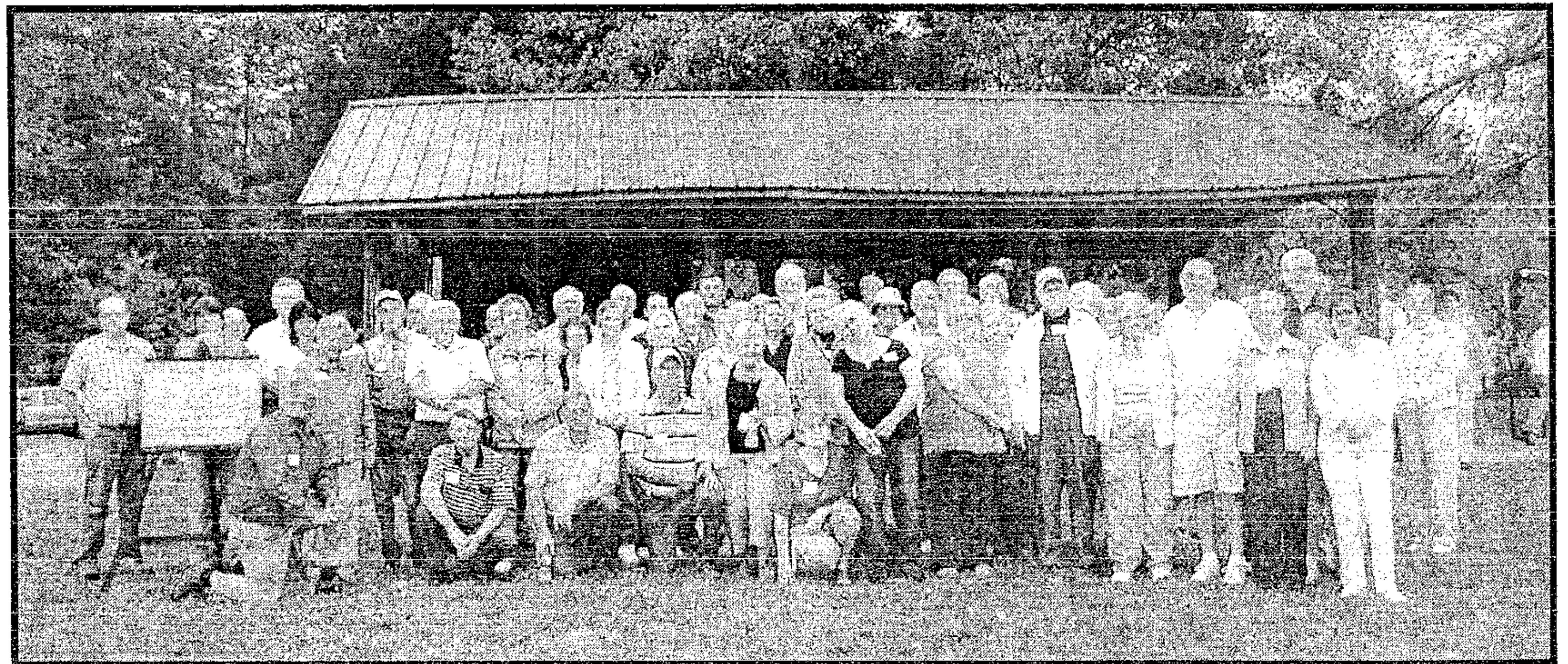

tion revealed he had suspended license, which led to his arrest, which in turn led to a search that reportedly produced drugs and paraphernalia including needles and a dirty spoon.

Jonathan Russell McGee, 22, McGhee Boulevard, Lenoir City was charged Sunday with a *capias* (failure to appear), suspended license,

possession of drug paraphernalia and possession of schedule II.

According to reports, while on patrol Corporal Pete McGinley, LCSO observed a gray Chrysler coast to a stop in front of a residence on Old Midway Drive. The deputy stopped to see if he could be of assistance.

A white male, identified as McGee got

out of the drivers seat, came back to the officer and stated he ran out of gas. The man's speech was slurred and he seemed unsteady. When asked for his license, he handed the Corporal a Tennessee ID. A check of the ID number through NCIC came back suspended.

Corporal McGinley asked Mr. McGee if he had anything on

his person that would stick or poke him and Mr. McGee stated he had a needle in his pocket. After removing the needle the corporal asked Mr. McGee if had any illegal narcotics on him or in the vehicle. Mr. McGee stated he had a "roxy" in the car and also had more needles.

Corporal McGinley checked the vehicle and found the needles in a black plastic box, a spoon with a white and green substance in it, a lighter and a small plastic bottle containing water.

McGee was transported to the Loudon County Jail.



victim; on April 14th, 2010, at approximately 11:30 PM, he (the victim) went to Scotty Flanagan's residence on Doyle Street to stay the night. Around the same time, the victim took Mr. Flanagan to McGhee Square to pick up his phone charger.

While there, the victim witnessed Mr. Flanagan get into a verbal altercation with another individual he broke up the argument before the pair got back in the vehicle and returned

to Doyle Street. Once they arrived at the residence, Mr. Flanagan became angry at the victim because he believed the victim was taking sides in the previous altercation. The man said he told Flanagan he had not done that and Flanagan walked away. While the victim was outside on his cell phone, Mr. Flanagan approached him on his right side and struck him in his right eye causing visible swelling.

The victim sought

medical treatment and stated surgery will be required to correct the broken bone in his eye and the force of the hit
