The driver, Robert Smith had a strong odor of an alcoholic beverage coming from his person and there was an open beer can in the cup holder.


Mr. Smith also had extremely slurred speech and appeared unsteady on his feet. He did very poorly on several field sobriety tasks.





A Loudon County Jail inmate was charged with aggravated assault after he injured another inmate when he punched him.

Randall Dale Brown, 25, Abbott Road, Lenoir City was charged with aggravated assault.

According to an affidavit filed by Deputy Nathan Wilson, LCSO; on June 3rd, 2010, at approximately 8:00 PM, Randall D. Brown physically assaulted a fellow inmate at the Loudon County Jail. According to statements from Mr. Brown, the inmate, and from viewing surveillance video, it was determined Mr. Brown punched the other inmate about the facial area causing him to fall and hit his head on a block wall.

The inmate was trans-

ported to Fort Loudoun Medical Center where he received nine staples in the back of his head. He also had a swollen jaw.

The injuries were a result of being assaulted by Randall Brown. The video evidence showed the other inmate did not touch Mr. Brown before the assault occurred. Deputy Nathan Wilson served the warrant on Monday.


