**Couple with infant leads police on 100+ mph chase, flees on foot after wrecking**

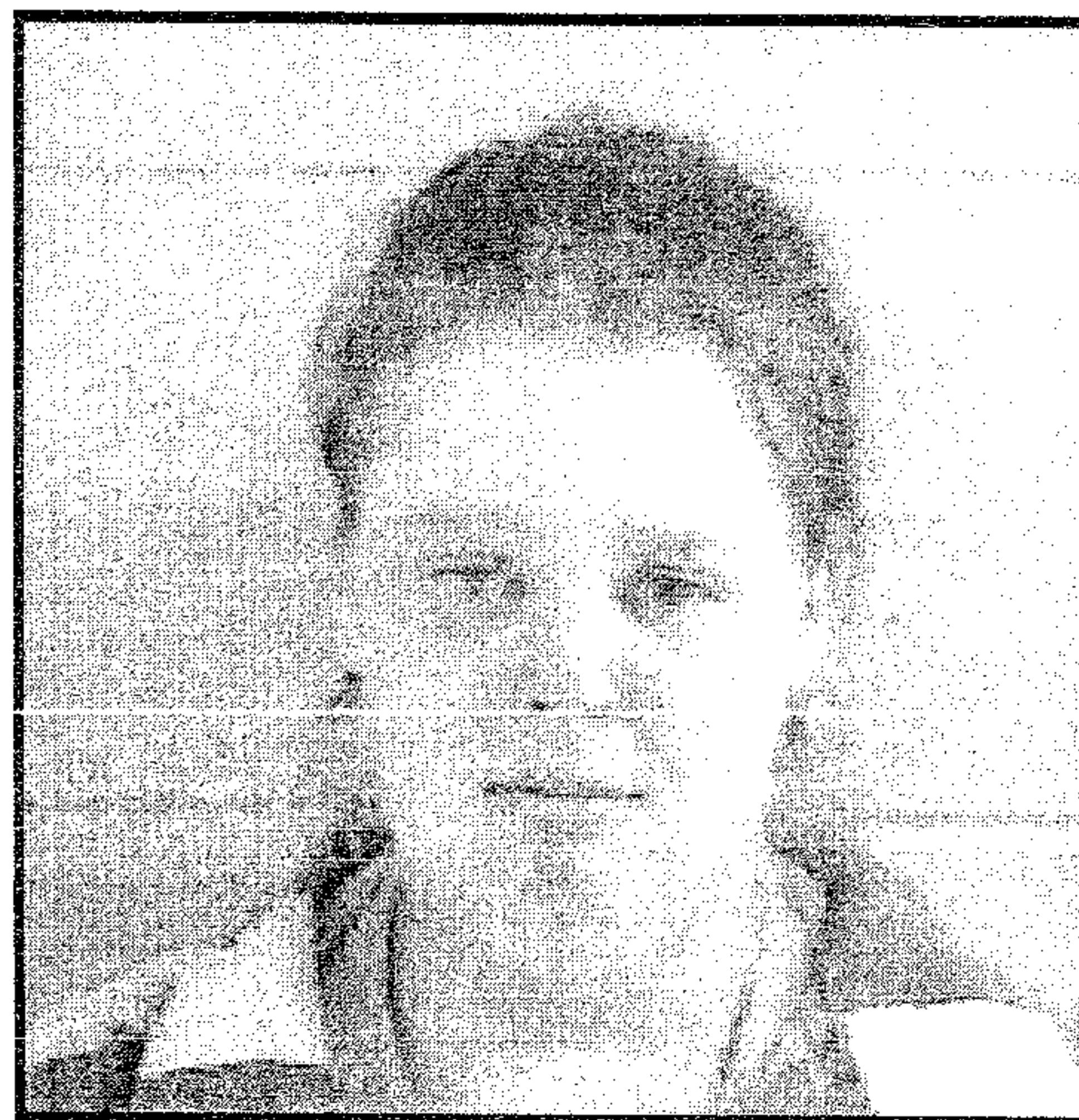
A Loudon couple was jailed on a slew of charges after reportedly leading police on chase exceeding 100+ mph speeds and then fleeing on foot with their infant child after crashing into a ditch. Both reportedly were intoxicated at the time of the incident.

Jimmy Lynn Thompson, 24, Bradshaw Hollow Road, Loudon was charged Sunday, with felony evading arrest, driving on suspended license, driving under the influence 2nd offense, reckless endangerment, felony child abuse, and possession of a legend drug (ibuprophen 800 mg).

A Loudon man reportedly made threats against himself and others when he showed up at work heavily intoxicated and was told to go home. He went to jail instead.

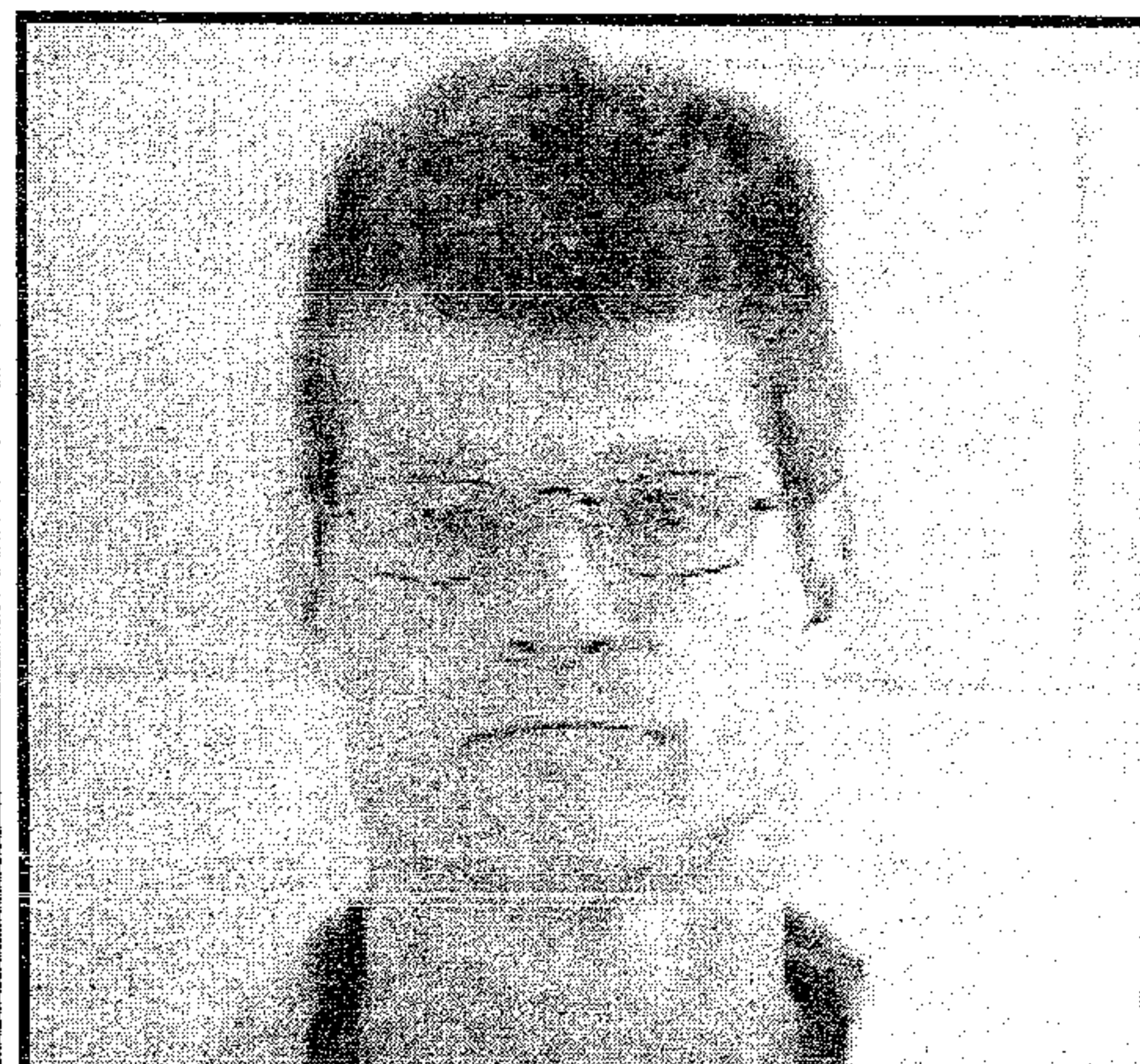

Keith Eugene Evans, 44, Bishop Road, Loudon was charged with public intoxication.

The report states, Saturday around 11:30 PM, Officer Samuel Harrison, LPD received a call from the Loudon County 911 Center in reference to an intoxicated employee at Monterrey Mushroom

in Loudon. The 911 Center also advised the employee was making threats to harm himself.

Upon arrival, the officer made contact with Keith E. Evans in the parking lot standing next to the security building. Evans had a very strong odor of an alcoholic beverage about his person and breath, bloodshot eyes, very slurred speech and

was very unsteady on his feet.

Other Monterrey employees stated Evans threatened to harm himself and possibly harm others when he was not allowed to work because he was drunk.

Officer Harrison felt Evans, who drove to work by himself, posed a danger to himself and to the public at large and placed him under ar-

rest.

A witness heard the fighting and saw Thomas sling the woman into the bed and slap her face.


According to the deputy's report, the victim had bruising and scratches on both arms, and a red mark on her cheek.

## Couple

Emily Lue Thompson, 19, also of Bradshaw Hollow Road, Loudon was charged with child abuse, resisting stop, halt, and frisk, DUI by consent, and underage consumption.

According to reports, Officer Brendan DeBoer, LPD clocked a white Dodge Stratus at 65 mph in a 45 mph zone on Highway 72 near the McDonalds in Loudon. The officer turned around and tried to catch up, at which time he clocked the Stratus again at 100+ mph. He turned on his lights and siren but the vehicle kept going.

The Dodge continued racing down 72 and began passing vehicles on the double yellow line before continuing onto Marble Bluff Road, nearly striking several fishermen on the "Polecat Bridge."

After approximately a 10 minute pursuit,

the Stratus wrecked into a ditch on Duke Lane in Roane County. The driver, Jimmy Thompson, fled from the vehicle with his wife Emily carrying their 6 month old child.

The couple ran into the woods, going through thick briar patches and numerous barbed wire fences. All three were taken into custody a short time later. Mr. Thompson had a strong odor of an alcoholic beverage on his person.

The officer reported Thompson put numerous people, in vehicles as well as on foot, in risk of great bodily harm. Thompson neglected his child in such a way as to adversely affect the child's health and welfare, due to the speed of the vehicle and carrying the child through multiple barbed wire fences and briar patches in order to evade arrest.

During a search of the Stratus, 2 white

pills were found, which Mr. Thompson, after Miranda Warnings, advised were prescription medication given to him by his cousin. His license were suspended in the state of Tennessee and he had a previous DUI in 2006.

Thompson agreed to a BAC test at Fort Loudoun ER, before being transported to jail.

Records indicate Mrs. Thompson is the registered owner of the vehicle, who gave consent to her husband to drive the car, knowing he had consumed a large amount of alcohol. She also had a strong odor of alcohol on her person and after being read her Miranda Warning, admitted

to drinking alcoholic beverages just prior to encountering law enforcement.

Mrs. Thompson neglected her child by running from the vehicle, and carrying the child through barbed wire fences and briar patches in order to evade arrest.

## No License

Amanda Hope Kiser, 24, Highland Avenue, Loudon was charged with driving without a license.

According to reports, around 9:34 AM, Thursday Officer Brad Parks, LPD noticed Amanda Kiser driving a white Chrysler on Robinson Spring Road at Bell Road in Loudon. The officer had prior knowledge she didn't have a valid drivers

license.

A check of Kiser's status came back as unlicensed.

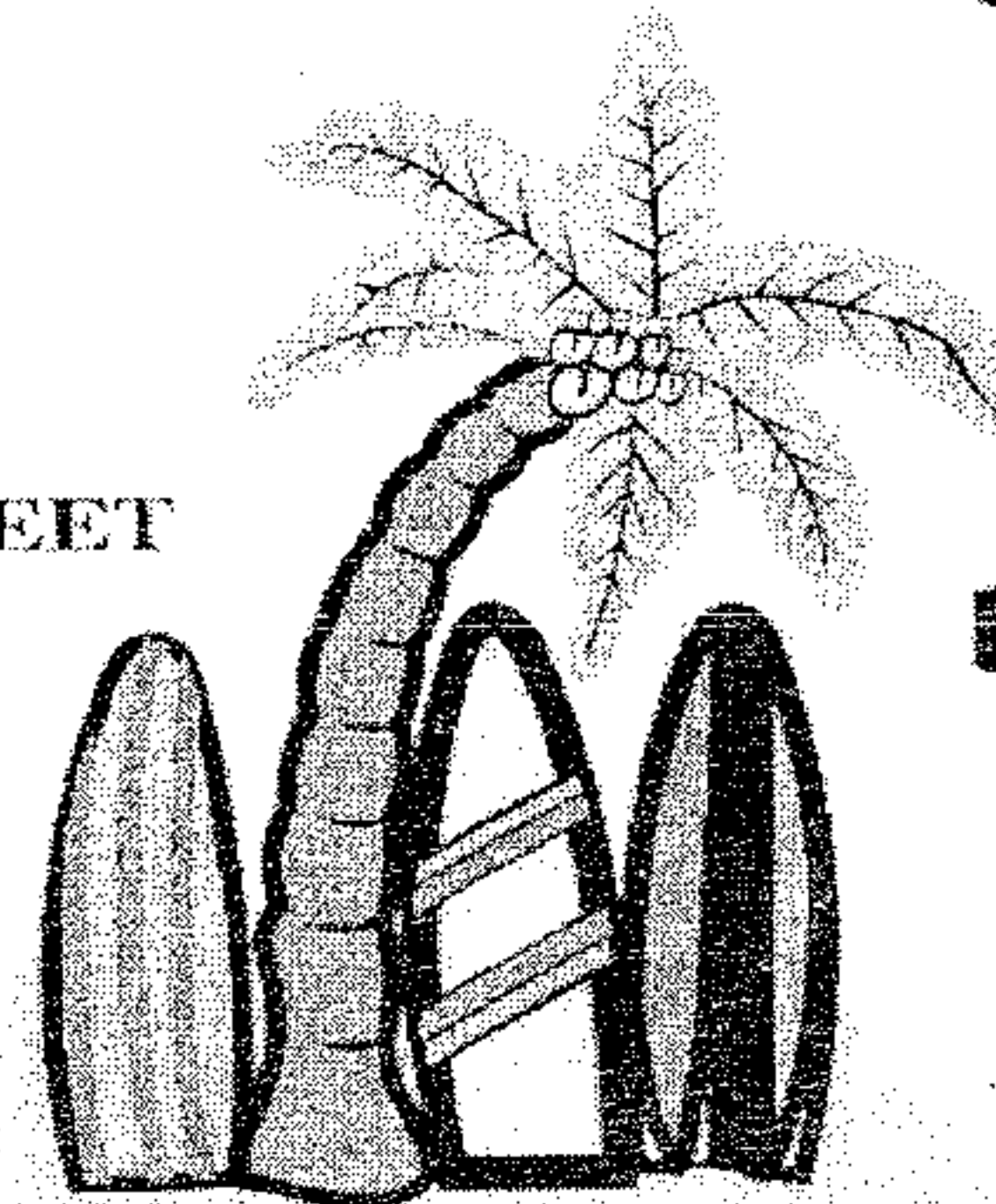
Tina Ranell Potter, 36, Alcove Boulevard, Greenback was charged Monday with driving on suspended license.

### Rolon

Police arrested Jimmy Leon Rolon Monday after he allegedly robbed another man in the rest room of a Lenoir City business.

Rolon, 29, Foster Road, Lenoir City was charged with robbery.

According to reports, Officer Jason Felts, LCPD responded to 1111 Highway 321 North Monday in reference to a robbery. Upon arrival, the officer made contact with the victim, Mr. Jonathan Griffith.

Griffith advised while he was using the rest room at the Exxon Station Jimmy Rolon walked in and put his forearm up against the back of Mr. Griffith's neck shoving him up against the wall and began going through his pockets. Mr. Rolon took a twenty dollar bill, two ten dollar bills and a lighter wrapped in brown snake skin.

Mr. Griffith said he pushed Mr. Rolon to
