



Allen William Lowe, 19, West Broadway, Lenoir City was charged with aggravated assault.





(oxycodone 15 mg), felony possession of schedule II for resale (methadone 10 mg), felony possession of schedule II for resale (methamphetamine), felony possession of schedule VI (marijuana), and felony possession of drug paraphernalia.

Eric Joseph Adams, 21, also of Ben Alder Lane was charged with felony possession of schedule II for resale (oxycodone 30 ma), felony possession of schedule II for resale (oxycodone 15 mg), felony possession of schedule II for resale (methadone 10

mg), felony possession of schedule II for resale (methamphetamine), felony possession of schedule VI (marijuana).

According to numerous reports, Thursday, around 8:07 AM, THP Knoxville Dispatch gave all units a BOLO (be on the lookout) for a areen GMC Yukon traveling north on Interstate 75 near the 62 mile marker after caller reported the vehicle was driving all over the road, weaving from lane to lane, and the driver was possibly intoxicated.

Trooper Daniel Morton, THP positioned his patrol unit on

the entrance ramp from the 72 exit and waited. He reported he observed a vehicle matching the description and confirmed the license plate matched the one on the BOLO. He also witnessed it following another vehicle approximately 1-2 car lengths before stopping it near the 77 mm northbound to investigate the BOLO and the traffic violation.

The driver, Mr. Thomas was able to show registration and insurance for the car. The passenger, Mr. Adams stated he was the owner of the vehicle.

Trooper Morton further reported he asked Mr. Thomas to exit the vehicle so he could determine if he was under the influence and Thomas stated he had not been drinking. When asked why he was driving instead of Mr. Adams, Thomas replied Mr. Adams got sleepy over the long drive from Florida where they were vis-

iting his cousin. He could not recall the city or his cousin's address, but stated it was 100 miles from Destin.

During the conversation Mr. Thomas reportedly appeared nervous and did not stand still. He kept looking back at the vehicle.

Mr. Adams stated they left their residence in Knoxville earlier that day and had been to Loudon to visit Mr. Thomas's cousin, but he did not know where the cousin lived in Loudon. He made no mention of traveling to Florida.

Records indicate the trooper clarified with Adams they had not been out of state, only to Loudon. Trooper Morton asked Mr. Adams for consent to search his ve-

hicle and was asked specifically about drugs and weapons, Adams stated there was nothing illegal inside the car and gave verbal permission to search. Mr. Adams also appeared to be nervous. He spoke in a broken voice and his hands were shaking.

Mr. Thomas also gave permission for the search, including his overnight bag from his trip to Florida and said there was nothing illegal in the car.

The trooper asked for a county deputy and a K9 to come to the scene, and Corporal Paul Curtis and his K9 Deacon responded. Upon arrival, the K9 was deployed and alerted on the outside of the car. He also alerted

on the inside between the front seats. The lawmen then began the search and initially found iPods, cell phones, a CB radio and scanners. The scanners had frequencies of local, state, and federal law enforcement agencies programmed and were turned on.

The officer reported the center console's

lid had screw heads that appeared to have been recently removed. The screws on the console itself were in original condition. Inside the natural void of the armrest there were two plastic bags with something inside, rolled in toilet tissue.

When the trooper removed the bag he found what appeared to be several hundred pills. Oxycodone 30

mg in one bag and 15 mg oxycodone in the other.

As the search continued, Corporal Curtis removed the cup holders revealing another natural void area. There, the lawmen found a black pouch and a green knife case. Inside the pouch was a large sum of cash. The money was packaged together using rubber bands in one thousand dollar increments. There was a total of \$3000 in cash made up of 100, 50, and 20 dollar bills.

Inside the green case was a clear plastic bottle containing six white pills. The pills were later identified as methadone 10 mg. Also in the green case was a clear plastic bag containing a white powdery substance. The substance appeared to be methamphetamine and weighed DAILY EDITION · July 14, 2010 · Page 7

approximately .5g.

Also under the cup holders, Corporal Curtis reported he found a blue and orange pipe commonly used for smoking marijuana. There was a burnt substance still inside the bowl area that was believed to be burnt marijuana residue.

In the same compartment, Trooper Mike Wilson located a dark colored tar substance that was identified as hash marijuana that was believed to weigh less than 1/2 oz.


The two men were transported to the Loudon County Jail for questioning.

The DEA-Knoxville responded to the jail and conducted interviews with both Thomas and Adams.

Records indicate Mr. Thomas had been given three individual state identification cards to pick up prescriptions in Florida. The people who the cards belong to were identified and it was learned, each had written permission slip giving Mr. Thomas the authority to use their ID cards to purchase their medications in Florida. All medications from all persons involved had been combined into the two bags.

Both Thomas and Adams were also charged with the possession of controlled substance with the intent to obtain, deliver, and facilitate the sale of the schedule II and VI drugs.

The total amount of US currency recovered was \$4260.
