Child Rape Charges Filed Against Lenoir City Man by 9th DTF

A Lenoir City man has been charged by the 9th DTF in connection with the Knoxville Police Department with raping a child under 2 years of age. The man was taken into custody on Northshore Drive on the Loudon County side.

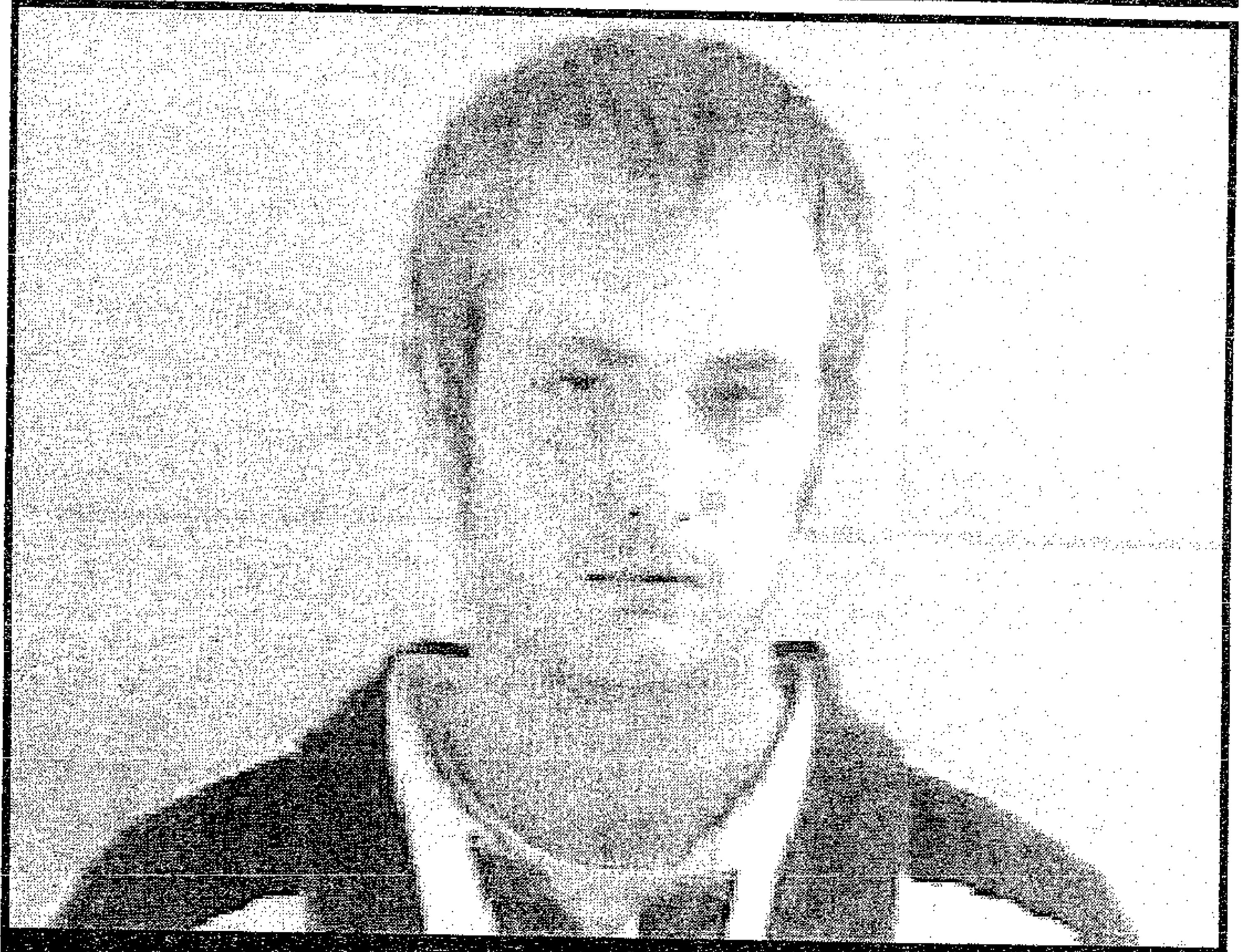
Edward William 'Eddie' Crandall, 23, North Shore Drive, Lenoir City was charged with 2 counts of child rape under two years old.

According to affidavits, on July 1st, 2010, Agent Daniel

Schneider, 9th DTF served a warrant at a North Shore Drive, Lenoir City residence for aggravated sexual exploitation of a minor and seized several computer related equipment items.

On July 1st, 2010, the agent started an exam of the media and located several images of Mr. Crandall and a white male juvenile approximately 2-3 years of age, some fully clothed, inside the camper where Crandall lived.

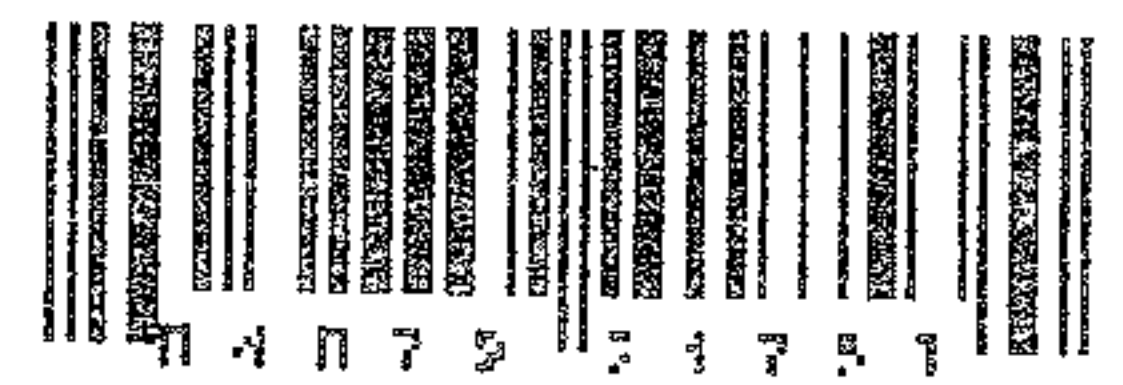

juvenile male completely naked. The next images were of Crandall and the little boy next to each other with no shirts on. The next images were of a sexual act.

Agent Schneider was able to identify the images were taken inside the camper where Crandall resides and Crandall was the adult, how-

ever the agent was unable to identify the child at that time.

Due to the images being in order, Agent Schneider went to Mr. Crandall's place of employment and contacted him. The agent told Crandall he wanted to talk to him about some issues involving his computer, Crandall agreed to follow the agent to the Knoxville Police Depart-

ment Internet Crimes Against Children Office and speak to him.

Upon arrival, Crandall was read his Miranda Warnings from a written form and he agreed to speak to Agent Schneider and Detective Tom Evans from the Knoxville Police Department I.C.A.C. Unit and signed the affidavit.

During Agent Sch-

neider's conversation with Mr. Crandall, Crandall admitted the images on the media card were of a 2 year old male family member. He admitted to removing the child's clothes, laying him on the couch, then removing his clothes and performing a sexual act on the nude child.

Crandall then admitted he again laid the little boy on the couch on his stomach and again mounted him and performed a sexual act.

Both times Crandall reported he never ejaculated and stated while he was raping the child, the child was just laughing and not reacting to what he was doing.

The charges were brought by the 9th DTF and the Loudon County Sheriff's Office was not contacted despite having an ICAC member for our area and therefore could not comment on the case and referred all calls to the 9th DTF.


Editors Note: WATE TV6 apparently gained knowledge of the case from unknown sources and were able to locate the victim and mother (which are not listed on any reports and do not live at the same location) where they conducted an interview. At least one of the facts

of the case reported by WATE TV6 were wrong including a reported videotape, which according to authorities, does not exist. Also the mother of the victim had no to little knowledge of the charges at the time of the interview which also preceded her interview with detectives and DCS. The mother of the victim also reported they have not lived together for quite some time. She contacted us to report her side which we are including with the full and correct story.

To the Editor:

I just want to say that even though I wasn't surprised to hear about the two counts of child rape on Eddy Crandall. I am however surprised to hear that these charges may concern my son. I want people to know that I always had my suspicions about Eddy. WATE TV 6 failed to tell me anything concerning my son. And the authorities have yet to release any information to me about the matter.

I had absolutely no idea and was utterly shocked to learn that he would do anything of that nature with his own son!

Records indicate Ms. Woodbury resisted arrest by not getting into the back of the patrol car. She also had thirteen tablets of tizanidine hcl 4 mg with no prescription label, which was located between the seats.

Revenue is reminding Tennessee shoppers that during these three days of savings, you can save almost 10 percent on tax-free clothing, school and art supplies and computer purchases.

"The annual Sales Tax Holiday was designed with Tennessee families in mind," said Governor Phil Bredesen. "The holiday provides much needed savings for all Tennessee shoppers and prepares children for success by making sure they start the first day of school properly equipped with items they need."

The holiday begins Friday, August 6 at

12:01 a.m. and ends Sunday, August 8 at 11:59 p.m. During the designated three-day weekend, consumers will not pay state or local sales tax on select clothing with a price of \$100 or less per item, school and art supplies with a price of \$100 or less per item, and computers with a price of \$1,500 or less.

"Last year's tax-free weekend was extremely successful in giving back to Tennesseans, providing nearly \$8 million in tax savings to Tennessee families," said Revenue Commissioner Reagan Farr. "We are hopeful that all Tennessee shoppers will enjoy the immediate relief of the 2010

Sales Tax Holiday."

In a continued effort to promote Tennessee's sales tax holiday, the Department of Revenue has launched a new dedicated facebook page at <http://www.facebook.com/TNTaxHoliday>.

Examples of exempt items include:

- Clothing: Shirts, dresses, pants, coats, gloves and mittens, hats and caps, hosiery, neckties, belts, sneakers, shoes, uniforms whether athletic or non-athletic and scarves
- School Supplies: Binders, book bags, calculators, tape, chalk, crayons, erasers, folders, glue, pens, pencils, lunch boxes, notebooks, paper, rulers and scissors
- Art Supplies: Clay and glazes; acrylic, tempera and oil paints; paintbrushes for artwork; sketch and drawing pads; and watercolors
- Computers: Central

processing unit (CPU), along with various other components including monitor, keyboard, mouse, cables to connect components and preloaded software (Note: While the CPU may be purchased separately, other items must be part of a bundled computer package in order to be eligible.) iPad's are eligible for tax exemption, video games and consoles are not.

The Department of Revenue is responsible for the administration of state tax laws and motor vehicle title and registration laws established by the legislature and the collection of taxes and fees associated with those laws. To learn more about the department, log on to www.TN.gov/revenue.


