

## Hill charged with retallation, False report harassment in dog case

Authorities charged local Greg Hill with harassment and retaliation after a woman involved in a legal case against him called E911 to report he was following and threatening her and other family members. Officers responding to the call reported locating Hill just one car behind the woman near Dixie Lee Junction prior to interviewing both parties and subsequently placing Hill under arrest.

Jack Neal Rose, 29, and Gregory Lee Phillips, 43, of Stanford, Kentucky were charged with felony possession of schedule II - 30 mg. oxycodone and felony possession of schedule IV - 2 mg. alprazolam Friday.

According to reports, while on routine traffic patrol on Interstate 75 south near the 72 mile marker, Trooper Daniel Morton, THP noticed a red and black Chevy S10 stopped in the median. There was one person in the truck with his feet hung out the driver's side window.

The officer reported he turned around to check on the person and as he approached from behind, he saw two more men running from Highway 72 to the Chevy S10. When he stopped, Trooper Morton noticed the truck was disabled due to the front tire

being off.

The man in the vehicle was identified as Jack Rose. One of the other two men was identified as Gregory Phillips who was the owner of the pickup. A NCIC check revealed a felony warrant for he arrest of Mr. Phillips from Kentucky. The men gave conflicting stories about their traveling and appeared nervous. All three gave consent to search the vehicle.

Records indicate the officer discovered a pill bottle prescribed to Gregory Phillips concealed inside the air filter/breather under the hood. Inside the bottle were 79 oxycodone 30 mg. tablets and 24 alprazolam 2 mg. tablets. The pills had strips of plastic bag stuffed around them and were packaged consistent with

recovered a red plastic container under the passenger seat that had 68 oxycodone

30 mg. tablets and 27 alprazolam 2 mg. tablets inside it. These pills also had strips of plastic bag stuffed around them and were packaged consistent with drug trafficking. The pills were all obtained in Florida and were divided, once the vehicle became disabled, between Phillips and Rose. Phillips kept his pills in his own bottle and Rose kept his in the red container. They were both charged with possession of Schedule II and IV with the intent to obtain, deliver or sale the pills.

The total amount of pills recovered were 147 oxycodone and 51 alprazolam.



ley, LCSO was dispatched to the area of Highway 70 and the Adesa Extension in reference to Greg Hill following a vehicle known to Mr. Hill as being driven by a woman who is the victim in a prior court case where Mr. Hill was the responsible party for the woman being attacked by his dogs. The female ad-

vised Loudon County E911 Mr. Hill threatened to kill her and anyone involved in the dog case. She also advised Mr. Hill may be armed with a gun. She saw him with a gun earlier in the day.

Deputy Stanley made contact with the vehicle described as Mr. Hill's vehicle, a silver Pontiac with chrome wheels and single male driver, on Highway 70 near Di-

xie Lee Junction. The Pontiac was behind the victim's vehicle with only one vehicle between them.

The deputy activated his blue lights and conducted a felony traffic stop with the help of Deputy Brandon Dixon, LCSO and Trooper Dan Morton, THP for officer safety due to the possibility of a weapon in the vehicle.

Records indicate the driver, Greg Hill, was fully compliant and showed no aggressiveness toward officers. Mr. Hill was detained at the scene and read his Miranda Rights by Deputy Dixon and consented to a search of his vehicle. No weapon was found.

Deputy Stanley spoke to the victim and a juvenile passenger who was in the vehicle with her when both were placed in

fear for their lives due to Mr. Hill following them from Mincey Street all the way to Highway 70 where he was stopped.

According to statements taken from the woman and the juvenile on the scene, Mr. Hill has been threatening her and her family in order to try to get her to drop charges against him in the dog case. The victim stated she has been told by Greg Hill on numerous occasions that he would harm her and Hill has followed several of her family members from their residence to their destinations.

Mr. Gregory Hill was placed under arrest.

Scott Allen Stephens, 43, Blair Street, Loudon was charged with DUI 3rd offense, possession of schedule III, and driving on revoked 1st offense.


According to reports, Sunday, at ap-
