## Deputy injured in foot pursuit, 1 charged

A Loudon County deputy was injured in a foot pursuit after he went to serve warrants on a local man who ran when officers showed up at his residence. The man was later taken into custody and served the warrants that prompted the pursuit.

Gabriel Alexander Coronado, 26, Ferry Street, Loudon was charged with resisting stop, frisk, halt, arrest and felony evading arrest.

The report states, Loudon County Sheriff's Deputies Brandon Dixon and Chris Jenkins went to arrest Mr. Gabriel Alexander Coronado Monday on

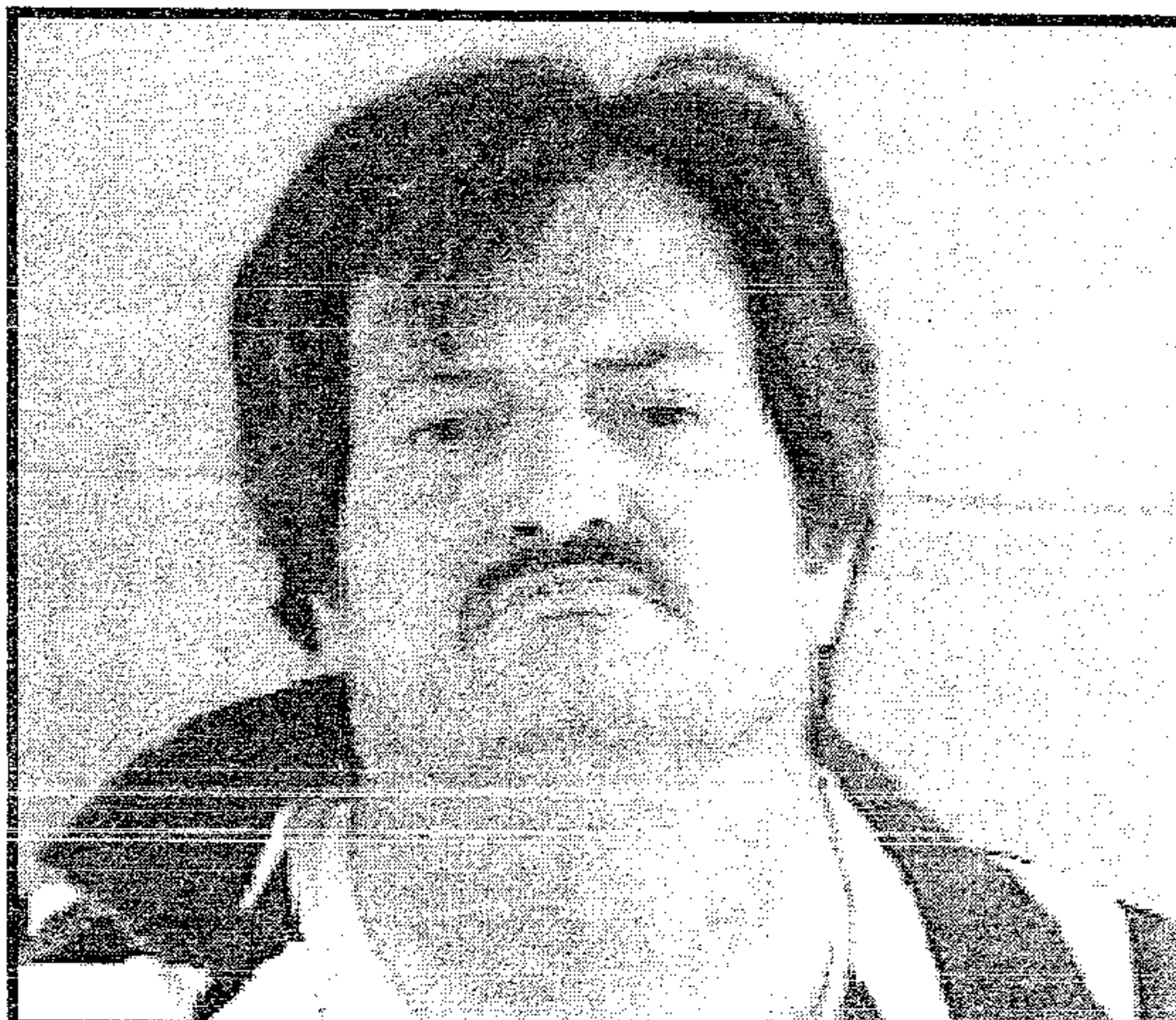
## Threats with knife, resisting arrest

A Philadelphia man is accused of resisting arrest after officers responded to his residence on a domestic violence where the victim advised she'd been beaten and threatened with a knife.

James Allen Hemphill, 46, Moss Road, Philadelphia was charged Tuesday with aggravated assault by domestic violence and resisting stop, halt, frisk and arrest.

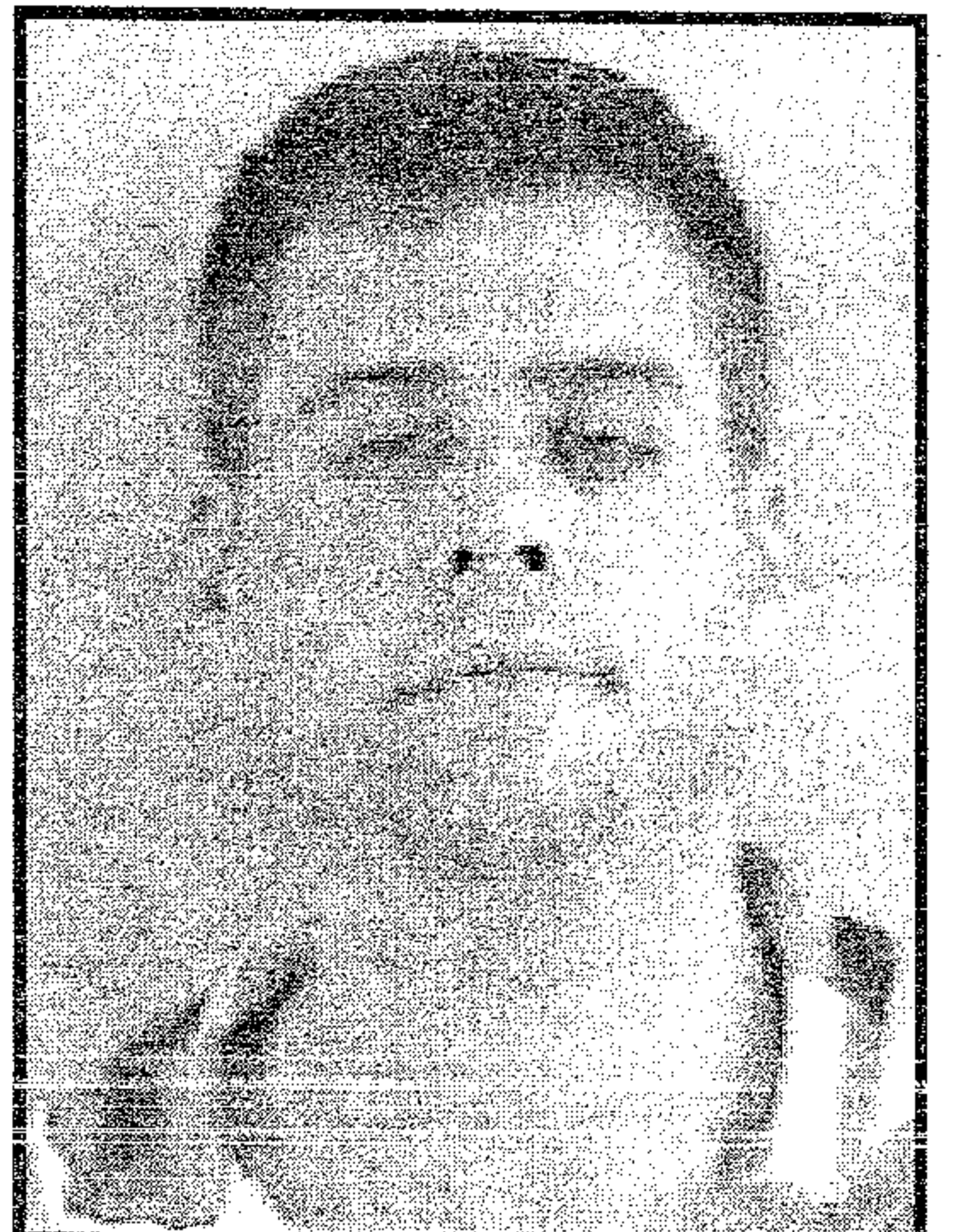

**Coronado**

a outstanding warrant for failure to appear on domestic assault with past domestic assaults and resisting law enforcement by evading. When the two lawmen arrived at Mr. Coronado's residence, Deputy Dixon exited his patrol vehicle, in uniform, and attempted to effect an arrest.

Mr. Coronado re-

sisted by running on foot and Deputy Dixon repeatedly gave Mr. Coronado several verbal commands to stop running, but he still resisted arrest.

Due to Mr. Coronado resisting, Deputy Dixon deployed his X26 Taser in an attempt to arrest him. Coronado still resisted by removing the probes and continuing to run.

Deputy Dixon again

gave verbal commands and Coronado again resisted by running on foot.

During the foot pursuit, Deputy Dixon suffered a severe injury to his right knee and was transported to the hospital by ambulance for treatment.

Coronado got away until he was located the following day at Loudon Outreach Ministries and arrest-

ed by Deputy Jason Goddard, LCSO, on charges of failure to appear, Corporal Angi Martin also served 3 attachment warrants on Mr. Coronado Tuesday while he was in the Loudon County Jail.

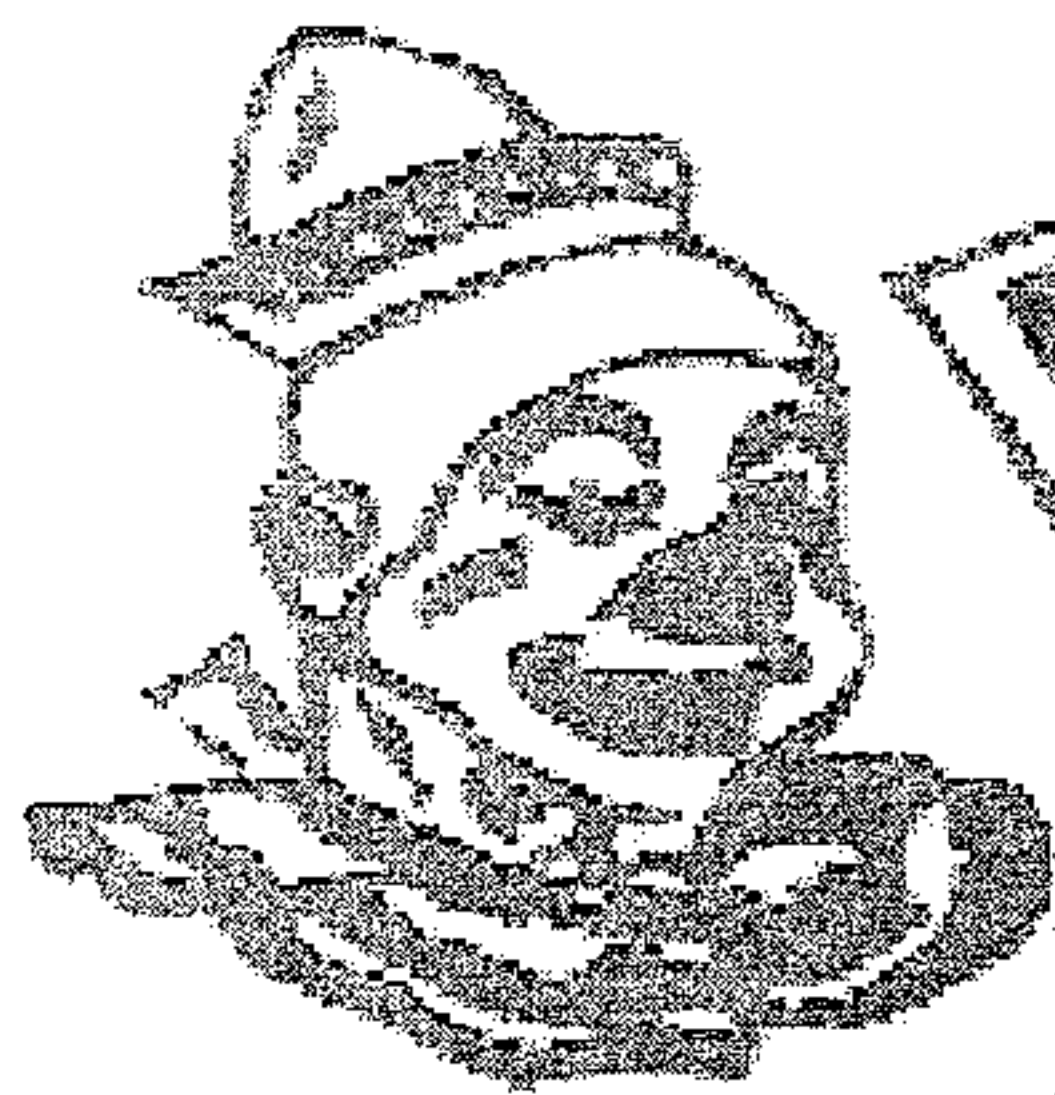
Javier Lopez Zamudio, 28, Waller Street, Loudon was charged with DUI 1st offense.

The report states, Saturday, around 10:30 PM, Officer Bennie Houser, LPD saw a white Dodge Ram with no tail lights traveling on Grove Street and turn north onto Mulberry Street. The officer fell in behind the vehicle and noticed it cross the

center line numerous times and the speed was erratic. He stopped the truck in the Mr. Gas parking lot and made contact with the driver Mr. Zamudio.

Zamudio had a strong odor of an intoxicant about his person and stated he drank one or two beers. During the field sobriety tasks, Mr. Zamudio would not open his mouth and swallowed whatever he had in there, which left his mouth white.

Zamudio performed poorly on field sobriety. Mr. Zamudio was read implied consent and was transported to Fort Loudoun Er for a BAC prior to going to jail.

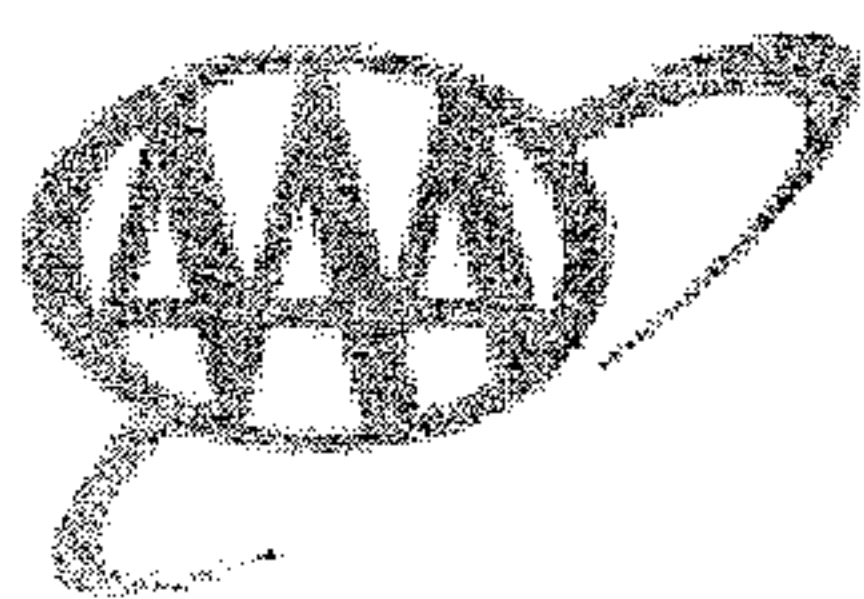

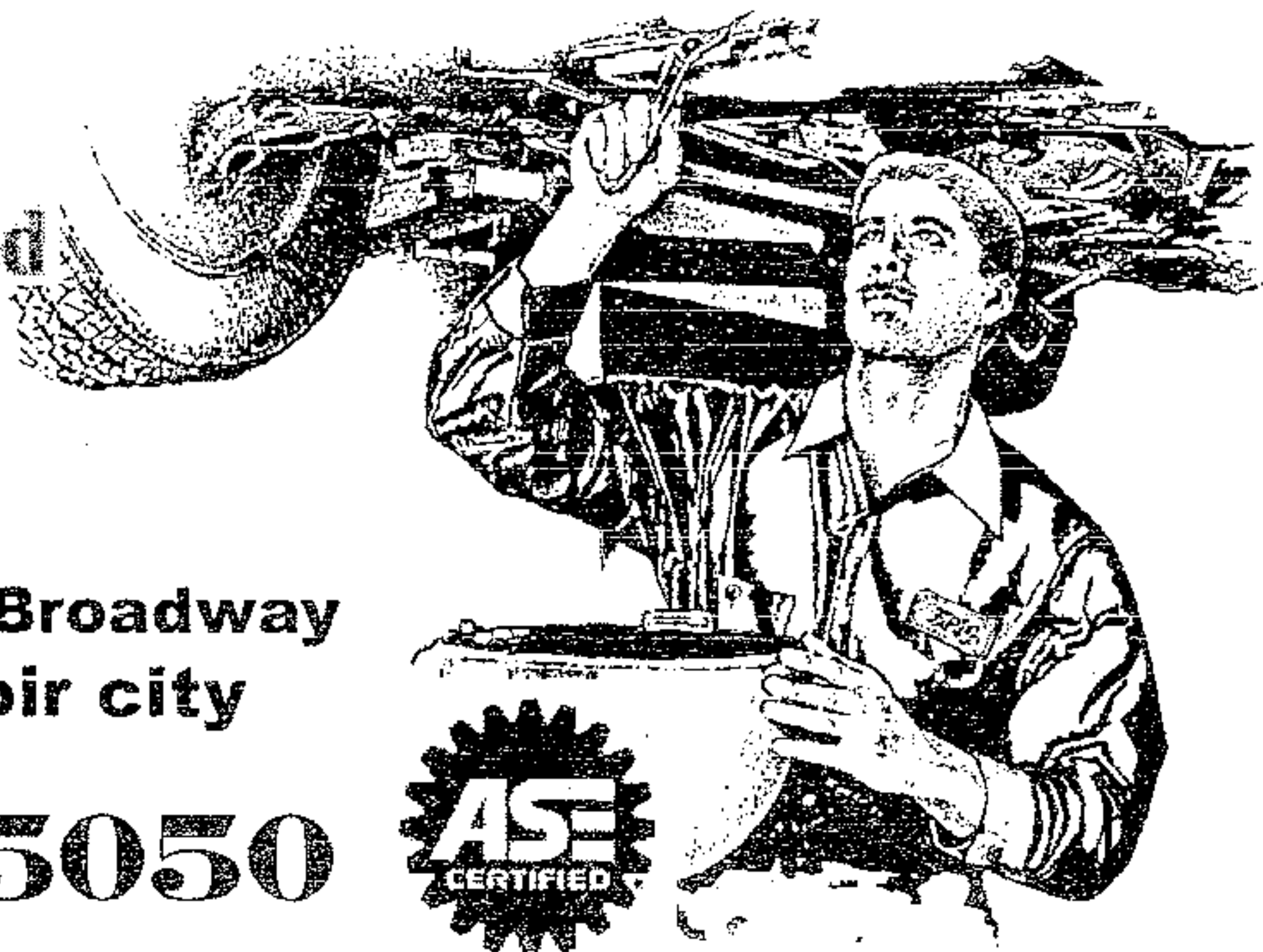

hill had been drinking and assaulted her in the back bedroom after he threatened her with a knife in the living room.

Mr. Hemphill was on the couch yelling and screaming, and a steak knife was on the coffee table within his reach. After securing the knife and separating the pair, the deputy told Mr. Hemphill to stay on the couch where he could see him while he talked with the victim on the front porch.

Deputy Jenkins attempted to speak with the woman, but Mr. Hemphill would not let him. He began screaming and yelling and trying to come to the door.

Hemphill was told repeatedly to stay on the couch, but continued to scream and yell. Then he went to the sliding door in the living room and stated he was not going to jail and fled the resi-

dence on foot.

Mr. Hemphill was told repeatedly to stop resisting and get on the ground, but he did not comply. He was taken to the ground in an attempt to effect an arrest and was taken into custody.

Hemphill had a strong odor of an alcoholic beverage about his person, was unsteady on his feet and had red watery glassy eyes. According to the deputy's report, the victim had red marks on her right and left biceps and the back bedroom door and frame was busted. She stated several times, she was scared for her life.

Deputy Jenkins deemed Mr. Hemphill to be the primary aggressor in the altercation and took him to jail.

**Chastain**

A Loudon man wanted for theft and burglary reportedly tried to run from officials, but was taken into custody a short time later by fellow lawmen.

Cody Michael Chastain, 19, Welch Avenue, Loudon was charged with criminal court capias, resisting arrest, and evading arrest.

According to records, around 8:00

PM, Sunday, Deputy Charles Butler, LCSO noticed Cody Chastain walking down Mulberry Street and stopped and exited his patrol unit. He approached Mr. Chastain and escorted him back to the patrol car and advised him he was under arrest due to having a warrant in hand for burglary and theft.

Chastain reportedly pulled away from the deputy, who ordered him to stop, but Chas-

tain continued to flee toward the Huffland Drive area.

Deputy Butler then engaged in a foot pursuit of Mr. Chastain, all the while giving him loud verbal commands to stop. He lost sight of him around the Welch Avenue area.

After patrolling the area for about 45 minutes, Chastain was located at a residence on Welch Avenue by LPD after a neighbor observed him enter the residence.

**Smiddy**

An Oak Ridge man received his third DUI charge after THP officials stopped his vehicle when it was seen driving all over the roadway along the I-75 Monday.

Paul Jacob Smiddy, 31, Balboa Circle, Oak Ridge was charged Monday with DUI 3rd offense, violation of implied consent, and

driving on suspended license.

According to reports, Mr. Smiddy was driving north on Interstate 75 and was weaving and swerving from lane to lane. His white Chrysler Sebring drove on the shoulder numerous times and had a near miss crash with another car. Smiddy was also following a semi truck at less than 1 car length.

Trooper Daniel Morton, THP stopped the vehicle just past the split on I-40. Mr. Smiddy had slurred speech, watery eyes and his pupils were dilated, even with light present.

Smiddy admitted to drinking alcohol and taking xanax and performed poorly on standard field sobriety tasks. NCIC revealed Mr. Smiddy's license were suspended for failure to satisfy citations x 3, frequent traffic violations, a reckless driving in 2007, and DUI's on April 18, 1998

and April 10, 2000.

While in the patrol car on his way to jail, Mr. Smiddy stated "I'm Screwed!"

Joseph K. Smith, 24, Jan Way, Lenoir City, was charged Saturday with domestic assault.

According to records, Patrolman Jeremy Dishner, LCPD responded to a 911 call from an apartment on Jim Hartsook Drive determined it was a domestic disturbance.

Smith reportedly refused to allow his girlfriend to leave the bedroom where they were having an argument. Mr. Smith stood in the doorway and refused to allow her to leave, although she asked him several times to move so she could leave.

The woman was able to get by after several attempts, but in the process she was injured. Her injury was approximately 6 inches in length to the top of her left arm.
