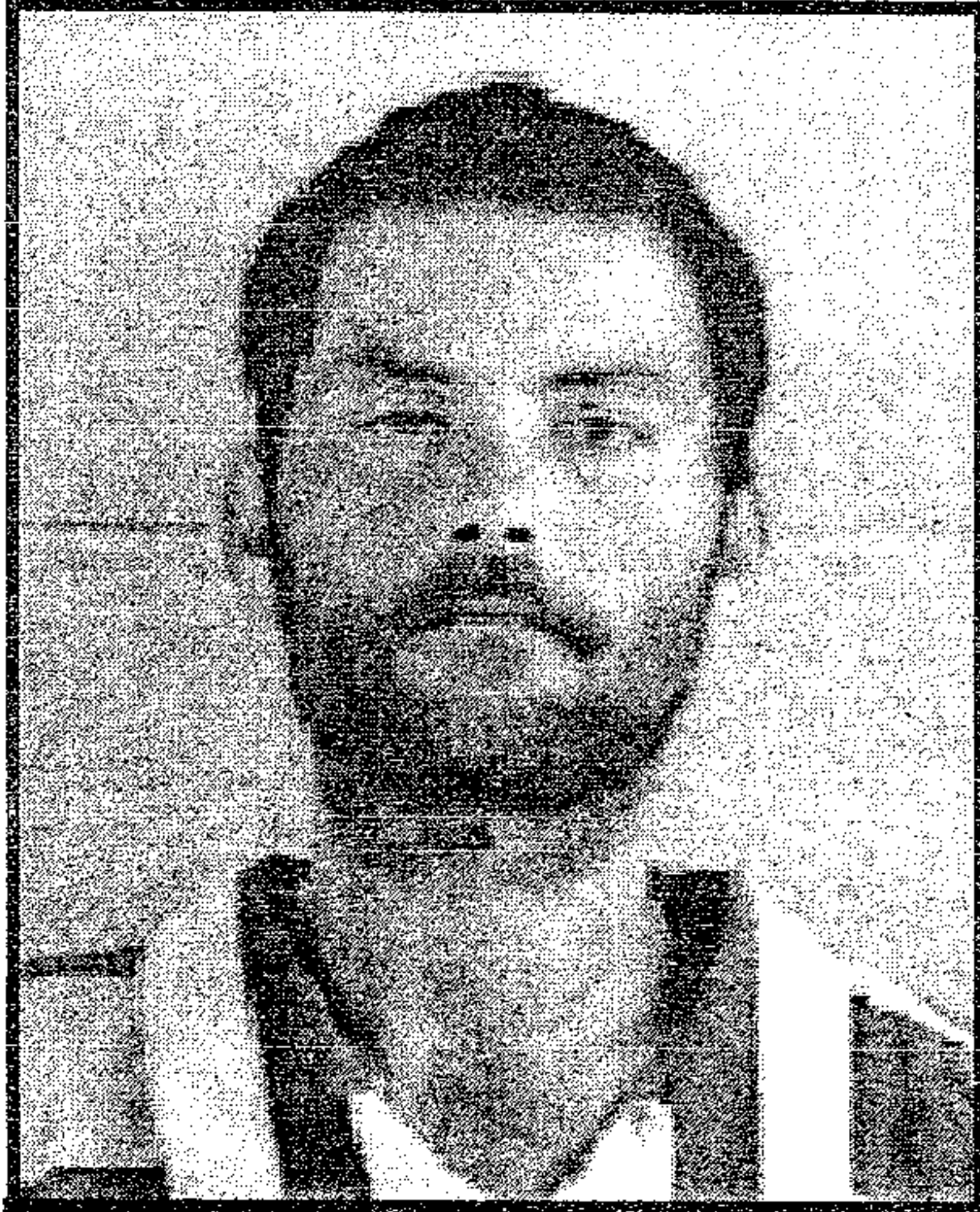

Trio turns on inmate after officer's business card found

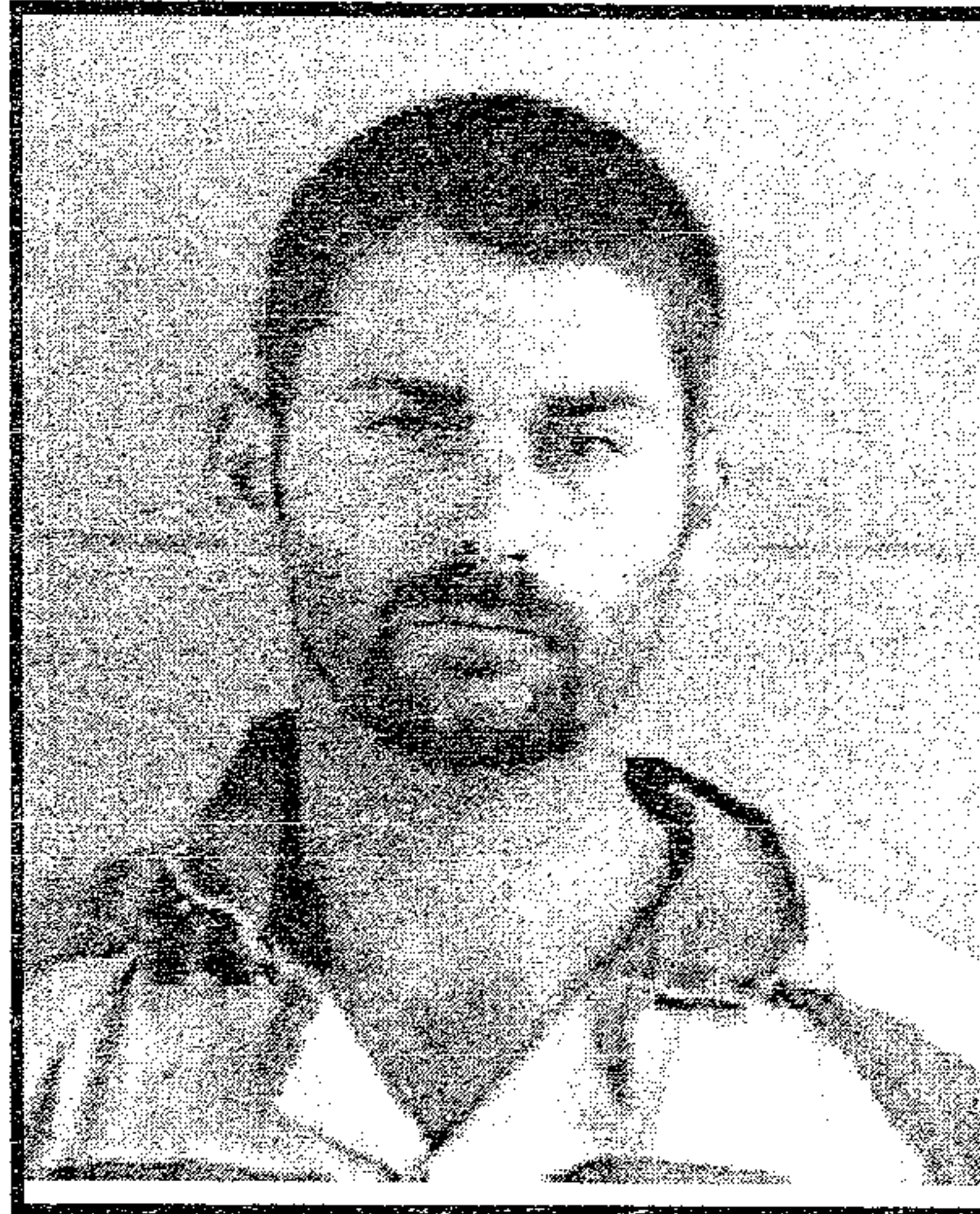

Bobby Lee Littleton, 30, Pathkiller Trail, Loudon and

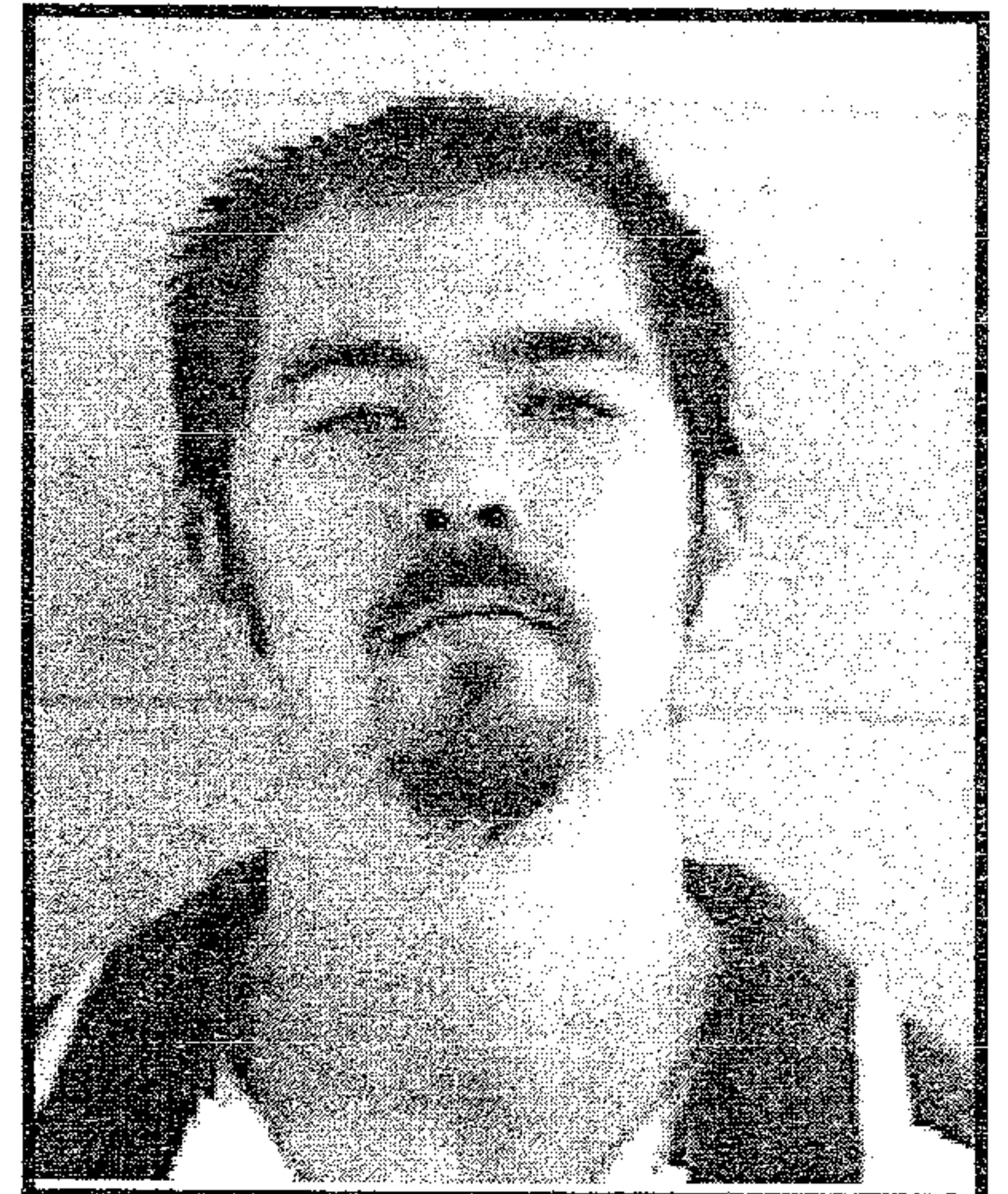

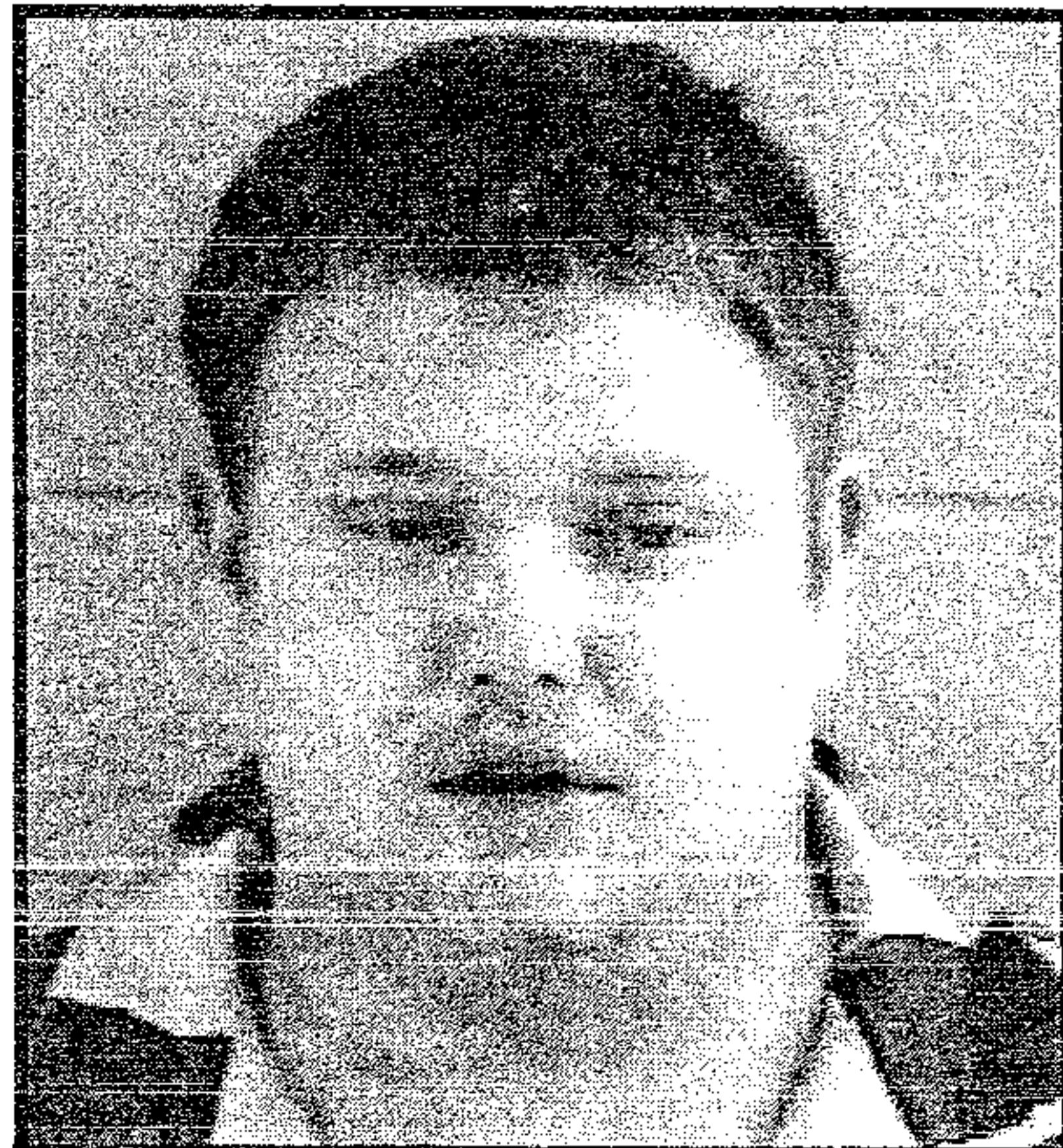
Inmates team up on Coronado

Two inmates at the Loudon County Jail were charged with aggravated assault after they reportedly teamed up on a third inmate and beat him causing severe injuries.

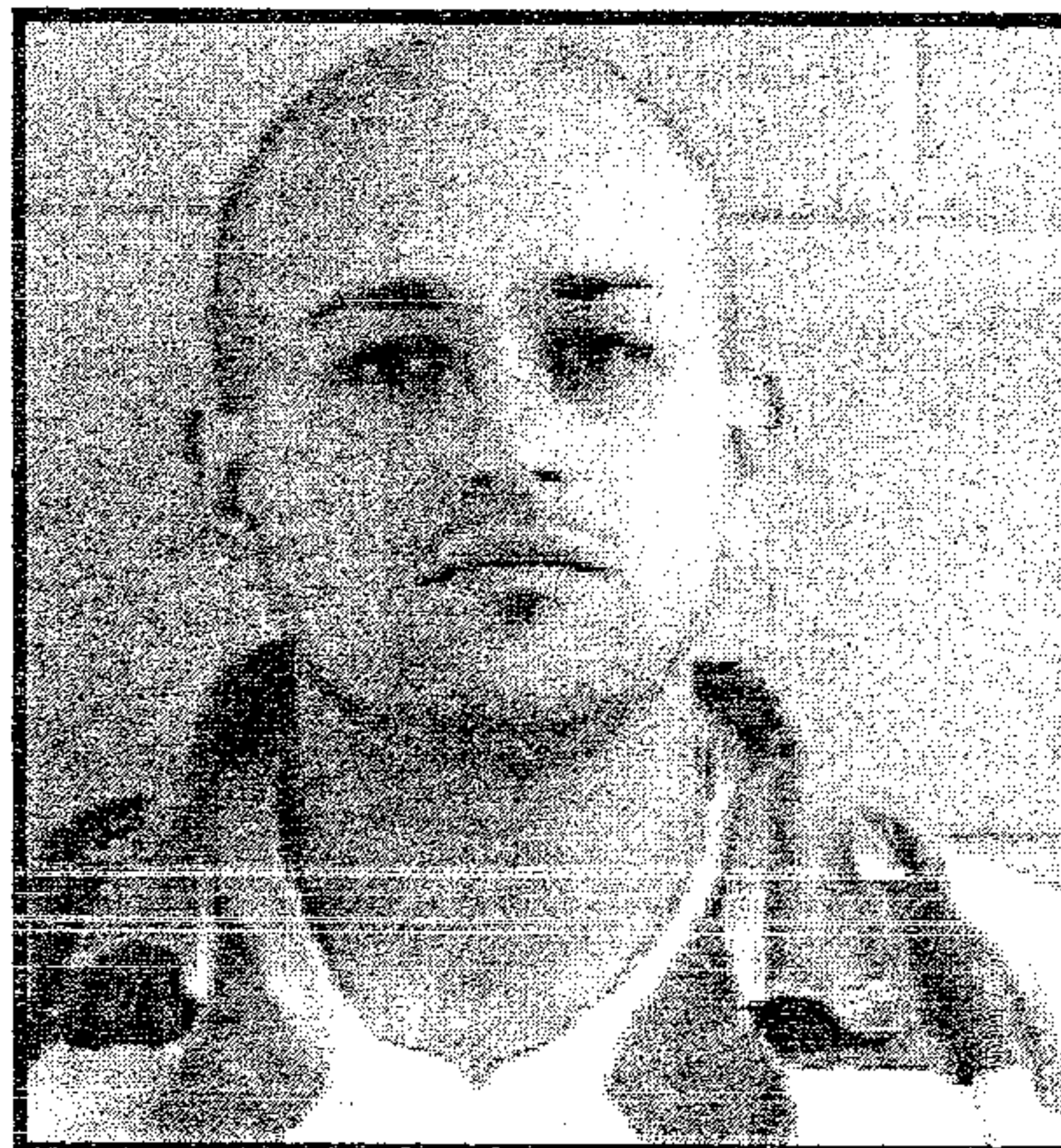

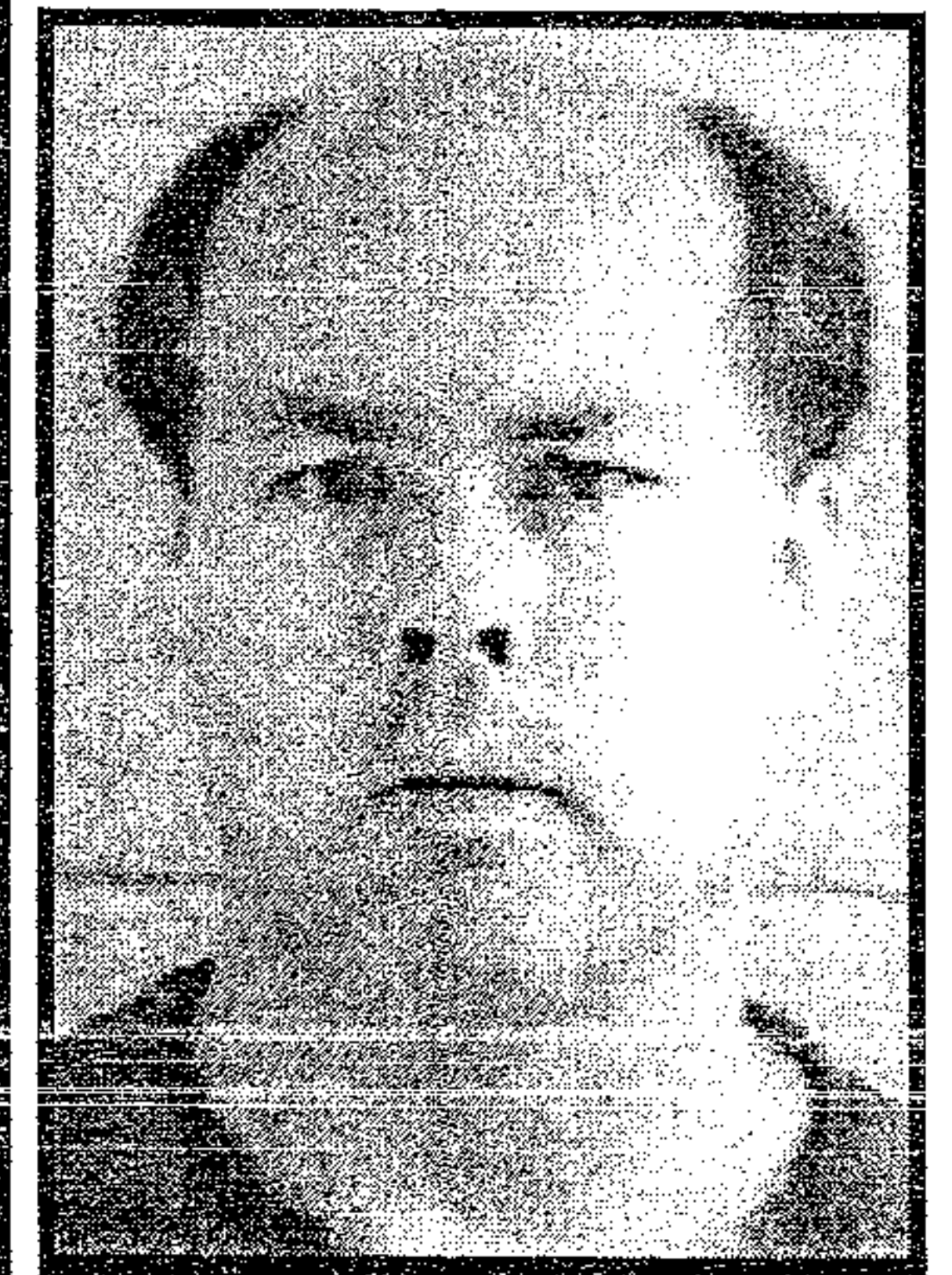

A Greenback man found himself in the hoosegow after allegedly firing weapons towards another residence in his neighborhood after having his stereo playing so loud it was disturbing others.

Richard Gerald Gillette, Jr., 45, Black Road, Greenback was charged with reckless endangerment.

According to an affidavit filed by Deputy Craig Brewer, LCSO; according to witnesses, on August 18th, 2010,

around 10:50 PM, Richard G. Gillette, Jr. was outside his residence and had the stereo in his home turned up so loud it was disturbing the neighbors. Then the neighbors started hearing shooting coming from the direction of Mr. Gillette's home. When they went outside they saw Mr. Gillette on the front porch.

Gillette then went to the car in the driveway and started shooting what they thought to be two different handguns in the direction of the residence across the roadway from his

home. He did this several times while they were watching.

Mr. Gillette was shooting in a manner that had no regard for others safety or his own safety.

When Deputy Brewer approached the residence and knocked on the door to try and talk with Mr. Gillette about his shooting at night and towards residences, Gillette turned up the radio and would not respond to the knocks on any of the doors. The deputy could see Gillette in the residence through the blinds on

the windows.

According to the description given to Deputy Brewer by the witnesses, it matched what Mr. Gillette was wearing and the description of the male they saw in the yard doing the shooting.

Deputy Brewer arrested Mr. Gillette on a Tennessee state warrant Monday.

Travis Blake Langley, 25, Vonore Road, Loudon was charged Sunday with assault domestic violence.

The report states Deputy Marty Stanley, LCSO responded to a residence on Vonore Road in reference to a complaint of an ongoing domestic situation. Upon arrival, the deputy found Mr. Langley sitting in a vehicle and his wife standing outside the vehicle on the side of the road crying.

Mr. Langley was determined to be the primary aggressor and was placed under arrest. Deputy Chris Jenkins, LCSO was also on scene.

2010, Mr. Gabriel Coronado was brought to the Justice Center and was processed into the jail. At approximately 4:00 PM, he entered A Block cell.

Coronado advised he went over to a bunk to sit down and was struck in the head by a fist or foot. He advised Mr. Justin Bullard and Mr. Alfredo Fernandez started kicking him several times and he was unable to defend himself.

Coronado stated after he begged several times for the pair to stop because they were killing him, they stopped and made him leave the cell.

Upon further investigation, it was learned Mr. Coronado received a broken nose, broken sinus cavity, chipped teeth and lacerations about the face from the assault and was taken for emergency medical treatment.

Lt. Upton reported he interviewed Mr. Bullard and Mr. Fernandez. Both men admitted to the attack and said it was carried out because of some things Mr. Coronado had said to Mr. Fernandez's girlfriend. Both men admitted they kicked Coronado several times and Mr. Bullard had on shoes. Both Fernandez and Bullard advised Mr. Coronado did not even have a chance to get in a single punch.

for aggravated assault Tuesday.

Brent Allen Snyder, 27, Caldwell Road, Loudon were charged with assault

According to affidavits filed by the victim; on or about August 17th, 2010, the victim, also an inmate at the Loudon County Jail stated inmate Brent Snyder found Detective Jeff Russell's business card inside his

belongings. Mr. Snyder accused him of being a snitch and he said to Mr. Snyder he wasn't.

The complainant/victim said he was on the phone at the time that Mr. Snyder approached and then Mr. Snyder attempted to pull him away from the phone. The complainant/victim grabbed onto the bars to avoid being pulled into the cell.

At that time, Inmate

Ricky Littleton appeared and began hitting the complainant's hand with a cup to force him to release the bars. Once he released the bars Bobby Littleton, also an inmate, struck him in the nose with a closed fist and in the jaw. Mr. Snyder also struck him in the head and in the jaw.

After examination by the nurse it was found the complainant/victim had broken cartilage in his nose. He stated he did nothing to provoke the incident.

Corporal Angi Martin, LCSO served the warrants Friday.

Shawntay Nicole Jones, 31, Bell Road, Knoxville was charged Friday, with possession of schedule II (oxycodone), possession of drug paraphernalia, and public intoxication.

According to the affidavit filed by Investigator Jason Butler, LCPD; on August 20th, 2010, officers with the Lenoir City Police Department were dispatched to the Marathon Gas Station,

located at 1114 Highway 321 North, Lenoir City in reference to a possible intoxicated female. Officer Emily Lawson, LCPD located the female, identified as Shawntay Jones in the rest room.

Jones appeared to be under the influence of a controlled substance and was a danger to herself and others. Subsequent to Officer Lawson locating Jones, Jones identified her vehicle, a 2001 Audi A6 in the parking lot of the Marathon Gas Station, which was being occupied by Lawrence Huling, whom also appeared to be under the influence of a controlled substance, and was a danger to himself and others.

Lt. David Flynn, LCPD obtained verbal consent from Jones to search the vehicle. Subsequent to a search of Jones's vehicle, officers found two small straws in the driver's side door, which are commonly used to snort controlled substances. Officers also found seven, 30 mg oxycodone tablets in

the inside zipper pocket of a purse containing Jones's personal property, as well as her Tennessee drivers license.

Jones stated to officers she does not have a prescription for oxycodone.

After Huling was advised officers were investigating the vehicle for evidence of a drug crime, Officer Lawson observed Huling reach into the front passenger side of Jones's vehicle and dip a small red straw into a cup of liquid and then Huling put the straw into his mouth in an attempt to prevent officers from finding the straw.

Lawrence Bradley Huling, 32, Bell Road, Knoxville was charged with possession of drug paraphernalia, tampering with evidence, and public intoxication.

Subsequent to a search of Jones's person at the Loudon County Jail, officers found one small red straw concealed in her clothing, which was similar to the other two straws found in her vehicle.
