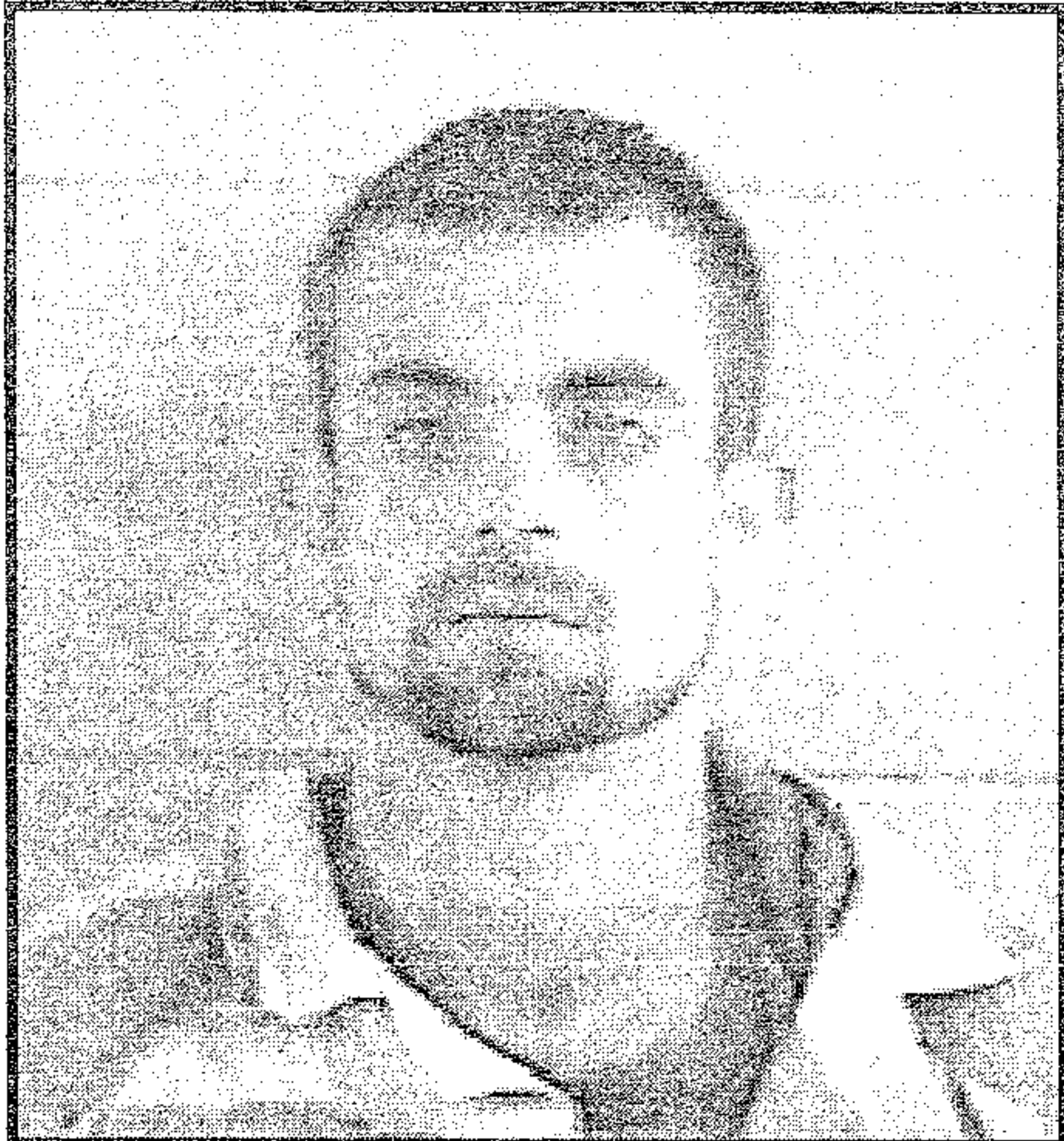

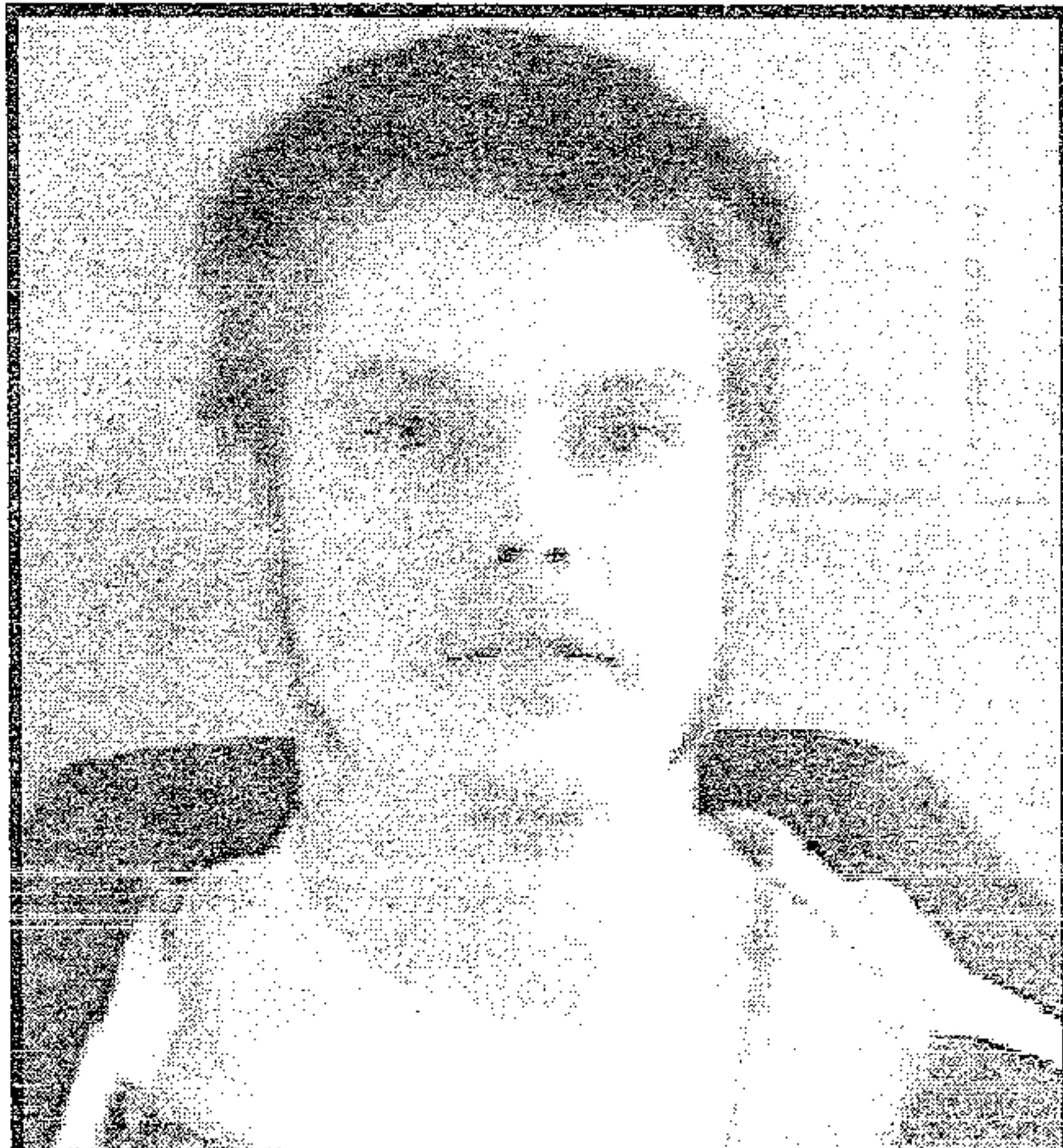

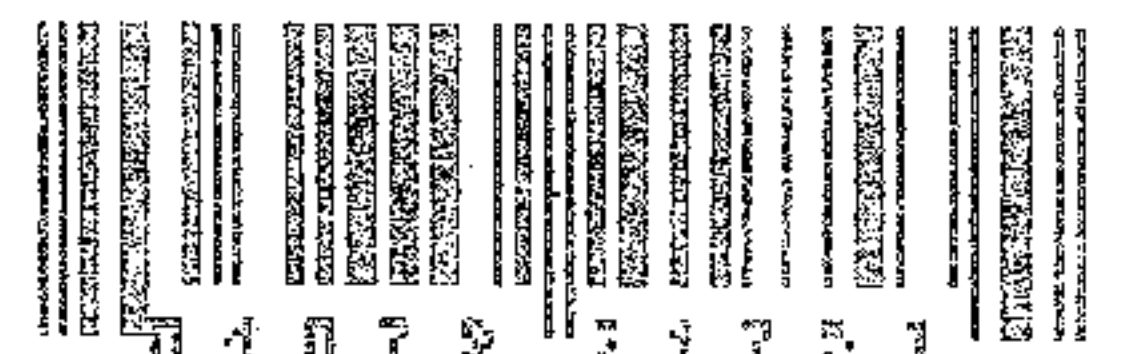

**Robertson**

According to an affidavit filed by Sgt. Lynette Ladd, LCPD; Sunday, July 25th, 2010, William Robertson committed the offense of simple assault while at the E-Z Stop on West Broadway in Lenoir City. Robertson assaulted a man by striking him in the mouth. The man was a customer at E-Z Stop with Robertson's ex-girlfriend.

According to the victim and witnesses, Robertson chased the man around a vehicle and struck him with his fist. Robertson fled the scene and was located a short distance from E-Z Stop in an out-building.

The victim had an injury to his mouth and went to City Hall to sign a warrant with the clerk for simple assault. Robertson

was transported to the Loudon County Jail by LCPD.

On Monday, was incarcerated at the Loudon County Jail when he was served a warrant for domestic violence assault.

According to the affidavit filed by Robertson's ex-girlfriend, when she picked up Robertson from work, he started "nitpicking" at her. She told him to leave her alone.

When they arrived at their residence on River Street, Robertson took her keys out of her purse to leave. She didn't want him driving her vehicle. She got mad and started breaking dishes.

Robertson told his ex-girlfriend's kids to get in their room and shoved one of the kids into the wall. The woman walked over to check on her child and the child showed her a bruise and said, this is what "Dale" did.

Robertson reportedly then punched

his ex-girlfriend in the back of her head. She asked him "what was that for?" and Robertson picked her up by her throat and attempted to put her head through a wall.

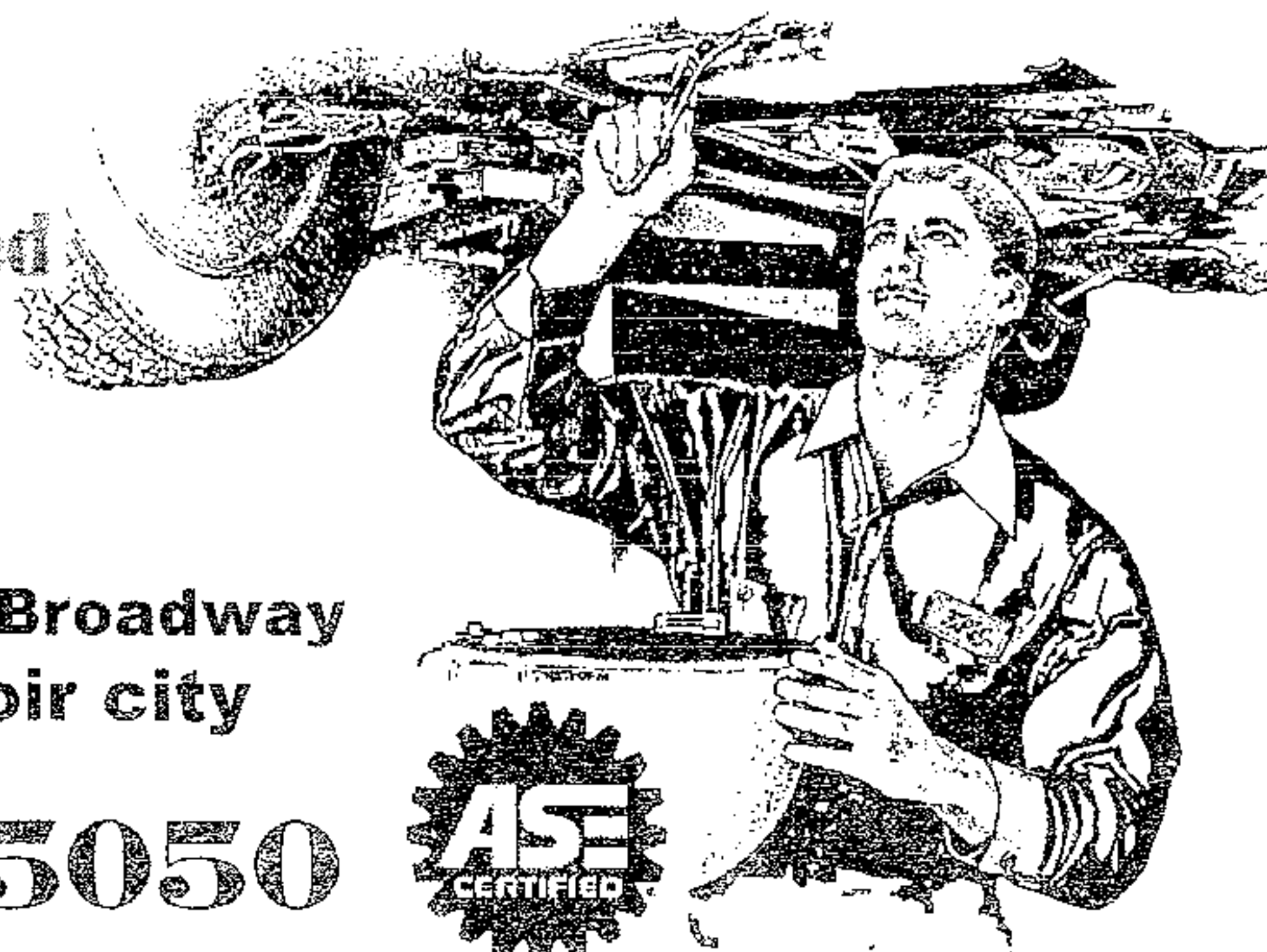

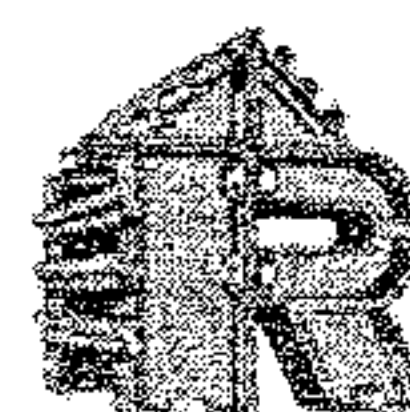

### Crouch
