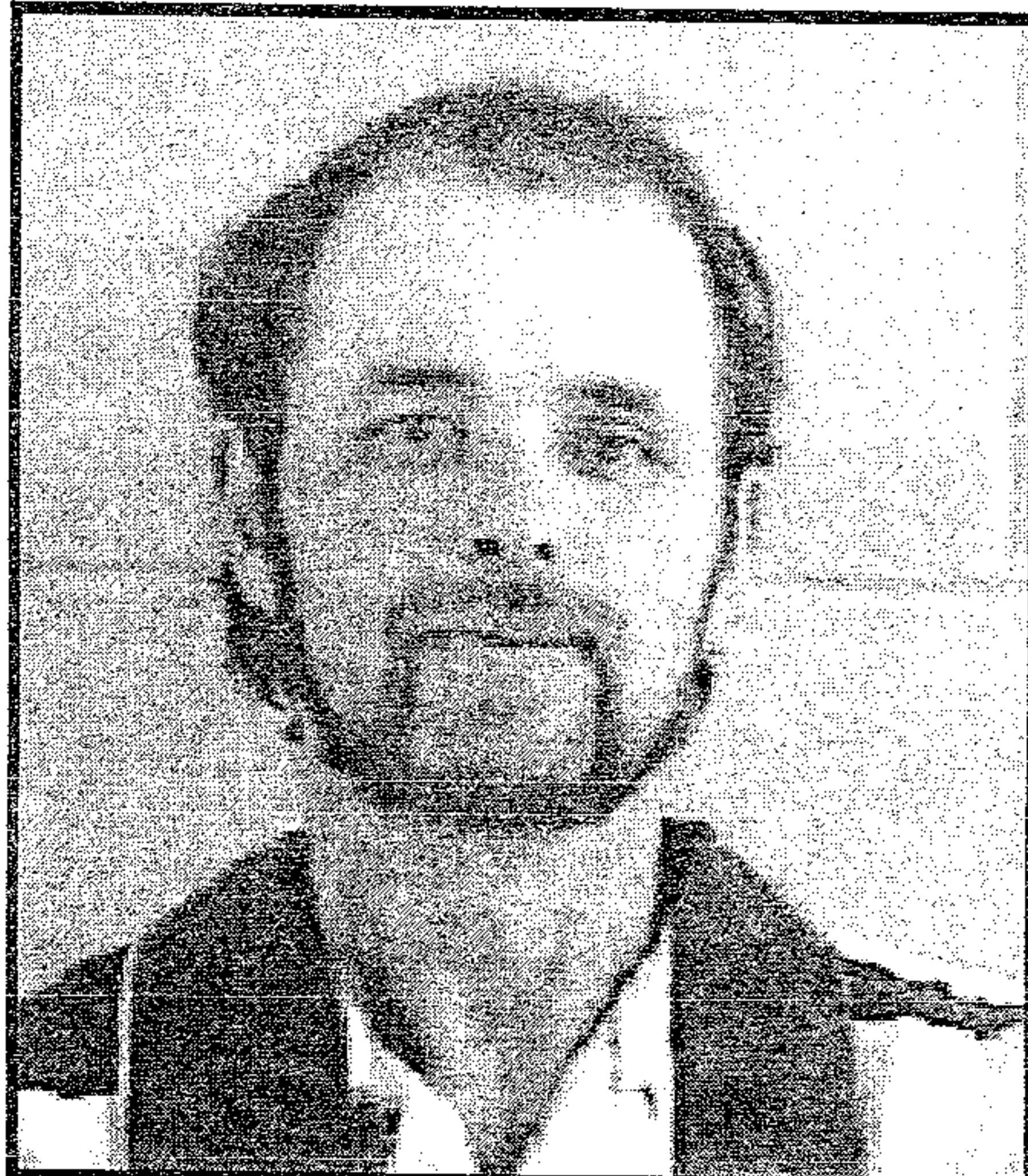

Alleged addict charged with burglary, more

Yokley, LCSO was dispatched to a residence on Cox Road concerning a possible breaking and entering into a garage. Deputy Craig Brewer, LCSO went to the scene and got a description of the suspect.

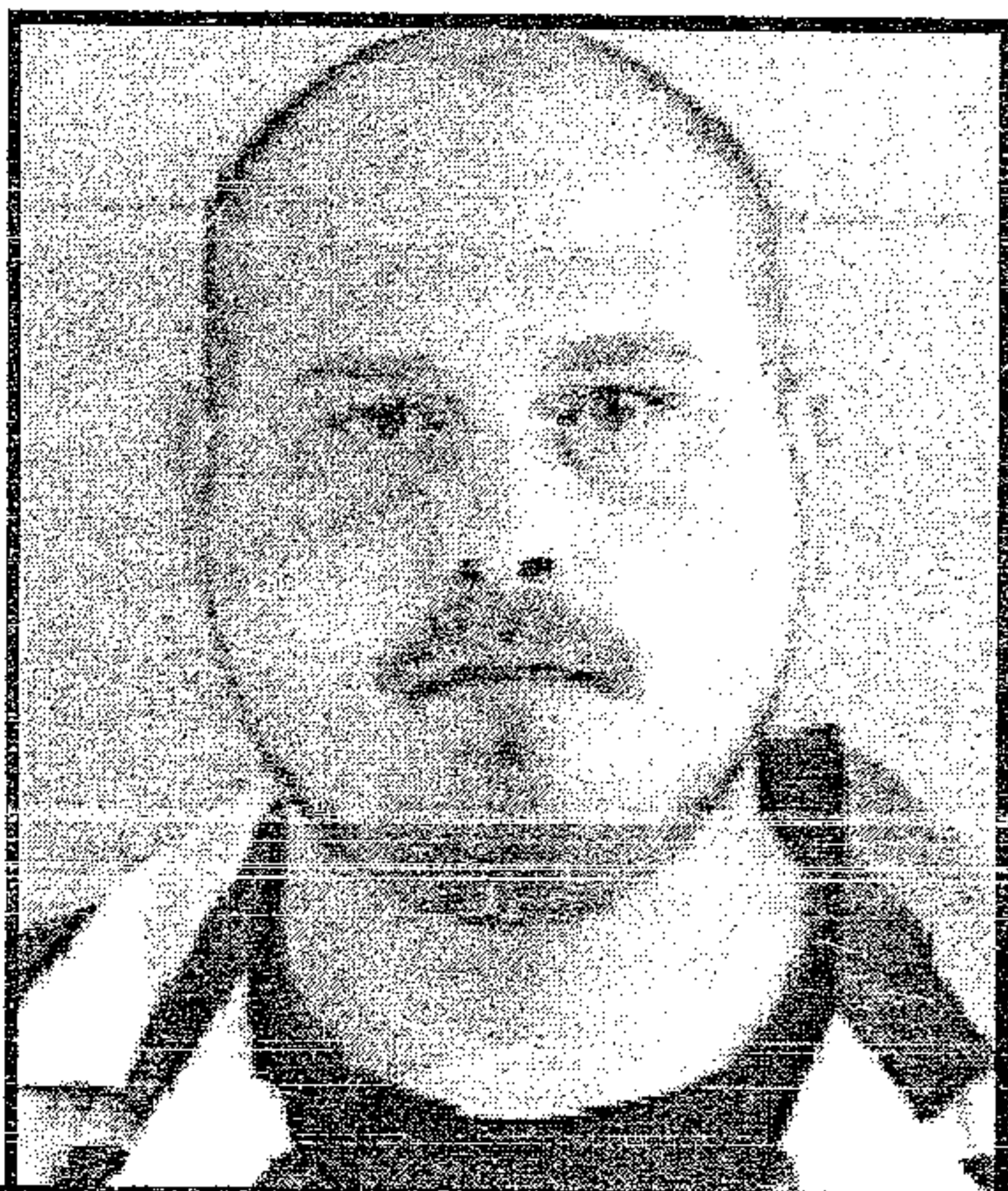

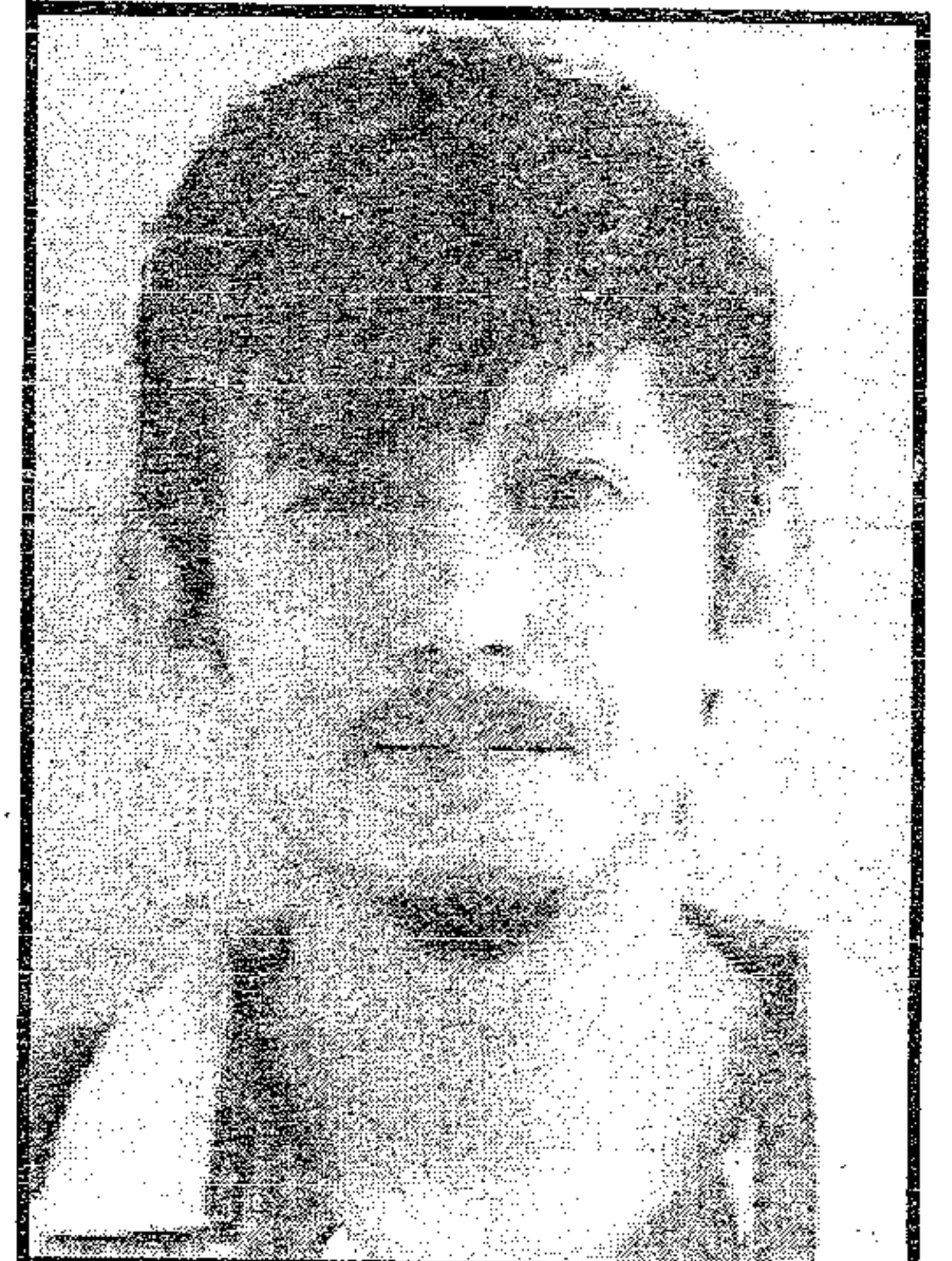
Man terrorizes family with death threats

Almanza

Detective Jack Fine, LCPD; on August 25th, 2010, at approximately 12:22 AM, Mr. Almanza was in a white Mitsubishi when he stopped in front of the victim's house on Doyle Street and yelled threats at the victim indicating he would shoot the victim's son. The lawman noted Almanza committed the offense once before, on or about August 13th, 2010. Almanza's actions

have placed the victim and the victim's juvenile son emotional distress, and caused them to be terrorized, frightened and intimidated.

Corporal Angi Martin, LCSO served the warrant at the jail Thursday.

Season

Sept. 1 through Sept. 26; Oct. 9 through Oct. 24; and Dec. 19 through Jan. 15. Hunting times, other than opening day, are one-half hour before sunrise until sunset for all other days.

Doves are found throughout the various regions in the state, but the most concentration is in farming areas. The hunter must have on his/her person a valid state hunting license and Tennessee Migratory Bird Permit at all times while hunting. Hunters must have landowner's permission to hunt on private land.

The daily bag limit is 15. There is no limit on collared dove. Doves not readily identifiable as collared doves will be considered mourning doves and will count toward the mourning dove daily bag limit. No person shall take migratory game birds by the aid of baiting, or on or over any baited area. Any auto-loading or repeating shotgun must be incapable of holding more than three shells while dove hunting.

website (www.tnwildlife.org) under the "For Hunters" section. The 2010 Tennessee Hunting & Trapping Guide can also be viewed on the Web site or a copy may be obtained at any TWRA regional office or wherever hunting and fishing licenses are sold.

Morgan

While checking the area of Dailey Avenue and Blair Bend Road, Sgt. Yokley observed a white male that matched the description of the suspect. When the officer approached the man he

noticed a strong odor of an alcoholic beverage on his breath and person. He was identified as Arless Morgan III.

Mr. Morgan did poorly on field sobriety tasks and was placed under arrest. While searching the backpack he was wearing, a spoon with a burned bottom and a hypodermic needle were discovered inside. Mr.

Morgan reportedly made the statement he was a drug addict.

On Friday, Deputy Lonnie Gaut served a warrant for burglary on Morgan while at the jail after the victim was called in and identified him.

According to that affidavit, which was filed by Lt. Patrick Upton, LCSO-CID; on or about August 26th, 2010, Mr. Alex Whitt,

Cox Road, Loudon went to his garage around 9:30 PM and upon entering saw someone ran out the back door, dropping tools which had been taken from the garage. Mr. Whitt described the man as being a white male with a beard, hat and blue jeans. Upon further investigation, deputies found Mr. Arless Morgan III behind the res-

idence and he matched the description of the burglary suspect. He was arrested for possession of drug paraphernalia and public intoxication.

Upon further investigation, Lt. Upton took the victim through a six person lineup and he picked the photo of Mr. Morgan as the subject who had taken his tools from the garage and fled.

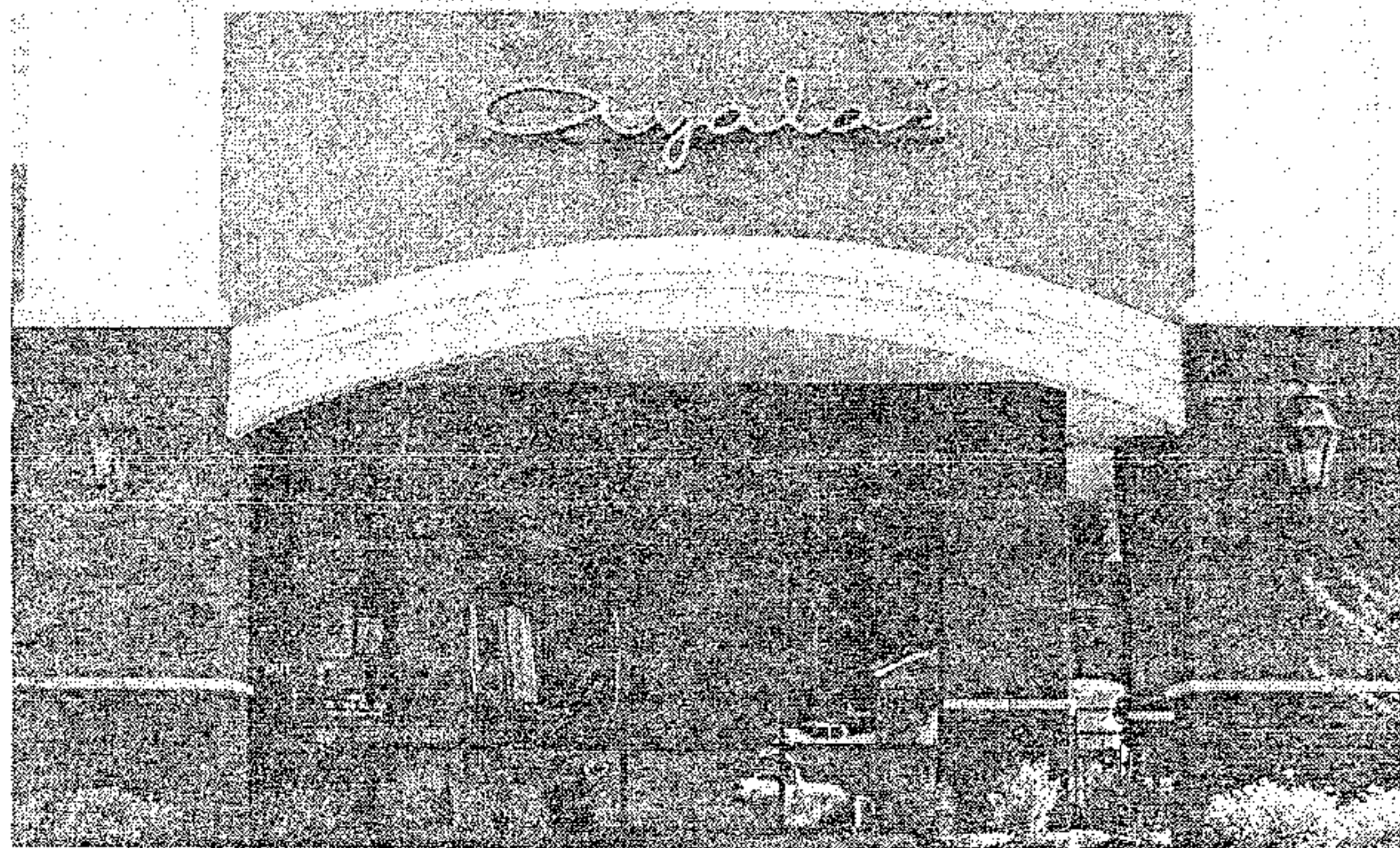
