Acts 20: 16-24 (NKJ)

to Ephesus and called for the elders of the church. 18 And when they had come to him, he said to them: "You know, from the first day I came to Asia, in what manner I always lived among you, 19 serving the Lord with all humility, with many tears and trials which happened to me by the plotting of the Jews; 20 how I kept helpful, but proclaimed it to you, and taught you publically and from house to house, 21 testifying to Jews, and also the Greeks, repentance toward God and faith toward our Lord Jesus Christ. 22 And see, now I go bound in the spirit to Jerusalem, not know-

ing the things that will happen to me there, 23 except that the Holy Spirit testifies in every city, saying that chains and tribulations await me. 24 But none of these things move me; nor do I count my life dear to myself, so that I may finish my race with joy, and the ministry which I received from the Lord Jesus, to testify to the back nothing that was gospel of the grace of sible for the persecution, God.

> Each of us as Christians received the same instructions that Paul did from Jesus, to go and testify to the gospel. Paul went on to Jerusalem where he was beaten, put in prison and chained while preaching to his accusers, the courts and the jailers. He was eventually released, kept preaching, imprisoned again, beaten again and eventually

killed. And he was glad to do it!

We have no danger in America of getting harmed or imprisoned for sharing our faith in Christ but many of us still don't do it. The only thing standing in our way is the sin we can't let go of and our own pride. Paul wasn't from heaven or superhuman. He was responbeatings and murders of Christians before Jesus changed him, forgave him and told him to go and share the gospel to all nations. Paul realized how big and how real Jesus is and how important His work should be in our lives. Do you?
