son Drive and spoke to a witness who stated Donna Purdy came to her residence around 3:30 AM. While she was there, Purdy's son Paul Dailey walked from he and his mother's residence on Johnson Drive to the witnesses house to confront his mother. The woman said she let Mr. Dailey in and he started arguing with his mother, Donna Purdy.

According to the witness, Mr. Dailey wanted Donna Purdy to give him her medication and she wouldn't give it to him, so he grabbed her by the throat and tried to get her purse away from her. He wasn't able to get the purse before the witness called law enforcement.

Mr. Dailey fled the

Later, Lenoir City Police Department stopped a vehicle on Harrison Road at the Lenoir City High School and Mr. Dailey was in the vehicle. Loudon County Sheriff's Office advised LCPD they had domestic violence charges on Dailey. LCPD placed him under arrest.

Sgt. Jeremy Bowen, LCSO picked Mr. Dailey up from the traffic stop and transported him to jail. In the meantime, Mrs. Purdy was unable to write a statement at the time of the incident due to her condition, as she appeared to be under the influence of some type of medication, Law enforcement called a medic unit to the scene.

man Drive, Lenoir City was charged with simple possession of schedule II and possession of drug paraphernalia.

According to affidavits filed by Agent Richard Wood, 9th Drug Task Force; on May 17th, 2011, agents were conducting a narcotics investigation into the illegal sale of oxycodone. During the course of the investigation, agents conducted several buys at 241 Turman Drive, Lenoir City, of 30 mg oxycodone pills, utilizing a confidential source, and did receive information that

the subject of the investigation, identified as Sue Jones, had been using a gold Chevrolet truck bearing a Florida registration.

Agents made contact with the vehicle while it was being driven and discovered the registration was for a black Ford Mustang. A probable cause traffic stop was conducted for the registration violation by Agent Jon Yates, 9th DTF at 911 Highway 321 north in the Walmart parking lot.

The truck was occupied by Faith Pauly and Sue Jones.

During the stop, verbal consent to a search of the vehicle was asked of and granted by the driver, Ms. Faith Pauly.

Consensual search of a purse that Ms. Jones claimed as hers produced two bottles

of 30 mg oxycodone that were labeled to Jones and had been filled on May 11th, 2011. The bottles were for a total of 205 pills and only contained 13.

In a purse belonging to Pauly agents found a single 30 mg oxycodone pill and two devices commonly used to snort narcotics containing a powdery residue believed to be crushed pills.

9th DTF Agents Jeff Vittatoe and Brendon DeBoer were also on scene.

controlled substance, possession of schedule III controlled substance, and possession of schedule VI controlled substance.

Laura Ann Crowder 'alias' Walden, 44, Reed Springs Sweetwater Road, was charged with promotion of methamphetamine manufacture, and possession of schedule VI controlled substance.

According to affidavits; Officer Kevin Condee, LCPD, responded to Walgreen's Pharmacy Monday on a report of suspicious persons purchasing pseudoephedrine. Upon arrival, he observed a female matching the description of the suspicious person walking through the parking lot and getting into the driver's seat of a Honda Civic.

Officer Condee stopped the vehicle as it began to pull out. He then witnessed the driver, identified as Angelia Michelle King, switching seats with the front passenger, Laura Ann Crowder 'AKA' Walden.

King was ordered to get out of the vehicle and Sgt. Lynette Ladd, LCPD conducted a pat down search of King for officers safety and found a plastic ink pen barrel with white residue inside that appeared to have been used for snorting a

powder form of narcotics.

Officer Condee advised Ms. King of her Miranda Rights and she admitted she purchased pseudoephedrine and that her passenger Laura Ann Crowder 'Walden' had also purchased pseudoephedrine.

Officer Condee spoke with Ms. Crowder and she admitted she purchased cold medicine containing pseudoephedrine from Walgreen's.

The officer looked in the left rear floorboard and saw a box of cold pills in plain view. The vehicle was then inventoried prior to being towed. During the inventory search of King's vehicle an additional four boxes of cold medicine was found. The total amount of pseudoephedrine inside the vehicle was 12 grams.

A cigarette case containing a cellophane wrapper with a green plant material believed to be marijuana inside was found in the front passenger floorboard. In the driver's floorboard area, a pink zipper pouch was discovered, and it contained additional drug paraphernalia and substances believed to be methamphetamine, marijuana and lorazepam.

In addition to the methamphetamine product that was found, Officer Condee also found another zipper pouch which contained components for the manufacture and sale of methamphetamine. The items included coffee filters, lithium batteries, aluminum foil, plastic baggies, and digital scales.

Ms. King and Ms. Crowder were placed under arrest and transported to the Loudon County Jail.
