

ensure public health and wellness, a senior department official is urging individuals to throw away all perishable food that may have been exposed to temperatures above 40 degrees Fahrenheit for two hours or more.

"I understand this is a particularly stressful

and difficult time for Tennesseans, many but it's necessary to remind everyone that food compromised by a loss of electricity poses a health risk," said State Medical Epidemiologist Tim F. Jones, M.D. "A commonly held food safety philosophy is 'when in doubt, throw it out'. As you

go about the process of recovery, your and your family's health and wellness are too important to take any chances."

Foods that should be discarded include canned goods that are bulging, opened or damaged as well as those that have an unusual odor, color or texture. Perishable

food items that have above 40 degrees Fahrenheit for two hours or longer should also be thrown away. This includes meat, poultry, fish, milk, eggs and leftovers.

There are a few exceptions. Undamaged and dent-free canned food items may be cleaned. To do so, remove the labels, wash the cans, and dip them in a solution of 1 cup (240 milliliters) of

bleach in 5 gallons of clean water. Re-label the cans with a marker. Also, thawed food from the freezer that contains ice crystals or is 40 degrees Fahrenheit or below can be refrozen or cooked.

While the power is out, keep the refrigerator and freezer doors closed as much as possible. Add block ice or dry ice to your refrigerator if the electricity is expected to be off longer than four hours. Wear heavy gloves when handling ice.



been briefed by the intelligence community last August that bin Laden was in hiding "within a compound deep inside of Pakistan." Over the intervening months, intelligence agencies worked to confirm the intelligence. Then last week, President Obama determined there was enough intelligence to take action.

"Today, at my direction, the United States launched a targeted operation against that compound in Abbottabad, Pakistan," the President said from the East Room of the White House. "A small team of Americans carried out the operation with extraordinary courage and capability. No Americans were harmed. They took care to avoid civilian casualties. After a firefight, they killed Osama bin Laden and took custody of his body."

Well before the events of 9/11, bin Laden had openly declared war on the U.S. and was committed to killing innocents. His al-Qaeda group was responsible for the 1998 bombings of the U.S. Embassies in Dar es Salaam, Tanza-

nia and Nairobi, Kenya. The attacks killed over 200 people. Bin Laden was indicted for his role in planning the attacks and added to the FBI's Ten Most Wanted Fugitives list in 1999.

Intelligence agencies quickly learned that the 9/11 attacks were carried out by bin Laden's terrorist organization, and in October 2001, his name was added to the U.S. Department of State's Most Wanted Terrorists List.

"Tonight, we give thanks to the countless intelligence and counterterrorism professionals who've worked tirelessly to achieve this outcome," President Obama said. "The American people do not see their work, nor know their names. But tonight, they feel the satisfaction of their work and the result of their pursuit of justice."







Haslam Issues Executive Order on Transportation of Emergency Supplies

NASHVILLE, Tenn. - Tennessee Gov. Bill Haslam has issued an executive order suspending certain provisions affecting vehicles carrying emergency equipment, services or supplies to support the emergency relief efforts for the severe storms and tornadoes that crossed Tennessee on April 25, 2011.

"It's our priority to ensure that food, water and other emergency relief supplies can get

to those in need as soon as possible," Haslam said. "This executive order will assist in that effort, specifically ensuring there are no disruptions to the delivery of these critical needs."

Haslam's Executive Order No. 4 allows permitted vehicles to carry loads in excess of otherwise lawful maximum weight, height, length and width limits for permitted vehicles carrying emergency equipment or sup-


Spring Rabies Clinic
