The five participants will be contacted and provided information relating to the hunt. The hunt is scheduled Oct. 17-21 at the North Cumberland Wildlife Management Area.

The Wildlife and Forestry Division will provide the commission an overview of major changes that are coming in the area of big game check in. The Wildlife and Forestry Division will also provide the commission with new language that would allow for land purchases to take place without necessitating a proclamation change. Small tracts of land are sometimes purchased adjacent to Wildlife Management Areas when they become available, especially in West Tennessee.

The Boating Division will present the statewide work efforts made by boating safety during the 2011 Memorial Day holiday weekend. There were no boating fatalities recorded during the holiday period.

The Law Enforcement Division will present an overview of the efforts of TWRA wildlife officers in response to the tornadoes in East Tennessee and the flooding in West Tennessee this spring.



The call came juana, and possession from off-duty Officer April Farmer, LPD. She advised they were extremely intoxicated.

When agents arrived they found two people sleeping in the Explorer and checked on their condition. They were identified as Larry B. Phillips Jr. and Chelsea M. Boshears.

Agent Yates reported he noticed certain items of drug paraphernalia A pill crusher with lying in the back floorboard, which included rolling papers, a round

pink container that appeared to have a powder substance in it and a cut straw commonly used to snort narcot-

Agent Yates removed Mr. Phillips and asked to pat him down. Phillips stated he may have needles on him, but a check did not uncover any.

K-9 Bear was deployed on the vehicle and gave a positive alert to the presence of the odor of narcotics along the passenger side door. A search of the Explorer confirmed the items Agent Yates saw in plain view as drug paraphernalia that contained powder residue believed to be crushed pills.

residue was found in Ms. Boshear's purse and several hypodermic

needles were found in the back floorboard.

Additional search uncovered a small amount of marijuana in the center console in a candy bag, which weighed approximately 3 grams, that Ms. Boshears had access to. The third party was identified as Marla Moore, who attempted to avoid agents in the store.

An additional search

of the vehicle uncovered a clear plastic bag containing several pills. It was concealed behind the radio and accessed by removing the glove box. It contained 21 xanax, 46 oxycodone 15 mg, and 68 oxycodone 30 mg, approximately half of Moore's prescription. The pills were proceeds to Larry Phillips from Marla Moore for


