



Daniel 3: 13-25 (NKJV)

Then Nebuchadnezzar, in a rage and fury, gave the commandment to bring Shadrach, Meshach and Abed-Nego. So they brought these men before the king. Nebuchadnezzar spoke, saying to them, "Is it true, Shadrach, Meshach and Abed-Nego, that you do not serve my gods or worship the gold image which I have set up? Now if you are ready at the time you hear the sound of the horn, flute, harp, lyre, and psaltery, in symphony with all kinds of music, and you fall down and worship the image which I have made, good! But if you do not worship, you shall be cast immediately into the midst of a burning fiery furnace. And who is the god who will deliver you from my hands?"

Shadrach, Meshach and Abed-Nego answered and said to the king, "O Nebuchadnezzar, we have no need to answer you in this matter. If that is the case, our God whom we serve is able to deliver us from the burning fiery furnace, and He will deliver us from your hand, O king. But if not, let it be known to you, O king, that we do not serve your gods, nor will we worship the gold image which you have set up."

Then Nebuchadnezzar was full of fury, and the expression on his face changed toward Shadrach, Meshach and Abed-Nego. He spoke and commanded that they heat the furnace seven times more than it was usually heated. And he commanded certain mighty men of valor who were in his army to bind Shadrach, Meshach and Abed-Nego, and cast them into the burning fiery furnace.

Then these men were bound in their coats, trousers, their turbans, and their other garments and were cast into the midst of the burning fiery furnace. Therefore because the king's command was urgent, and the furnace exceedingly hot, the flame of the fire killed those men who took up Shadrach, Meshach and Abed-Nego. And these three men, Shadrach, Meshach and Abed-Nego, fell down bound into the midst of the burning fiery furnace.

Then King Nebuchadnezzar

was astonished; and he rose in haste and spoke, saying to his counselors, "Did we not cast three men bound into the midst of the fire?"

They answered and said to the king, "True, o king."

"Look!" he answered, "I see four men loose, walking in the midst of the fire; and they are not hurt, and the form of the fourth is like the Son of God."

I get cold chills just reading that last part! King Nebuchadnezzar went on to release Shadrach, Meshach and Abed-Nego. When released from the fire, all three men were in perfect health with the hairs of their head not singed and there was no smell of fire on them. Nebuchadnezzar then believed and praised God Almighty after seeing this miracle.

The fact that this account will not be on the news tonight makes it no less true.
This is the protective power of our Lord and Savior who was, is and always will be. I hope, as I grow closer to the Lord, that I will always trust Him in all of my dealings and quit sweating the small stuff. Jesus will walk through our valleys with us, just as He did the men in the fiery furnace.

Many people today may not worship golden images but worshipping our sinful lives, our possessions, our status or political image is no different. If we put our trust in Jesus Christ, we too can experience the awesome power of the

Lord. I have been forgiven, cleansed and released from the things in my life that stole the happiness and joy that I now experience.

I am far from perfect and I fail Him every day, but I am trying daily to pick up my cross and follow Him. I believe that Jesus will use Angie and I for His glory someday, somewhere. We as Christians must plant seeds of faith and trust that God will see to the harvest in His time and according to His plan.

#### Suspended driver "pulls a fast one" - right in front of 5 State Troopers!

A suspended driver is accused of trying to avoid a sobriety checkpoint by cutting across two travel lanes to turn onto another road right in front of a group of Tennessee State Troopers. He was charged with DUI and another traffic violation, however, after the long arm of the law reached out and plucked him from another street about a half mile away.

Timothy B. Farmer, 22, White Wing Road, Lenoir City was charged with DUI 1st offense and driving on sus-

pended license 1st offense.

According to affidavits; on Friday, at approximately 11:00 PM, Trooper Eric Miller, Trooper Chitwood, Trooper Beaty, Trooper Snow, and Sgt. Whitt, THP were conducting a sobriety checkpoint on Highway 70 at Creek Wood Park Boulevard when Mr. Farmer's maroon 2005 Infinity attempted to avoid the checkpoint by crossing both travel lanes and taking Creekwood Boulevard. The vehicle was stopped approximately 1/2 mile from Highway 70 where Mr. Farmer was found to have had an odor of an alcoholic beverage about his person.

Field sobriety tasks were conducted and Farmer had difficulty performing as instructed. A check of his drivers license revealed Farmer's driving privileges were suspended for failure to satisfy a

citation.

After placing Mr. Farmer under arrest, implied consent was read and explained and he consented. He was transported to Fort Loudoun Medical Center for a blood draw and then to the Loudon County Jail. Trooper Miller made the arrest.


