If we confess our sins, He is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness. Psalm 139: 23-24

Search me, O God, and know my heart: try me, and know my thoughts: and see if there be any wicked way in me, and lead me in the way everlasting.

25 meeting of the TWRC in Kingsport and discussed the possibility of a fishing guide license during this meeting as well.

The following are TWRA's proposed changes for 2012:

• Increase the creel limit on largemouth bass at Gibson County Lake in West Tennessee from 5 to 10 fish per day.

 At Lake LaJoie and Lake Placid at Chickasaw State Park in West Tennessee, replace the current 15-inch minimum length limit on largemouth bass with a 14-18 inch slot limit and a creel limit of 10 fish per day, only 1 of which can be over 18 inches.

• At Ft. Patrick Henry Reservoir in East Tennessee, place an 18-inch minimum size limit on walleye with a creel limit of 5 fish per day.

•Redefine the Boone Reservoir boundary in East Tennessee for fish regulation

purposes on the South Fork Holston River Arm from the Highway 11E Bridge to the Highway 37 Bridge at Bluff City.

• Establish a 16-inch minimum length limit for lake trout on Watauga Reservoir. Guide License Proposal

The Tennessee Wildlife Resources Commission discussed the possibility of imlicense at the Aug. 25 Commission meeting in Kingsport. The Commission felt that a guide license is needed to assist in expenses at TWRA's state fish hatcheries due to the likely reductions in trout production at federal fish hatcheries in Tennessee, Dale Hollow and Erwin National Fish Hatcheries.

A recommendation was made to consider a fishing guide license only for the following waters: the rivers immediately below Wilbur, Watauga, South Holston, Cherokee, Norris, Appala-

chian, Tim's Ford, Center Hill, Dale Hollow, and Normandy dams. The Agency was asked to recommend a proposed cost for the guide license, both resident and nonresident; any qualifications or restrictions that may be necessary; the projected cost for managing the program; and the projected revenue generated from the program. plementing a fishing guide These recommendations will be presented to the TWRC on Oct. 13 at the Commission meeting in Nashville.

TWRA Soliciting Comments The TWRA is soliciting comments for its 2012 sport fishing regulation changes and guide license proposals. This is an opportunity for the public to share ideas and concerns with the TWRA staff.

Public comments will be considered by fisheries managers and may be presented as proposals for regulation



sometime between August 1st, 2011, and August 5th, 2011, Josef Keith Smith did enter the home of the victim on Rogers Circle in Lenoir City. Entry was made through a rear window Smith had prior knowledge of. While there, Smith numerous items including a child's rocking horse, children's clothes, bracelets, a tricycle, a bicycle, food, a glass table, a power wheels battery, three prescription medications, and more all totaling \$1137.

Then, on August 5th, 2011, Josef Keith Smith tried to run over the victim while backing out of another driveway on Rogers Circle in Lenoir City. The victim had prior knowledge that Josef Smith had stolen over \$1000 worth of property and medication from her

home and was trying to get his tag number when he put the vehicle in reverse and tried to hit her.

The victim said she avoided the assault and Smith sped away screaming obscenities at her. Smith's actions placed the victim in fear of her life and severe bodily injury as he used his green 2000 Ford Ranger pickup truck as a deadly weapon.

Additional affidavits indicate Josef "Chubby" Smith violated the conditions of his probation in a material respect by failing a drug screen when he was given a 10 panel drug screen on July 19, 2011. Smith admitted before the test was given he would fail for marijuana. After the screen was given, Smith then admitted he had taken roxicet the day before the screen.


Smith also gave false information to his probation office. On a monthly reporting form Mr. Smith admitted he had not used

illegal drugs or used prescription drugs illegally since he last met with his officer, but after his drug screen he admitted to taking roxicet illegally.

Smith has also failed to pay court costs and fines. He has a balance \$678 and his last payment was made on June 2nd, 2011. Smith has failed to pay supervision

fees and has a balance of \$45.

Deputy Robert Gray, LCSO served the warrants and made the arrest Saturday at the Loudon County Jail.
