

Man charged with theft of vehicle


Detective Jonathan Sartin charged a Lenoir City man with theft after he allegedly stole a vehicle from a woman he had been staying with.






When K-9s and their trainers play: An armed "intruder" at far right drops his gun when Loudon County's own K-9 Deacon takes a bite out of crime







Along with it being a great experience for the officers to be in New York City just before the 10th Anniversary of 9/11,


the officers with NYPD also showed tremendous hospitality, even while enduring the effects of Irene.


