

Cosner, LCSO-CID; on September 7th, 2011, at approximately 1:45 PM, a White Wing Road, Lenoir City man called the Loudon County Emergency Communication Center and reported two men broke into his house, assaulted him and stole his medication. He identified one of the males by name, known to him as Mark Nix and

described the other male as large man wearing a black shirt.

The man stated he was in his home when the two men entered the residence without consent, at which time Mr. Nix began assaulting him. He also stated that during the assault, Mr. Nix threatened to get a butcher knife and cut his throat.

The man reportedly sustained visible injuries about his body and

was transported by Rural Metro EMS to Fort Loudoun emergency room for treatment.

During the investigation, Detective Jason Smith, LCSO-CID and Detective Cosner went to the residence of Mark Nix on Hotchkiss Valley Road to locate Mr. Nix and the described male. On arrival, a large male, identified as Brian R. Erickson, who matched the description of one





During the interview, Mr. Erickson first denied being at the residence, then reportedly admitted he had taken Mr. Nix to the residence and saw Mr. Nix assault the victim using a coffee cup, but denied any involvement.

When the victim was interviewed, he stated that Mr. Erickson was intimidating him by making threats to him while Mr. Nix assailed him.

Deputy T.J. Scarbrough, LCSO made the arrest at Nix's home Thursday around 1:30 PM. Lt. Patrick Upton and Detective Cosner were also on scene.

After Mr. Russell was placed under arrest he was asked to take a blood test and he refused. Russell's license was revoked in 2010 for DWI.

Vaccine

baiting program administered by USDA's Animal and Plant Health Inspection Service, Wildlife Services, will begin in Tennessee on September 30, 2011.

"Control of raccoon rabies is vital to public health, and we are pleased to be part of this important and effective program to reduce rabies in wildlife, which helps prevent transmission to people, pets and livestock," said Health Commissioner John Dreyzehner, MD, MPH, FACOEM.

Vaccine packets placed inside fishmeal blocks or coated with fishmeal will be distributed throughout a 15 county area in Tennessee. The barrier varies from 30 to 60 miles wide and covers approximately 3,400 square miles, running along the Virginia/North Carolina border in northeast Tennessee to the Georgia border in southeast Tennessee near Chattanooga. Baits will be distributed by hand from vehicles in urban and suburban areas and dropped from specially equipped airplanes in rural areas.

The oral rabies vaccine will be distributed on the following schedule:

September 30-October 8: Carter, Cocke, Greene, Hamblen, Hawkins, Sullivan, Unicoi and Washington Coun-

October 5-15: Bradley, Hamilton, Marion, McMinn, Meigs, Monroe and Polk Counties

"Rabies is most common in wild animals in Tennessee, and it poses a risk to humans and domestic animals that come into contact with wildlife," said John Dunn, DVM, PhD, deputy state epidemiologist. "It's important for pet owners to make sure rabies vaccinations are current for dògs and cats to ensure their health and safety, and help provide abarrier between rabies in wild animals and humans. It is also extremely important that raccoons not be transported from one area of the state to anoth-

Rabies, once disease develops, is almost universally fatal. However, it is completely preventable if vaccine is provided soon after exposure.

This is the tenth year Tennessee has participated in baiting with rabies vaccine to slow and possibly halt the spread of raccoon rabies. One raccoon has been diagnosed with rabies in the eastern part of Tennessee so far this year. Since raccoon rabies was first detected in Tennessee in 2003. the disease has not spread as rapidly here as has been documented in other areas of the United States.

Although the vaccine products are safe, the USDA Wildlife Services program has issued these precautions:

• If you or your pet finds bait,

confine your pet and look for other baits in the area. Wear gloves or use a towel and toss baits into a wooded or fencerow area. These baits should be removed from where your pet could easily eat them. Eating these baits won't harm your pet, but consuming several baits might upset your pet's TDOH will also take part in

• Don't try to remove an from your pet's mouth, as you could be bitten.

stomach.

- Wear gloves or use a towel when you pick up bait. While there is no harm in touching undamaged baits, they have a strong fishmeal smell. Wash your hands thoroughly with soap and water if there is any chance the vaccine packet has -been ruptured. ...
- * Instruct children to leave baits alone.

. • A warning label on each bait advises people not to touch the bait, and contains the rabies information line telephone number.






