
Tempertantrum leaves home in disarray, woman in jail





sioner Karla Davis announced new requirements of all employers in Tennessee to demonstrate that they are hiring and maintaining a legal workforce.

'This online verification process is designed to be convenient for employers and only takes a few minutes to complete. The department can provide assistance to employers who don't have Internet access," said Commissioner Davis.

Signed into law by Governor Bill Haslam on June 7, 2011, the Tennessee Lawful Employment Act requires verifying the

employment eligibility of all newly hired employees through the online E-Verify program (www. uscis.gov/everify), or requesting all newly hired employees to provide one of the following identity and employment authorization documents as required:

A valid Tennessee driver's license or photo identification

A valid driver's license or photo identification from another state where the

license requirements are at least as strict as those in Tennessee

A birth certificate issued by a U.S. state, jurisdiction or territory

A U.S. government issued certified birth certificate

A valid, unexpired U.S. passport

A U.S. certificate of birth abroad

A report of birth abroad

A report of birth abroad or a citizen of the U.S.



of the above listed identity/employment authorization documents for all non-employees as well. A "non-employee" is defined as any individual,

other than an employee, paid directly by the employer in exchange for the individual's labor or services.

The employment verification provisions referenced above will be phased in as follows:

All state and local government agencies must enroll and participate in E-Verify or request and maintain an identity/employment authorization document from a newly hired employee or nonemployee no later than January 1, 2012

All private employers with 500 or more employees must enroll and participate in E-Verify or request and maintain an identity/employment authorization document from a newly hired employee or non-employee no later than January 1, 2012

All private employers with 200 to 499 employees must enroll and participate in E-Verify or request and maintain an identity/employment authorization document from a newly hired employee or non-employee no later than July 1, 2012

All private employers with six to 199 employees must register and utilize E-Verify or request and maintain an identity/employment authorization document from a newly hired employee

or non-employee no later than July 1, 2013

The Tennessee Department of Labor does have the authority to impose penalties for non compliance. For a first violation. \$500 for each employee or non-employee not verified, for a second violation, \$1,000 for each employee or non-employee not verified, and \$2,500 for a third violation.

The private employer must submit evidence of compliance within 60 days of the final order. If the employer fails to submit such documentation, then the commissioner has the authority to suspend the private employer's license until the employer remedies the violation.

Any lawful resident of Tennessee or any employee of a federal agency may file a complaint alleging a violation of the employment verification provisions of the Act. If there is satisfactory evidence of a violation, the Commissioner of the Tennessee Department of Labor and Workforce Development will conduct an investigation.

Make sure it's a deer!

to manage the small population of the exotic deer.

At the December meeting of the Tennessee Wildlife Resources Commission, an amendment to the proclamation allows for an expansion to the original area.

Last spring, in an effort to eliminate a small population of exotic red deer in Claiborne County, a two-week red deer season was established after the white-tailed deer season ends. The hunting season is open in the portion of Claiborne County east of Highway 25E from the Kentucky state line to the Highway 33/25E intersection in Tazewell and east of Highway 33/25E intersection to the Union County line.

Since the proclamation was passed, the area where the red deer are located shifted. The amendment allows for an expanded hunting area in the county.

There is no bag limit on red deer and either sex may be harvested by gun, muzzleloader or archery equipment. Hunters must submit red deer harvested for biological sample by taking them to Southern Outdoors, 2809 Hwy 25E in Tazewell. Tennessee Wildlife Resources Agency personnel will be

present to collect samples during specific times. Otherwise, instructions for hunters will be posted at the Southern Outdoors location.

Most of the herd is located on private lands. Hunters are reminded that they must have permission of the landowners to hunt on private lands. State law prohibits hunting from a motorized vehicle and hunting from or across a public road or

right-of-way.

The TWRA also wishes to make hunters aware that red deer resemble elk in appearance and that anyone convicted of illegally killing a wild elk are subject to up to \$2,500 in fines and up to 11 months/29 days in jail.


