





Deputy Hall looked through the window in the door and could see a male lying on the kitchen floor, not moving.

announcing he was law enforcement, Deputy vehicle. door in, to gain entry.

Once in the residence,

the deputy made contact with several people and secured them, while Sgt. Jerramie Bowen, LCSO, tended to the person down on the kitchen floor.

One of the people was identified as Jordan Buck. While talking with Mr. Buck, he produced approximately 1 ounce of marijuana.

The person on the floor was an 18 year old male who had to be transported to the ER by EMS.

In the meantime, Deputy Hall located the owner of the Toyota who stated Mr. Gibson stole the vehicle several minutes' prior to the deputy's arrival. Gibson was unsteady on his feet, had slurred speech, and was extremely intoxicated. He was not cooperating with law enforcement due to his level of intoxication. A check of his license showed he was unlicensed and 18 years of age.

Witnesses stated, just prior to Deputy Hall's arrival, Mr. Gibson was confronted for stealing from the residence on Allen Shore Drive and fled on foot, then the owner of the vehicle found it missing and called Gibson who stated he crashed the vehicle.

Gibson admitted he had been drinking at a party down the road, prior to the accident.

The owner of the Toyota stated, the value of the vehicle was \$4500 and Gibson took the vehicle without his permission or consent.

The total estimated value of the stolen merchandise is \$5678. The investigation is ongoing with the criminal investigation division.




Officer Houser immediately activated his emergency equipment and stopped the Subaru and made contact with the driver, Mr. Frank Costen.

Their 12 year old daughter was in the vehicle with them. Sgt. Bill Evans, LPD, was also on the scene.






