Danny is 7 years old and was recently diagnosed with the disorder, which is extremely rare with an incidence of 2 per

100,000 children.

Danny's disorder is similar to autism. A child with CDD will at first develop normal skills sets such as verbal, social, motor, play and self-care

skills until the disorder becomes apparent, at which point they completely lose two or more of their learned skills. And the age this happens varies. It can be anywhere from age

two to ten.

Danny has been prescribed a Service Dog, but the cost of the dog is \$12,000. This dog is being trained specifically for Danny by Wilderwoods Service Dogs.

Also, you might know Danny's mom, Kristin. She's made many a'Grandaddy hoagie out at the Kenjo Market #28 on Highway 321 in Lenoir City where she works. She's a single mom and has a Facebook page called A Dog For Danny. Kristen needs help getting that dog for her little boy.

The causes of Danny's disorder are still unknown and there is no cure, no medications to directly treat it. The only help available at the present is behavior therapy to help relearn lost skills, and medications only to treat symptoms such as aggressiveness and prevent seizures.


works? (23) And then I will profess to them, I never knew you: depart from me, ye that work iniquity.

I have experienced salvation through Jesus and I am a different person because of Him. The flames of hell will never pierce my soul.... but what about you?









