## Young man is diligent in building criminal record

A young Lenoir City man is apparently working on building a criminal record by allegedly stealing from his father, assailing people with his vehicle and hiding from authorities when they come calling.

Brandon Thomas Deaton, 21, Phelps Road, Lenoir City was charged with resisting stop, halt, arrest.

According to records, Deputy Chris Jenkins, Lt. Paul E. Curtis, Deputies Chris Bowen and Brandon Dixon, LCSO responded to a residence on Martel Road Monday in an attempt to locate Brandon Thomas Deaton for outstanding warrants out of Knox County for aggravated assault and were aware Dixon also was possibly in possession of stolen weapons.

Mr. Deaton's vehicle, in which the assault was committed, was at the residence. When deputies approached the house the owner of the residence came to the door. The lawmen asked if Mr. Deaton was there and he advised

he was, and let them in.

During a search, a small hole was found in a room leading to underneath the residence. When officers found the hole in the floor they also found several weapons on the ground in

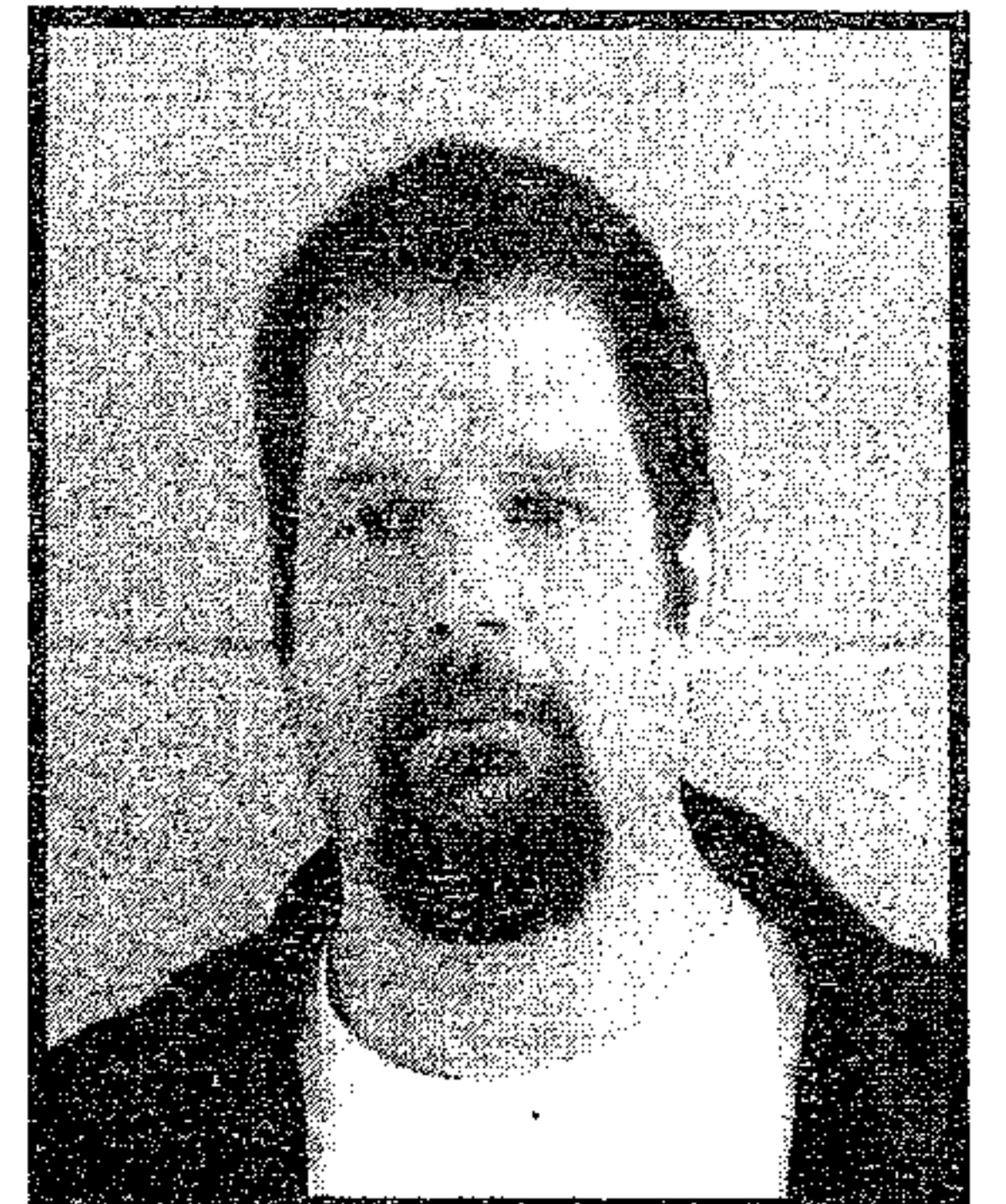


## Man charged with theft

visement and agreed to a blood test. After cuffing Mrs. Neeley, she stated she had her husband's medication on her and

when Deputy Stegall asked her where, she pulled a bottle of 2 mg clonazepam from her crotch. She was transported to Fort Loudoun

ER for a blood draw, then to the Loudon County Jail.

The medication bottle had Mark Neeley's name on it. The bottle

contained 47 clonazepam 2mg tablets and a straw. There was two small blue pills also in the bottle identified as roxicodone, a schedule II narcotic. Mr. Neeley claimed the pills and stated he had a doctor's script, but couldn't produce one. Mr. Neeley was also taken into custody.

According to additional records, the couple made a return trip to jail a few days later when they reportedly went to court intoxicated.

Megan Neeley was again charged with DUI first offense and Mark Neeley was charged with public intoxication.

According to those reports, on Thursday, Deputy Dustin Langley, LCSO called Deputy T.J. Scarbrough about two intoxicated people who were in court. Deputy Scarbrough was en route when Deputy Langley called back and stated they were leaving in a purple Pontiac Sunfire. Scarbrough got behind the vehicle as it pulled out of the Justice Center and followed it on Highway 11 west toward Loudon.

The officer reported the vehicle crossed the center line several times and he stopped it near

Natalie Boulevard. The driver was identified as Megan Neeley.

Mrs. Neeley had slurred speech, bloodshot watery eyes and was unsteady on her feet. She performed poorly on field sobriety tasks and appeared to be under the influence of some type of intoxicant.

Mrs. Neeley was read the implied consent advisement and submitted to a BAC performed at Fort Loudoun ER.

The passenger was identified as Mark D. Neeley. He also appeared to be under some type of intoxicant. He had slurred speech, bloodshot watery eyes and was unsteady on his feet. Mr. Neeley was deemed a danger to himself and others in his condition and was taken into custody. Once at the jail, Deputy Maples, LCSO was checking Mrs. Neeley's purse and found a bottle of prescribed oxycodone. The bottle had that day's date on it for a quantity of 90 pills, but it only had 82 pills left in it.

The prescription stated to take one tablet three times a day and Mrs. Neeley advised she had filled the prescription that morning before going to court.

plain view.

The hole led to a small crawl space under the house which was dark and unsafe for officers to search and it was unknown if Mr. Deaton was armed. Deputy Jenkins deployed K-9 Diego for assistance in locating the man and several warning announcements were made for him to come out. They received no response. After several more announcements and still no response from Deaton, K-9 Diego was released to search and locate him.

K-9 Diego made con-

tact with Deaton in the far corner of the residence under some duct work and insulation. Lt. Curtis and Deputy Jenkins had to crawl underneath the house where Deaton and the K-9 were.

The K-9 had Deaton by the back of the jacket. Due to where he and the K-9 were, the lawmen couldn't reach them so Deaton was ordered to come to their location. After Mr. Deaton and K-9 Diego were at a safe and visible location, the K-9 was ordered to release Mr. Deaton and Diego immediately released the man. They all crawled out from underneath the

residence and Mr. Deaton was escorted to an ambulance for medical treatment. EMS transported him to Fort Loudoun ER where his injuries were cleaned and bandaged.

Later, Deaton was released and transported to the Loudon County Jail where he received another charge for theft of property on February 8, 2012.

According to that affidavit, filed by Detective Charles Cosner, LCSO-CID; on February 3, 2012, the victim reported a total of seven guns were taken without his consent from his residence on Phelps Road in Lenoir City. The value of the guns was estimated at more than \$1000 but less than \$10,000.

During the investigation, the victim's son, identified as Brandon Deaton, was determined to be a suspect in the theft after an individual notified the victim he purchased two of the guns from Brandon Deaton.

On February 6, 2012, deputies from the Loudon County Sheriff's Office

served a warrant on Brandon Deaton, which was issued in Knox County and while taking him into custody recovered three of the guns, listed as stolen. Deputy Vance Wright, LCSO served the warrant on Mr. Deaton while he was incarcerated at the Loudon County Jail.
