A Knoxville man who resisted officers got more of a buzz than he bargained for when he reportedly broke into a Lenoir City pharmacy to steal pills and was apprehended going out the back door with a duffel bag of medicine bottles...

Dean Michael Burnette 'aka' Michael Dean Burnette, 43, Archibald Way, Knoxville, was charged with burglary, theft of property over \$500, vandalism over \$500 and resisting arrest.

According to affidavits filed by Officer Kevin Condee, LCPD; on or about February 25, 2012, Dean Michael Burnette entered East Tennessee Discount Drugs on Highway 321 after business hours without the consent of the owner. Mr. Burnette entered the business



A local man was jailed on assault charges after a warrant was issued alleging he and his friends have been threatening a Hispanic man and his unborn child and driving by the man's residence flashing knives and hurling racial slurs at him.

Virgil Allen Russell, 49, Smallen Road, Loudon was charged with aggravated assault.

According to an affidavit filed by the victim; a few weeks ago, Virgil Russell and two


