





burglary.

According to affidavits filed by Detective Brian Jenkins, LPD; on June 5, 2012, Mr. Monday entered the Good Fellows Tobacco Store

located at 1562 B Highway 72 North in Loudon at approximately one o'clock in the morning. Entry was made without the owner's consent or knowledge by prying open the front door.

Monday entered into the business with the intent of committing theft. Monday and two accomplices, 45 year old Timothy Hardwick and Travis Lay, 32, both of whom are now

deceased, took approximately \$8000 worth of merchandise including Marlboro cigarettes and four rolls of Skoal smokeless tobacco.

The merchandise was taken without the owner's consent with the intent to deprive the owner of its value. Much of the merchandise was recovered several minutes after the burglary

at the scene of a crash involving the vehicle Monday and the two accomplices were occupying. The vehicle was observed leaving from the area of the burglary and was recognized by LPD Officers Yates and Harrison as matching the description of a vehicle used in similar burglaries on June 3, 2012.

The vehicle crashed, killing Hardwick and Lay, while attempting to flee from Officers Yates and Harrison.

Sgt. William Evans, LPD made the arrest Thursday at UT Medical Center.

All three men were reported as having a lengthy criminal history in Knox County and had past convictions on charges ranging from burglary and drug possession to rape and forgery.





Lenoir City was charged with boating under the influence, violation of implied consent, and reckless operation.

According to reports, Officer Greg Julian, TWRA was on Fort Loudoun Lake Saturday,

around 10:40 PM, when he looked over his left shoulder to see a large boat coming directly at him. The officer waited a few seconds to see if the operator of the boat was going to notice his location and change his direction or speed, but he didn't, and the offi-

cer had to put his boat in gear and quickly throttle up in order to move to avoid a collision.

Once clear of the boat's path, Officer Julian turned his blue lights on and yelled, "Sir" in order to get the attention of the operator, and when the boat

slowed he made contact with the operator, whom he identified as Daniel L. Lewis.

Mr. Lewis didn't have his shoes or shirt on and was wearing a pair of black shorts. He was sunburned, his eyes were glassy and he had an odor of an alcoholic beverage on his person. He also stumbled while

moving about the boat.

When asked how much he'd had to drink, Mr. Lewis reportedly stated he'd had two at Calhoun's earlier. He did poorly on field sobriety tasks, however, and was placed under arrest. Mr. Lewis was then read the implied consent advisement and refused to be tested.

The report states, Officer K. Condee, LCPD responded to a reported fight in the Big Lots parking lot Tuesday, around 6:30 PM, and during his investigation he determined Robert F. Thornton, Jr. had engaged in fighting, and had displayed violent or otherwise threatening

behavior while in a public place.*

The lawman reported Thornton's actions caused public annoyance and alarm when he engaged in a fight with an individual who attempted to leave the scene to avoid a confrontation with him. According to the victim and witnesses, however, Thornton continued to provoke the vic-

tim, cursing at him and bumping into him until the victim eventually felt the need to defend himself and punched Thornton at least two times.

Thornton continued to yell obscenities at the victim and bystanders and Officer Condee placed him under arrest and transported him to the Loudon County Jail.



with two counts of especially aggravated kidnapping, two counts of felony child abuse, felony evading arrest, reckless endangerment, resisting stop, frisk, halt, arrest, or search, reckless driving and speeding.

According to affidavits; on Saturday, June 9, 2012, Investigator Jason Butler, LCPD responded to several emergency calls about

a man lying in the intersection of Highway 321 and Highway 11. Upon arrival in the area, the investigator was told the man had gotten into a gray Nissan Murano and was traveling north on Highway 321. Butler spotted the vehicle at the intersection of Highway 321 and McGhee Boulevard and activated his emergency equipment in an attempt to stop it. The driver then reached speeds

exceeding 80 mph and began traveling north in southbound lanes of Highway 321. The driver was observed committing numerous traffic law violations and placed every vehicle on the roadway in his path in imminent danger of death or serious bodily injury.

Investigator Butler lost sight of the vehicle around Highway 321 and Interstate 75 and began a search of the area. He found the vehicle parked in the center median of Highway 321 and White Wing Road. The man, later identified as Hayward Jimcoily, was outside the vehicle and was yelling belligerently.

Investigator Butler told him numerous times to get on the ground, he was under arrest. Mr. Jimcoily, but

he grabbed a three year old child next to him in the median and told police, "Your going to have to kill me."

Jimcoily then moved the child out of the way and attempted to get back into his vehicle to flee the area, at which point Investigator Butler deployed his Taser and took the man into custody.

The investigator also found another child who was five years old in the vehicle. Witnesses stated Mr. Jimcoily stopped the vehicle and physically threw the three year old from the vehicle just prior to the lawman finding them in the median. Through follow up investigation, Investigator Butler discovered Mr. Jimcoily was the father of the two children, however he does not have full

custody of the children and had left Nashville with the children without the knowledge or consent of the mother.

The mother notified Metro Nashville Police Department to report her children missing that morning.

Jimcoily was arrested and transported to the Loudon County Jail.
