





Mr. Upton struggled with the victim, who had retrieved a knife to defend herself, and he knocked her onto a couch before fleeing the residence.





#### Busted

According to records, Sunday, around 4:59 AM, Deputy Cody Fritts, LCSO observed a green Chrysler Concorde on Highway 70 with the high beam lights on and when the vehicle passed the deputy the driver failed to dim the headlights.

Deputy Fritts turned around to follow the vehicle and his radar registered it's speed at 88 mph. He initiated his emergency equipment

bought him a new suit (that he wouldn't have worn), or invited him and his wife to a fancy dinner somewhere. Instead, I wanted him to have the best day possible in Montana where he could relax and enjoy himself while we spent some time together. So I did what any good country boy would, I took him fishing. I hired a guide that lived in the area and told him to take us to where he would want to fish if he had only one day to do so. I told the guide that we wanted beautiful scenery, minimal people and lots of brown and rainbow trout. Angie and I flew into Helena, Montana the evening before our fishing trip. I packed a bag, checked the weather, checked in with Pastor Hales, checked the weather again and then talked about our upcoming day of fly fishing on the famous Misouri River until my wife was tired of hearing about it. I made her go with me to Walmart to get some rain gear and snacks, then back to the hotel to repack my bag and yes, check the weather.

The following day was awesome! Our guide had already

for the fish we were after; we were gently rolling those nimphs out beyond the boat and presenting our flies as clearly and naturally as we possibly could. And the fish believed! We caught rainbows, browns and whitefish the entire day. After landing a fish in the safety of the net we celebrated, "high fived", and then returned each fish to its home before seeking the next one. By the end of the day I was wet, tired and sore but I didn't want to quit, I wanted to keep

fishing! Mathew 4:18-22 (NKJV) (18) And Jesus, walking by the Sea of Galilee, saw two brothers, Simon called Peter, and Andrew his brother, casting a net into the sea; for they were fishermen. (19) Then He said to them, "Follow Me, and I will make you fishers of men." (20) They immediately left their nets and followed Him. (21) Going on from there, He saw two other brothers, James the son of Zebedee, and John his brother, in the boat with Zebedee their father, mending their nets. He called them. (22) and immediately they left the boat and

lowed Him.

This scripture excites me in more ways than I have time to discuss here today, but I do want to unpack a little of what this passage means to me. (That is besides the fact that Jesus is just real fond of fisherman! Kidding)

Jesus had just begun His ministry. He had been baptized by John the Baptist, been tempted by Satan for forty days on the mountain and is now walking beside the Sea of Galilee when He begins to call His disciples. Why did He choose four fisherman you might ask? Why would Jesus Christ, the Son of God, God in the flesh, want to begin the most important ministry, HIS, since the creation of the universe by recruiting four regular, everyday, common, mostly uneducated fisherman to spread His gospel to the nations?

In my mind, Jesus wanted the world to know that you don't have to be a great theologian, have a doctorate degree in religion or even smell good to lead souls into everlasting life with Christ. All you have to do.....IS FOLLOW HIM!

Police Beat
