





Labrabbed

A Greenback man who reportedly told 9th DTF agents he has been making meth since the beginning of the year was arrested along with two

others after the vehicle they were in was stopped for multiple traffic violations and a meth lab, drugs and paraphernalia were ultimately found in the vehicle.

Regina Gwen Collins, II 37, Juniper Avenue, Alcoa was charged with promoting the manufacture of methamphetamine, driving on suspended license, possession of schedule

methampheiamine and possession of felony drug paraphemalia.

Joseph Kemp, 36, Mountain Crest Lane, Greenback was charged manufacture of methamphetamine, promoting the manufacture methamphetamine, possession of schedule methamphetamine and possession of felony drug paraphernalia.

Timothy Trent Spires, 39, Morganton Road, Greenback was charged with possession of felony drug paraphernalia, promoting the manufacture of methamphetamine and manufacture of methamphetamine.

According to affidavits, Agent Brendan DeBoer of the 9th Drug Task Force conducted a traffic stop on a white Ford Explorer on Highway 321 at City Park Drive Thursday for going 45 mph in a 40 mph zone, failing to signal lane changes and for not having a bumper.

The driver, identified as Regina Collins, had a suspended drivers license and while speaking with her, the agent advised her of her Miranda Warnings.

The lawman reported Collins advised there was methamphetamine in the vehicle and meth making components and he asked her, and the registered owner, Joseph Kemp, for consent to search the vehicle.

During the search Agent DeBoer reported he discovered fuel, psuedo pills, cold packs, lithium batteries, brake fluid, a hot plate, tin foil and a Mountain Dew bottle half full of muriatic acid.

Ms. Collins stated they had just left Walgreens in Lenoir City where a

box of psuedo was purchased.

Severai baggies that tested positive for the presence of methamphetamine were found in a blue Coach purse. A hypodermic heedle and coffee litters were also found. Ms. Collins stated all the boxes she had purchased in the last six months, amounting to approximately three boxes per month, all went to manufacture metham phetamine.


Mr. Kemp was advised of his Miranda Warnings and he stated a flashlight in his pocket contained several bags of a substance that the officer reported tested positive for the presence of methamphetamine. Kemp further stated he made the meth the night before.

Kemp had just purchased a box of psuedo at Walgreens and lithium batteries at Ingles in Lenoir City. Mr. Kemp advisedhe's been cooking meth for several months and has purchased 15 boxes of psuedo since the first of the year.

The rear seat passenger was identified as Timothy Spires. Mr. Spires was read his Miranda Warnings and was asked about his recent purchase of psuedo and he advised he was purchasing the psuedo for the manufacture of methamphetamine.

Upon speaking with all the occupants in the vehicle it was determined the trio have been manufacturing meth at Spires' residence.

Agents from the 9th Drug Task Force were allowed by the homeowner to check for meth components, and trash used to manufacture meth or it's by products were found and disposed of

Throughout the Bible, God has used blindness as an incredible tool in which to show His power and glory.

John 9:1-7 (NKJV) (1) Now as Jesus passed by, He saw a man who was blind from birth. (2) And His disciples asked Him saying, "Rabbi, who sinned, this man or his parents, that he was born blind?" (3) Jesus answered, "Neither this man nor his parents sinned, but that the works of God should be revealed in him. (4) I must work the works of Him who sent Me while it is day; the night is coming when no one can work. (5) As long as I am in the world, I am the light of the world. (6) When He had said these things, He spat on the ground and made clay with the saliva; and He annointed the eves of the blind man with the clay. (7) And He said to him, "Go, wash in the pool of Siloam." So he went and washed, and came back seeing.

*Mark* 8:22-26 (NKJV) (22) Then He (Jesus) came to Bethesda; and they brought a blind man to him, and begged Him to touch him.(23) So He took the blind man by the hand and led him out of the town. And when He had spit on his eyes and put His hands on him, He asked him if he saw anything. (24) And he looked up and said, 'I see men like trees, walking." (25)Then He put His hands on his eyes again and made him look ир And he was restored and saw everyone clearly. Then He sent him away to his house, saving, "Neither go into the town, nor tell anyone in the town."

In Acts Chapter 9 Jesus

blinded Saul of Tarsus because Saul had been persecuting, incarcerating and promoting the killing of Christians. For three days, Saul was blinded and had to be led by his companions. Jesus then sent Ananias, a Christian, to lay hands on Saul and heal him through the power of God. Saul was then renamed Paul and became a prominent leader of New Testiment Christianity, a great missionary and eventually wrote thirteen, if not fourteen, of the New Testiment chapters of the Bible.

When Blondie and I joined our missionary team to leave for Montana this past week I met a young man named Jarod Jackson. Jarod is a member of Highland Park Baptist Church and is almost completely blind. When I first saw Jarod with his cane, the sinful nature of my mind wondered what Jarod would be able to contribute to our "Mission". I am ashamed to admit that I even thought such a thing, but it is true, and I had to ask God to forgive me. In addition to forgiveness, God showed me this past week how He can use anyone in any circumstance for His glory.

Throughout this trip I was able to spend a little time with Jarod. I listened to him give his awesome testimony, sing about God's love and encourage our group and others around us.

Jarod suffered from a brain tumor as a young child and lost his sight completely in one eye and almost completely in the other. As an adult who has been dealt a hand that most of us would hold against God, Jarod praises Him! He thanks God for giving him a family

that loves him and takes care of him. He thanks God for allowing him to inherit salvation and he prays for others and not himself. Jarod has an awe-some sense of humor and brightens any room he enters. He doesn't lay around complaining, he shares the love of Jesus and he also has a job!

One night this week we were able to take the Hales' three children out with us so Darren and Susan could spend some rare time together alone. The Hales boys wanted to bowl so our whole team went to a local bowling alley after dinner. After watching Jarod bowl a couple of strikes and obtain a better score than me, I had to ask.... I said, "Hey Jarod, what exactly do you see when you look down the lane?" Jarod told me that he could only see a white blur at the end but he could make out the two gutters at his feet and was just trying to roll the ball between them. How awesome is that!

Jarod Jackson has shown me that I am often a selfish, self serving,

jail.


Highsmith stated her son had asked her to put the items in the television.






