Inn of Lenoir bust nets active meth lab, guns, stolen property, paraphernalia; 4 charged

On August 21 2012, Agents from the 9th Drug Task Force with the assistance of the Loudon Police Department, Loudon

County Sheriff's Office and Lenoir City Police Department, conducted a search warrant at the Inn of Lenoir, Highway 321.

The target of the warrant was Brandon Mckinley, who was known to have been staying in room 242 at the location. When the

search warrant was executed, Agents found Brandon Mckinley and Dennis Samuel Smith on the balcony in front of room number 240. While taking them into custody, a strong chemical odor was found to be coming from room 240. The entry team continued and secured room 242 and other law enforcement officials attempted to knock on the door of room 240.

Agent Brendan DeBoer reported he discovered room 240 was registered to Dennis Smith and asked for permission to search it. Agents entered room 240 to 'investigate the strong odor with the verbal consent from Smith and found an active shake bottle, or 'meth lab,' in the bathroom. Rooms near 240 were evacuated and a search of room 242 began.

Found in room 242 were two shotguns and ammunition that were reported stolen in a recent Meigs County burglary, as well as numerous other items from other burglaries.


Also found in room 242 were burglary tools and several forms of drug paraphernalia that included pipes, straws and razor blades. Brandon Mckinley is a four-time convicted felon and is prohibited

from possessing firearms.

During a containment of room 240 by the Loudon County Sheriffs office Meth unit, all the components necessary for the manufacturing of methamphetamine were found, as well as the active "shake bottle." The components found were all acquired earlier that day by all four persons present during the execution of the search warrant. According to Agent De-Boer, "The defendants had set up and were actively monitoring a surveillance camera that they had set up in the window of one of the rooms and which was hooked up to a laptop computer. Mckinley and Smith were also communicating on two-way radios as they kept watch for any approach made by law enforcement."

All four persons were taken into custody. They were iddentified as Brandon Mckinley, Dennis Samuel Smith, Shannah Moore and Courtney Crass. All four are charged with Manufacturing Methamphetamine, Promoting the Manufacture of Methamphetamine and Felony Possession of Drug Paraphernalia.

Mckinley was also charged with Felon in Possession of a Firearm.

Counting the Cost

When you turn on the news these days you will undoubtedly have to hear something about our upcoming presidential election. As I have recently watched both candidates try to market themselves I have found one thing in common with each; Their promises don't always match their policies. That is, their actions are not always consistent with what they claim to stand for.

This is very similar to a lot of Christians today. Many people want others to believe they are Christians but their actions give us the impression that they are not. Acts 5: 1-11 (NKJV)

Sapphira his wife, sold a possession. (2) And he kept back part of the proceeds, his wife also being aware of it, and brought a certain part and laid it at the apostle's feet. (3) But Peter said, "Ananias, why has Satan filled your heart to lie to the Holy Spirit and keep back part of the price of the land for yourself? (4) While it remained, was it not your own? And after it was sold, was it not in your own control? Why have you conceived this thing in your heart? You have not lied to men but to God." (5) Then, Ananias, hearing these words, fell down and breathed his last. So great fear came upon all those who heard these things. (6) And the young men arose and wrapped him up, carried him out, and buried him. (7) Now it was about three hours later when his wife came in, not knowing what had happened. (8) And Peter answered her, "Tell me whether you sold the land for so much?" She

said, "Yes, for so much." (9) Then Peter said to her, "How is it that you have agreed together to test the Spirit of the Lord? Look, the feet of those who have buried your husband are at the door, and they will carry you out." (10) Then immediately she fell down at his feet and breathed her last. And the young men came in and found (1) But a certain man her dead, and carrying named Ananias, with her out, and buried her by her husband. (11) So great fear came upon all the church and upon all

who heard these things. This married couple lost their lives because they tried to have it both ways. Have you ever tried to fool God or fool others? God made it very clear in this story that He will not be deceived! He used the sin and punishment of Ananias and Sapphira as an example to many others as described in verse 11; "So great fear came upon all the church and upon all who heard these things." I believe many in our churches no longer fear God and this is such a dangerqus place to be.

I believe stories like this one are true and included in the Bible so Christians can have a better understanding of what God expects from us. I have been an "Ananias" and I am confident that Blondie will tell you she has been a "Sapphira". For years we deceived ourselves and foolishly thought we could fool

our Lord and Savior. I believe God has continued to bless me over the years because He has a plan for my life.

Jesus said in Mathew 12:30 that "He who is not with Me is against Me, and he who does not gather with Nie, abroad." scatters Friend I don't know about you, but I want to be one who gathers and never one who scatters abroad.


