According to the warrants, Trooper Eric Miller, THP conducted a traffic stop for failure to maintain lane of travel and failing to use headlights in inclem-



ent weather. The vehicle was stopped at the 81 exit off I75. The driver Howard Knott stated he was coming from Atlanta. Mr. Knott was asked to perform sobriety tasks and performed poorly.

A search of the cell phone messaging revealed Knott was sending and receiving messages from Hollie Key in reference to buying methadone wafers for \$15 each or he would take payment back after her trip to the methadone clinic later in the month. The search of the vehicle produced an unsecured lockbox with 8 bottle of methadone 120mg, 5 loose bottles of methadone 120mg, a pill container with 7 1/2 tablets of what was believed to be adderall and one tablet of Alprazolam.

During the investigation Mr. Knott stated he was going to meet Ms. Key to exchange 3-5 wafers for \$15 each. During the inventory for tow a white female pulled up and asked if she could take possession of Mr. Knott's vehicle. The woman was informed she could not and left the parking lot. Mr. Knott identified the woman as Hollie Key.

A traffic stop was conducted on Ms. Key just up the road. A check was conducted and Ms. Key was asked to consent to a

search of her phone and vehicle to which she stated yes. During the search Ms. Key's phone number matched Mr. Knott's cell phone through text messaging and dialed calls. Ms. Key was transported to the Loudon County Jail and placed on hold pending her questioning for a drug transaction. Mr. Knott was transported to the Ft. Loudon Medical Center for a legal blood draw and then to the jail.

Upon arrival at the jail DEA Trooper Morton conducted interviews and took statements from the duo. During Ms. Key being placed in holding cell 5 she was observed through the window by Deputy Olwin Norman distributing pills to other inmates. Ms. Key was removed from holding cell 5 and a strip search was conducted where the deputy revealed a pill bottle Ms. Key had put inside her. The bottle contained approximately 8 tablets of Alprazolam.

Hollie D. Key, Hwy 72, 40 of Loudon, was charged with sell and delivery conspiracy and introduction into a penal facility.

Howard D. Knott, 26, Clinch Valley Drive, Blaine, was charged with DUI 1st, possession with intent to distribute, resale and simple possession of schedule II and IV. Trooper Miller made the arrests.
