ing. After making initial contact with the driver, the Deputy could smell a very strong and distinct odor of alcohol coming from the driver side window of the vehicle. Brown exited his vehicle to conduct Standardized Field Sobriety Tasks, which he did poorly on. Brown admit to having drank five (5) beers, as well as one (1) shot of rum, taking Hydrocodone. Brown was placed under arrest for Driving Under the Influence, at which point

Brown was read the Tennessee Implied Consent Form. Brown refused to submit to a chemical test to determine the alcohol and / or drug content of his blood. Brown was also found to be in possession of marijuana, weighing approx. 2 grams, from search incident to arrest while at the Loudon County Jail. Deputy Brandon Burley LCSO made the arrest.

Kevyn Miller, 23, Highway 11 W Lenoir City, was charged with Manufacture/sell/poss. Controlled substance,

and Poss. Of Drug Para.

According to the reports, The Loudon County Sheriff's Office Narcotics Unit as-

sisted by the 9th Judicial Drug Task Force, Loudon Police Department, and the Loudon County Sheriff's Office Patrol Division served a

search warrant at Highway 11 West, Lenoir City, TN.

During the search two glass jars were found under a bed in the back bedroom which contained a green plant material believed to be Marijuana were found. A third jar was found in the corner of the same bedroom which also contained a green plant material believed to be Marijuana. In the dresser in the bedroom, two plastic baggies containing green plant material were found as well as digital scales and baggies commonly used for packaging Marijuana. In a pull out drawer on the bed frame, a small glass jar with green plant materi-

al believed to be Marijuana was found.

The total weight of the Marijuana found was 351.1 grams. A pack of rolling papers, a Marijuana sifter, a Marijuana grinder, and a ceramic jar which contained Marijuana cigarette butts was found inside the back bedroom as well. During a Mirandized interview, Kevyn Deandre Miller advised all the Marijuana inside the residence was his. Kevyn Deandre Miller is charged with Possession of Schedule VI Narcotics for Resale and Possession of Drug Paraphernalia.

Investigator Marty Stanley LCSO made the arrest.
