lives, but after years of being "That Guy" I am now experiencing, in real life, what Jesus meant when he said, "*I am with you always.*" (*Matthew 28:20*)

It was just a few short years ago that I was a Christian with no visible attributes of being a Christian. Although I had accepted Christ many years before, I would snarl my nose at someone talking about the Lord, prayer, church, faith or anything that reminded me of my own sin.

I would often refer to those folks as hypocrites, Jesus freaks or Bible thumpers. Not because I didn't believe in God or my own salvation, but because I had never experienced a life that didn't revolve around ME and what I wanted to do, where I wanted to go, how I spent my time or my money and especially of how others would view me. I just massively missed the boat on a true relationship with Christ for a really long time.

Do I still have ungodly thoughts? I do. Do I ever say a word that God would not approve of? Unfortunately I do. Does God ever place opportunities in front of me that I pretend are not there? I am ashamed to say yes, but that is true. God didn't make me perfect, only He is perfect. God said for me to take up my cross daily and follow Him. I begin each day asking God to forgive me of the sins of yesterday and create within me a new heart for today, and He does!!!

Since returning to Christ, He has provided opportunities for Blondie and I to share our story across our community, across the state, into Montana, Indiana, New York City and even allowed me to stand before a crowd of

That line of thinking is not normal to most people but here is what most people are forgetting; there is life after death (which could be any moment) and each of us will spend eternity in one of two places. You and I both know that, we may just ignore that truth because we like the way our lives are going without Jesus in it. That is a choice that we each must make, bearing the consequences of those decisions.

However, there are people around the world who cannot make that choice because they don't realize there is a choice to make. Not everyone has heard

the name of Jesus! I believe God blesses us so greatly in the United States with the resources to reach the world but many times we leave that task to someone else. We are often consumed with "Me" and leave God at the church house with the "Hypocrites, Jesus Freaks and Bible thumpers!"

the deputy observed the vehicle cross the center divider line, strike a mailbox and drive into the ditch and continue east on Hines Valley Road. Upon stopping, the driver, William Mathew Allison Jr., exited and was very unsteady

on his feet and had very slurred speech. Allison was asked if he had been drinking and if he had anything illegal and he stated no. While escorting Mr. Allison to the front of the patrol car, he had his hand in his pants. The deputy told Allison to take his hands out of

his pants and he refused. After a brief struggle the deputy restrained Mr. Allison and placed him into handcuffs and found in his pants three pill bottles with several different types inside each bottle. Deputy Smith also discovered in the driver's floorboard one more pill

bottle with some round pink tablets inside.

At that time Deputy Smith advised Mr. Allison he was under arrest for DUI and he agreed to a blood sample. Deputy Smith collected for evidence 22 rectangle yellow tablets believed to be Xanax, 34 1/2 round pink tablets believed to be dextroamphetamine, 8 small yellow tablets believed to

be maloxicam, 14 tablets believed to be trazadone, and 15 oval tablets believed to be quetiapine fumarate.

William Mathew Allison Jr., 30, of Hines Valley Road, Lenoir City, was charged with possession of a legend drug (quetiapine fumarate) and resisting arrest.
