

## Wrecked, revoked and on the run

## Jailed

According to the reports, Trooper Robert Woody, THP reported the passenger was a suspect in a vehicle, which had alerted the Trooper while on I75 and a check of the alert showed the current registered driver to have a revoked license. The trooper then paced the vehicle at 70mph in a 65mph zone and made a traffic stop. The trooper made a passenger side approach to the vehicle and observed the window was broken out and the registered owner Richard Davis was the passenger. The trooper went to check out the driver, Jessica Leigh Clark as well as Mr. Davis. When the trooper returned he informed the duo he was deploying his K9 Jesse and asked

if they had anything to give up. The driver, Ms. Clark gave the trooper a bottle, which contained 71 hydrocodone. During an interview Mr. Davis reported they had a drug problem. During a check it was found Mr. Davis had outstanding warrants from McMinn County and was taken into custody. Ms. Clark performed poorly on sobriety tasks and refused

A search was conducted and a large sum of currency was found around a cell phone that both suspects used. The money totaled \$2235.

At the jail it was learned that Davis had a bottle of oxycodone in his buttocks. Also located was a small bag of marijuana.
