





of 31 years, Cheryl, his daughter and son-in-law, four grandchildren and a host of family and friends.




## Busted

According to the reports, Investigator Kevin Condee, LCPD observed a gray Chevy S10 pickup on Kelsey Lane. The vehicle had a temporary tag that was expired and

stopped it. The driver was identified as Jonathan Michael Hobbs and the passenger was identified as Bruce Russell Meddings. During the course of the traffic stop investigators developed suspicion that Hobbs and Meddings had been obtaining pseudo ephedrine for an unlawful purpose. The investigator asked Meddings if he would step out and reported he has a carry permit and was armed. The investigator brought Mr. Meddings out of the vehicle and removed

a loaded Smith and Wesson .40 cal pistol from Meddings front waistband. Meddings and Hobbs were both advised of their rights and both subsequently admitted they had purchased pseudo ephedrine with the intent to sell it for \$75 to a third party in Sweetwater for the purpose of manufacturing methamphetamine. Hobbs consented to a search of his vehicle and two boxes of pseudo ephedrine product, was found inside the vehicle. Mr. Hobbs told investigators they had obtained a lithium battery also to be sold for manufacturing meth. Hobbs directed investigators to look in the air vents and they found a lithium battery in the middle of the dash behind the vent.

Jonathan Michael Hobbs, 20, of New Highway '68, Sweetwater and Bruce Russell Meddings, 26, of Sweetwater Vonore Road, Sweetwater, were charged with promotion of methamphetamine manufacturing. Investigator Kevin Condee, LCPD made the arrests.

## Brewster

According to the report, THP initiated a pursuit on a white Jeep Cherokee. While in the area Deputy Chris Bowen, LCSO observed the vehicle coming in his direction on Old Kingston Road and attempted to stop the vehicle by posi-

tioning across the yellow line. The vehicle avoided the patrol car by going off the roadway and into the grass. The deputy turned around and activated his emergency equipment and the vehicle fled and continued onto Hotchkiss Valley Road and onto Huffs Ferry Road and parked in a wooded area.

Deputy Bowen arrived on the scene and identified the abandoned vehicle and Deputy Michael Watkins and his K9 along with Investigator Shane Ezell started tracking the suspect. A passer by told Deputy Bobby Hamilton Randy Brewster and a companion had exited the woods around the club house. Lt. Patrick Upton, Lt. Paul Curtis and Deputy Billy Hall responded to the area. Another individual notified Deputy Hamilton the suspects were inside the clubhouse at Riverview Golf Course. Deputy Bowen then responded to the clubhouse and identified the driver as Randy Brewster II. A check of his license showed them to be suspended. He was accompanied by a white female identified as Beth Ann Hensley.

Randy Phillip Brewster II, 18, of Mountain View Road, Sweetwater, was charged with driving while suspended and felony evading arrest. Deputy Chris Bowen, LCSO made the arrest.

trolle purchase of what was sold as four 30mg schedule II Kadian pills for \$40 from Angel Michaeu at her grandmothers house located

in Oakwood Apartments, Lenoir City. This controlled buy was accomplished using a confidential informant who has knowledge of

the unlawful business of illegal drug sales. The CI has proven to be credible and reliable as well as other law enforcement officials within the 9th district and other locations. The CI has assisted in numerous previous drug investigations in which convictions for drug related offenses have been the result. This controlled buy was audio recorded by the 9th DTF and the pills purchased were

later identified by the TBI crime lab as being a "non controlled" substance.
