rant, filed by Sgt. Detective Charles Cosner, LCSO CID; on January 31, 2013 the victim reported her former boyfriend continues to harass her by telephone, voicemail, and

text messages after he had been informed by the victim not to contact her again. The former boyfriend, identified as Ronald Ruzic, Jr. was contacted by Sgt. Cosner regarding the formal complaint and was informed to cease contact with the victim and he acknowledged he understood the consequences for further continuance of unwanted contact with the victim.

The victim made an additional report in March stating Mr. Ruzic continues to harass

her by phone, voicemail and text disregarding the issued warnings by both the victim and Detective Cosner to cease all contact. The victim received 44 unsolicited text messages from Mr. Ruzic on March 1 and the victim received 22 more unsolicited messages 15 of them within one hour. This harassment has created undue emotional distress on the victim.

Ronald Ruzic, Jr., 43, homeless, was charged with stalking. Corporal Michael Wilson, LCSO made the arrest at the McMinn County Jail.






The price has been paid and your options consist of two; life with Jesus or life without Jesus. I choose Jesus Because He lives!


