The deputy identified the driver as John Hester, Mr. Hester had watery bloodshot eyes, and a strong odor of alcohol on his person.


The deputy identified the passenger as Tyler Hughes, Mr. Hughes also had watery bloodshot eyes and a strong odor of alcohol.





Article 3 of the Bill of Rights, in my opinion, is one that can either be a blessing or a curse. Property rights are a hard thing to come by in most every country but America, and this amendment is a touchy subject when involving personal choice and belongings.

Article III

No soldier shall, in time of peace, be quartered in any house, without the consent of the owner, nor in time of war, but in a manner

to be prescribed by law.

I am not as familiar with this amendment as many of the others, simply because I have been quite a lucky lady and have never been alive during a domestic war. However; my parents were present for the Vietnam War where several of-age soldiers were trying to dodge the draft, and in my interpretation of this amendment, it would have affected any family that had housed or attempted to house a draft dodger at that time.




leave of absence to visit family or friends, as long as the government signs the leave of absence slips and knows how to track you down should you go AWOL and not return.
