#### Wanted







ing over 5,000 bills in a four moth time period. That being said, several bills caught my attention and several bills made it to the house floor after much debate in sub and full committees. Once to the floor, a more "political" debate ensues, allowing minimal actual debate and more of a newsworthy comment or two. During these floor debates, I watched next Bill, number VIII. as several members decided to vote for or against something based partly on the fact the opposition would not stop punishment inflicted. complaining. Hours of unnecessary commentary and debate over a bill they eventually voted for anyway.

This is eventually how the US Congress passed the Bill of Rights. Additions to the Constitution were not popular, even among supporters, however; once the opposing men began to ramble

on and on about why the people didn't need a Bill of Rights, it was added and approved. Sometimes I believe it is just better to keep your opinions to yourself if you truly do not want someone or something to be successful, do not take the time to discuss or debate it. I am sure glad our Congress did and that leads me to our

Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual

As we can determine from the basic writing of this statement, it is on a case by case basis these punishments are determined. No matter the efforts of our judicial system, we cannot legislate morality, only offer a guideline by which to punish immoral acts. That being

said, let us try to determine for ourselves what this means.

What is considered excessive bail? One million dollars is excessive to a minimum wage employee, but not to a multi-million dollar earner. What is considered excessive? Is there a percentage based on how heinous the crime? What about excessive fines? The difference is bail allows you to leave jail in wait for your court date and / or trial and fines are imposed during said court date/trial. The answer here is yes - sort of.

In Waters-Pierce Oil Co. v. Texas, 212 U.S. 86 (1909), the Supreme Court held that excessive fines are those which are "so grossly excessive as to amount to a deprivation of property without due process

of law." The Court wrote in its syllabus:

The fixing of punishment for crime and penalties for unlawful acts is within the police power of the state, and this Court cannot interfere with state legislation in fixing fines, or judicial action in imposing them, unless so grossly excessive as to amount to deprivation of property value or determination without due process of law. Where a state antitrust law fixed penalties at \$5,000 a day, and, after verdict of guilty for over 300 days, a defendant corporation was fined over \$1,600,000, this Court will not hold that the fine is so excessive as to amount to deprivation of property without due process of law where it appears that the business was extensive and profitable during the period of violation, and that the corporation has over \$40,000,000 of assets and has declared

dividends amounting to several hundred percent (David F. Forte. 'The Heritage Guide to the Constitution: Cruel and Unusual Punishment")

about How cruel and/or unusual punishment? Who determines what cruel is? Can you as a voter be objective enough to look at a case and ask yourselves, what if that were my family member? Would I want the same punishment given to them as I would to an unknown person that committed a like crime? Would life in prison be as cruel as the death penalty? Should capitol crimes such as rape, murder and child molestation be more severe than others? How about the 9/11 attackers? As a patriot could you have made the decision to or not to torture a terrorist? What if that person were your family? What would you want then?

I am not asking these questions to provoke your anger but merely to provoke the thought process a Federal Judge who is required by law to see things as fairly as possible. It is quite a difficult task to endure. There are special considerations for every crime committed as history unfolds and adapts

to the changing climate of politics and beliefs, but one thing remains quite certain. Without the guideline of the Bill of Rights, our government could make each determining punishment more or less a personal decision and not one of objectivity.
