Justin May, 20, Cairn Circle Knoxville, was charged with Responsibility Act,

Diego Guzman, 20, Calloway Circle Lenoir City, was charged with responsibility act.

Ally Grubb, 18, Pleasantwood Drive Knoxville, was charged with, 18 - 21 responsibility act, Contributing to the Delinquency OF A Minor, Simple Poss, Poss. Of drug Para.

Harley Mathews, 20, Harvey Road Kingston, was charged with Re-

sponsibility Act, Evading arrest, and Resisting arrest.

Jordan Carlson, 21, Pine Top Rd. Lenoir City, was charged with Disorderly Conduct.

Trevor Cutts, 21, Scenic Drive Greenville, was charged with Disorderly conduct.

Deputy Chris Hutchens LCSO was dispatched to a medical call, that someone was bleeding from the head. Medics arrived on scene just prior to Deputy arrival and were canceled by the person who called 911, but the medics did state they believed there was a party at the address.

Once the Deputy arrived on scene there were several people standing outside on the porch and once they realized Deputy's car was a police car several of the persons be-

gan running back into the house. There were 21 persons at the residence and the subject who needed medical attention had major lacerations to his eye and appeared to have a concussion. Medic units were called back to the scene and he was transported to the emergency room for treatment.

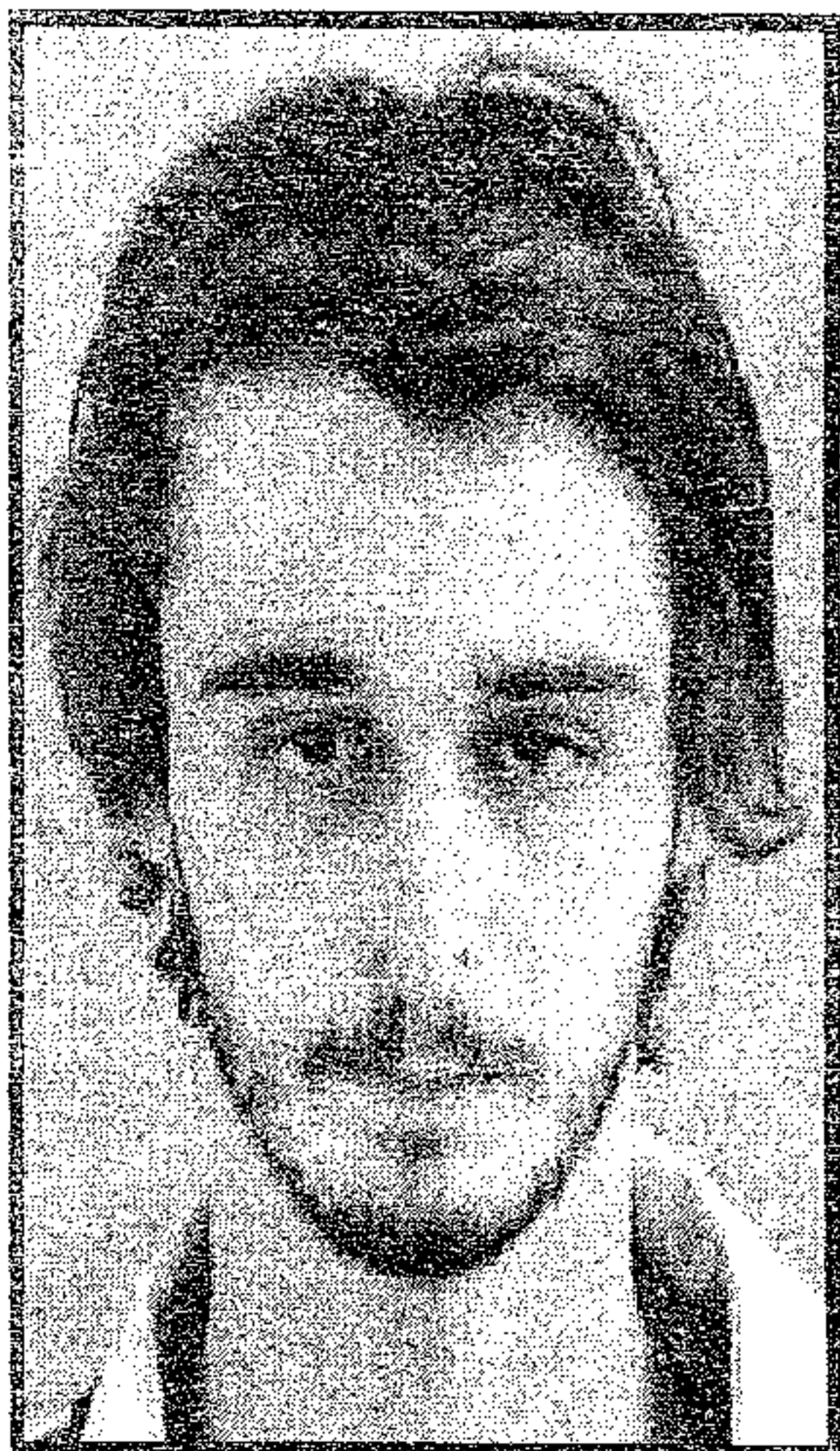
There was a strong odor of marijuana emitting from the open door of the house and the home owner signed a consent to search form for the residence and directed Deputies to approx. 8 grams of marijuana, as well as 2 marijuana grinders and one marijuana pipe. In another room was found 2 handguns, due to the nature and high level of intoxication of the rest of the parties present these firearms were taken into custody

for safe keeping. There were found to be two juvenile females at the party, both were highly intoxicated. One juvenile was hiding in a car with Ally Grubb, in which both were smoking marijuana in the car. The car belonged to Ally Grubb. Both juveniles and Ally Grubb were arrested.

There were 3 males found to be under the age of 21 who were highly intoxicated and refusing to comply with commands from officers on scene and became belligerent, Mr. Justin May was arrested, and then Mr. Diego Guzman was arrested after exposing his genitalia to everyone there. The third underage male, ID was found in a vehicle, when Deputy asked who was the name on the Id, he got up and

fled on foot down the driveway and onto Highway 11. The Juvenile was pursued on foot by Deputy Hutchens and Sgt. Jerramie Bowen (in his vehicle). The juvenile was apprehended approx. 200 yards from the house. Two adult males Mr. Jordan Carlson, and Mr. Trevor Cutts, were also refusing to comply with orders from Officers and Mr. Cutts even returned with a new beer after being allowed to go to the restroom, both subjects were acting very belligerent.

The rest of the subjects were checked for sobriety and those who were sober were allowed to leave and those who were not were instructed to remain at the house. Deputy Chris Hutchens LCSO made the arrest.

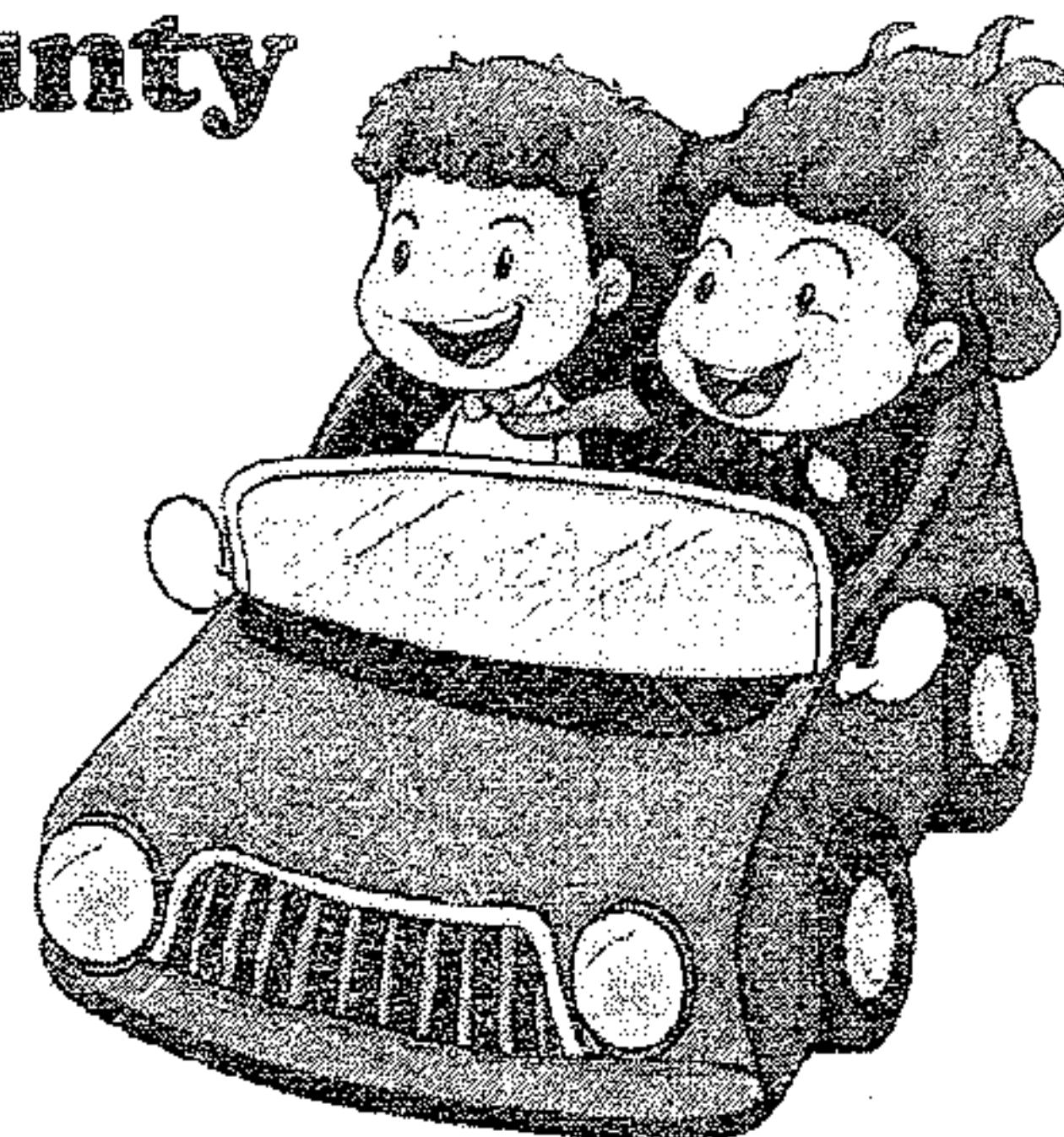

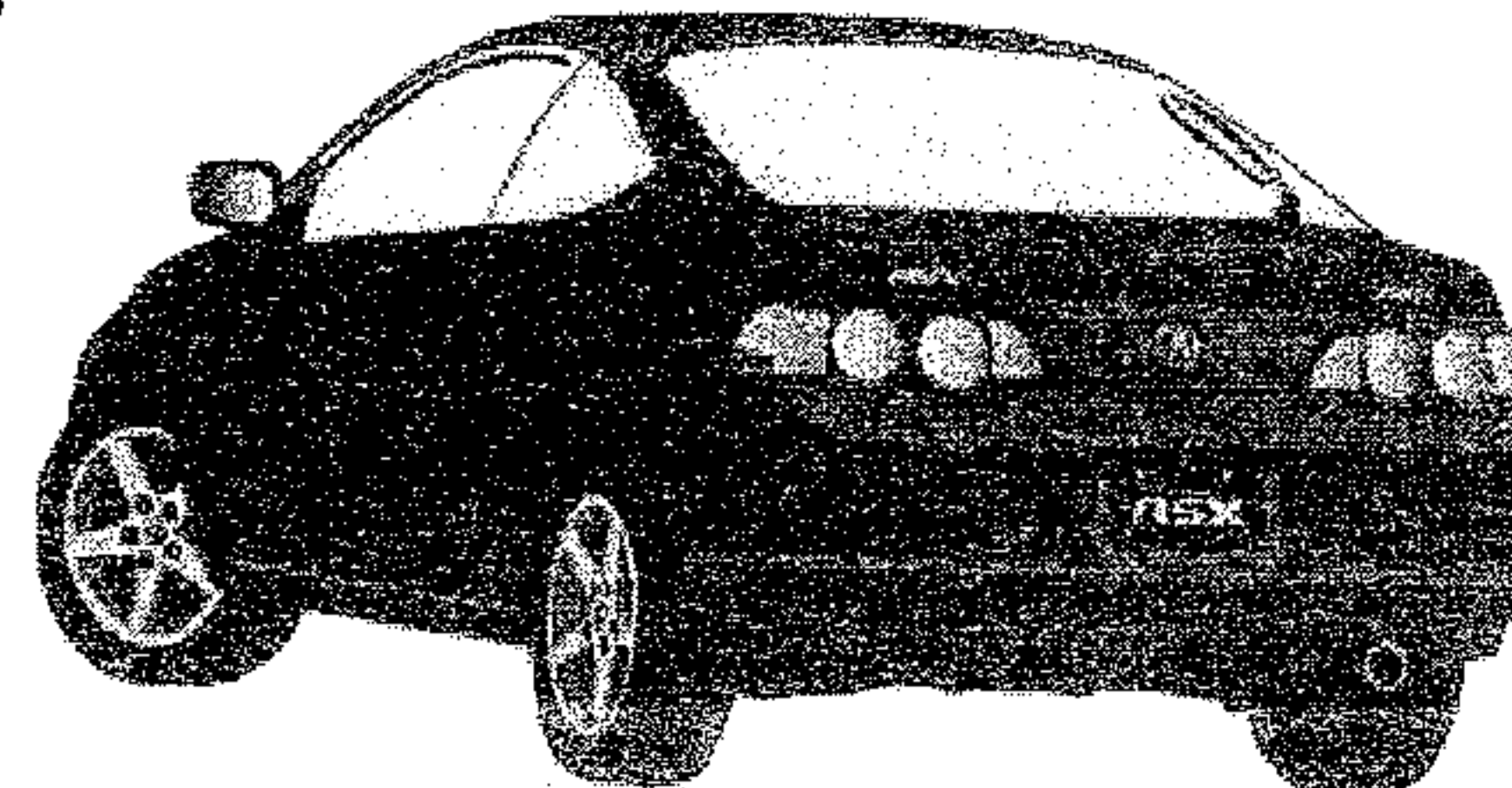

According to the report a traffic stop was conducted on a black vehicle with Pennsylvania tags. The vehicle was traveling 51 mph in a 40 mph zone. The vehicle came to an abrupt stop in the middle of HWY 321 to pull into a parking lot appearing to be attempting to avoid a Lenoir City Officer car from being behind him. SGT. Eddie Range conducted a traffic stop on this vehicle and identified the driver as Robert Flanagan.

The passenger of this vehicle was found to be Christopher Gracie. A check through local agencies found that they both had outstanding warrants for their

arrest. Robert was very fidgety and sweating while outside temp was approx. 50 degrees.

Mr. Flanagan was asked to perform a series of field sobriety test after the completion of test it was believed that he was under the influence of Meth. Flanagan admitted to smoking Meth hours before this stop.

During the investigation it was found that Christopher Gracie conspired with Robert to sell \$200 dollars of crystal meth to several individuals just prior to the stop. Several drug Para. items was found in the vehicle.

9th DTF Agent Brendan Deboer was called in and made the arrests.
