travel abroad in pursuit of Christians, Paul (Saul at the time) was headed to Damascus to arrest any followers of Christ he could find and bring them back to Jerusalem to be imprisoned or killed.

As he traveled towards Damascus, a great light appeared from heaven and he was confronted by the presence and voice of

Jesus Christ for persecuting believers. Jesus caused him to be blind for a time and sent him into the city to wait for further instructions.

While Saul was blind and sitting in the house of Judas, Jesus spoke to a Christian named Ananias, telling him to go visit Saul and lay his hands on him so that he might receive his sight.

Ananias had heard of Saul, he knew what Saul had been doing to Christians and he

relayed his fear to Jesus during this conversation that occurred through a vision. Read for yourself how he does this and pay close attention to Jesus' response to him;

Acts 9:13-16 (NKJV)
Then Ananias an-

swered, "Lord, I have heard from many about this man, how much harm he has done to your saints in Jerusalem and here has authority from the chief priests to bind all who call upon Your name."

against Him and knew that Saul was on his way to beat, imprison and maybe even kill many more Christians. Yet Jesus referred to Saul as a "Chosen vessel of Mine".

Ananias did as Jesus commanded so that Saul's sight was restored and he believed on Jesus from then on. Saul, now called Paul, then spent time with the disciples and later began to spread the gospel of Jesus Christ to many nations. He is credited with writing thirteen (possibly fourteen) letters to new churches and Christians that are included as part of the New Testament. Paul himself was later imprisoned for his faith in Christ and history indicates that he was eventually beheaded.

If Jesus can change the heart and life of a ruthless (see Int. ctd. pg. 8)

But the Lord said to him, "Go, for he is a chosen vessel of Mine to bear My name before Gentiles, kings and the children of Israel. For I will show him how many things he must suffer for My name's sake."
