





Meth

Christopher Evans, 26, Garrett Road, Madisonville, was charged with Promotion of Methamphetamine Manufacture.

Tracy Callison, 42, Lake Brooke Drive, Vonore, was charged with Manufacture/sell/poss. Of controlled substance.

According to the report, Deputy Chris Hutchens LCSO, stopped a Pontiac Grand Am at Highway 411 in the intersection of East Coast Tellico Parkway for traffic violations. During the traffic stop, Deputy Hutchens advised the female driver of the vehicle tossed what appeared to be an active meth lab across the guardrail near where Deputy Hutchens was standing.

Investigators with the Narcotics Unit were called to the scene and confirmed that the bottle was an active one pot shake bottle. The driver of the vehicle was identified as Tracy Renea Callison and the passenger was identified as Christopher Allen Evans.

Deputy Hutchens deployed K9 Dante to conduct a sniff of the vehicle for the odor of illegal narcotics. K9 Dante alerted to the presence of the odor of illegal narcotics in the vehicle.

During a search, 15 coffee filters, 1 funnel, 5 pairs of pliers, 1 lithium battery, 5 syringes, a roll of electrical tape, a small plastic canister,

a piece of tubing with a bottle cap on one end, and two pieces of aluminum foil were found in a black Sentry safe in the trunk of the vehicle. 1 lithium battery, 1 syringe, 1 pair of pliers and 1 funnel were found in Callison's purse. These items are commonly used in the production of methamphetamine.

During a Mirandized interview, Callison advised the one pot shake bottle was hers and Evans had no knowledge it was in the car. Callison advised she is a meth cook and produces methamphetamine on a regular basis.

During a Mirandized interview, Evans advised he may have placed the black Sentry safe with the items used to produce methamphetamine in the trunk of the vehicle.

Investigator Marty Stanley LCSO, made the arrests.
