contact with Mr. Abron.

Mr. Brown was also inside the residence Deputy Jenkins and Deputy Hutchens asked Mr .Brown several times to step back Mr. Brown did not comply with the orders and on several occasions stood in the way putting Deputy Jenkins and the other Deputies in danger. Mr .Brown also made several threats to Deputy and his family. Deputy Hutchens, Burley and Jenkins entered the backroom where Mr. Abron was located and did observe Mr. Abron was trying to flee out of the bedroom window. Mr. Abron was ordered to come back from the window at which point he stated that if he anyone touched him he would "knock them the f&#4



out". Mr. Abron was pulled back from the window, at which point he did strike Deputy Burley in the face with a closed fist. During which time Deputies Burley and Hutchens were attempting to gain control of Abrons using the minimal amount of force necessary. Mr. Abron continued to resist arrest striking Deputy Hutchens in the face several times with his elbows and kicking Deputy Burley with his legs. The amount of force being used proved ineffective at which time Deputy Burley did dry stun Mr. Abron in the



onto his stomach and gain effective control by Deputy Burley securing his right arm and Deputy Hutchens gaining control of his left arm, and then placing him in custody. During the struggle Courtney Brown continually attempted to prevent Deputies from arresting Abron and did strike Deputy Burley in the head with a flashlight. Once Abron was arrested Courtney Brown then did take the original warrants we were there to serve and hid in the bathroom with them refusing to relinquish them. She finally did release the warrants and Mr. Abron was secured and transported to the Loudon County Jail. Deputy Chris Jenkins LCSO made the arrest.

Wesley Allen Whaley. Mr. Whaley stated that he had smoked one joint when his car broke down on his way to Atlanta. Deputy Hutchens arrived

on scene and deployed his K-9, Dante. Dante did alert to the vehicle. A search of the vehicle was performed and inside the passenger compartment

of the vehicle, there was one cigarette holder containing two marijuana joints, one marijuana grinder and one pack of rolling pappers.

Also, inside the trunk, there was a duffle bag. containing a tea cylinder inside the cylinder there was two separate bags marijuana weighing approximately 21.8 grams, as well as a set of digital scales. There was also a tackle box in the back right corner of the trunk, inside the tackle box there was a glass mason jar with two bags of marijuana weighing approximately 55.8 grams, and two bags of Mollie (MDMA) weighing approximately 6.6 grams, and two small plastic bags containing a round white pill in each, imprinted with Watson 749, which was identified as oxycodone,

a schedule II substance. There was a Crown Royal bag inside the tackle box which also had 11 small bags containing Mollie(MDMA) with a total weight of approximately 1.8 grams. Lastly in the box was 5 empty bags containing residue, 2 packs of rolling papers, and 2 bags containing marijuana seeds. In a separate bag, rolled into rolls of \$100 was \$500, and Mr. Whaley had \$77 on his person, a total of \$577.






