



Trooper Eric Miller THP made the arrest.









Richard Brotherton, 39, Corinth Church Rd. Loudon, was charged with Possession of drug Para., and Poss. Of a handgun while under the influence.

Bennett, 39, Hubert Corinth Church Road Loudon was charged with Poss. Of Drug Para. and convicted felon in possession of firearm.

Deputy Brandon Burley LCSO, did respond to Corinth Church Road to a possible breaking and entering call. Upon arrival Deputy Burley did observe the front door open with foot prints in the fresh snow exiting the house.

Deputy Burley and Deputy Ketner did clear the house and came into contact with Hubert E. Bennett laying in the bed of a bedroom. Bennett acknowledged that he had a loaded firearm in the bed with him. The firearm that was recovered is a High Point 9mm rifle with 1, 9mm round in the chamber and 1, 9mm round in the magazine. Bennett has previously been convicted of Domestic Violence convicted on 04/07/2004 and also on 05/03/1996 in Loudon County,. Richard Brotherton, the owner of the residence and the complainant who called Loudon County E911 returned to the house and advised that per Loudon County E911's request he unloaded his firearm and left it at his mother's house next door. During the course of the investigation, Brotherton did admit to having used Hydrocodone and Oxycotin

prior to his handling of the firearm. Brotherton was extremely incoherent, unsteady on his feet with red bloodshot eyes. Brotherton advised that he had been up when he heard voices, these voices caused him to exit his house and discharge multiple rounds from his Smith and Wesson .40 Caliber handgun in the vicinity of his residence without regard for the safety of his roommate (Hubert E. Bennett) who was asleep inside the residence. Bennett advised that he did hear the firearm discharge at least two times, as well as Deputy Ketner did locate multiple shell casings. During the course the investigation Bennett advised Deputy Ketner to the presence of narcotics and narcotics paraphernalia in the residence. After speaking with the homeowner, Richard Lee Brotherton, he consented to a search

of the residence which

yielded aluminum foil, a butane lighter and a spoon with a white residue on it. Bennett advised the white residue to be Hydrocodone. Deputy Brandon Burley LCSO made the arrest.





While in the back of the Loudon County Sheriff's Department patrol vehicle Lonas did (see domestic ctd.pg. 8)


