One dead in shooting; no charges filed...yet

In reference to the Homicide that occurred in Lenoir City on Wednesday, October 22, 2014 at approximately 6:30 pm:

The Lenoir City Police Department was dispatched to a shooting call on the West end of the City. Upon arrival the officers discovered one white male subject that appeared to have been shot.

The subject's name is Michael Brown, who

was immediately transported by EMS to the hospital where he was pronounced dead. The shooter's name is Taylor Johnson. This investigation is still in progress and no further information can be released.

An autopsy on Michael Brown has been ordered. No arrests have been made at this time pending further investigation.



During the verbal altercation, both parties exchanged their opinions of the situation and according to witnesses, victim told Ms. Adams that she was not giving her the television remote control and that if she wanted it she would have to take it from her.

Ms. Adams approached victim, struck her several times about her face causing her to fall to the ground. While on the ground, Ms. Adams grabbed victim head and started violently striking her head against the concrete floor of the cell block. Other inmates did notify jail staff and corrections officers immediately intervened.

Corrections officers did notify the facility nurse who rendered aid until Rural Metro EMS arrived on scene. Based on the condition of victim, the Rural Metro supervisor requested the assistance of LifeStar to medivac victim to the University of Tennessee Hospital where she did receive medical care for head injuries. Claudett Flores, 33, Harrison Road Lenoir City, was charged with DUI, and Violation of Implied Consent.

Jennifer Flores, 29, Harrison Road Lenoir City, was charged with Public Intoxication and Resisting Arrest.

Deputy Brandon Burley LCSO, did observe a red Suzuki sedan on Harrison road traveling over 50 miles per hour in the 30 mile per hour zone as well as the aforementioned vehicle was swerving and was unable to maintain its lane. Deputy attempted to conduct a traffic stop on the above vehicle on Harrison Road before Chestnut Ridge; however, the vehicle continued driving until it arrived at 5454 Harrison Road.

During the initial approach Deputy identify the driver, Claudette Flores and front seat passenger (her sister) Jennifer Flores. Deputy did detect the odor of alcoholic beverage upon the driver which was more pronounced when she (Claudette Flores) would speak. Claudette did also have trouble locating her documents, have slurred speech, red / watery bloodshot eyes and a difficult time multi-tasking. Claudette did admitting to having consumed multiple alcoholic beverages and agreed to perform standardized field sobriety tasks.

Claudette did poorly on all standardized

field sobriety tasks providing multiple clues during each task. Based on Claudette's driving, personal contact with Deputy, as well as providing multiple clues on the standardized field sobriety tasks Claudette was placed under arrest for driving under the influence 1st offense. Once transported to the Loudon County Jail Claudette was read the Tennessee Implied Consent advisement as well Claudette did then read the form herself before refusing to provide a breath sample. Deputy did ask Claudette why she would not provide a breath sample and Claudette stated "Because I'm over (the limit) to drive." During the entirety of the traffic stop Jennifer who was in passenger did make multiple profane outbursts and attempt to exit the vehicle after being told to stay inside the vehicle for officer safety. Jennifer had a very strong odor of alcoholic beverage upon her person and Claudette did state that Jennifer was extremely intoxicated and has an alcohol abuse prob-

lem. Eventually Jennifer was told to exit the vehicle in order to attempt to control her loud profane outbursts. While standing next to Deputy patrol vehicle with Officer Halsey, Jennifer did continue to have outbursts and attempted to interfere with Deputy standardized field sobriety tasks on Claudette. Jennifer was told to turn around by Officer Halsey when Jennifer became combative, attempting to pull away and turn around on Officer Halsey and Deputy. Deputy did place handcuffs on Jennifer and while opening the rear door of the patrol car

Jennifer again tried to pull away and make a kicking motion towards Officer Halsey. Jennifer was placed in the backseat of the patrol car where she continued to kick, scream, and cause a disturbance. Jennifer was a danger to herself and others by continuing to cause a disturbance in a residential area and interfere with a police investigation. Deputy Brandon Burley LCSO, made the arrest.
