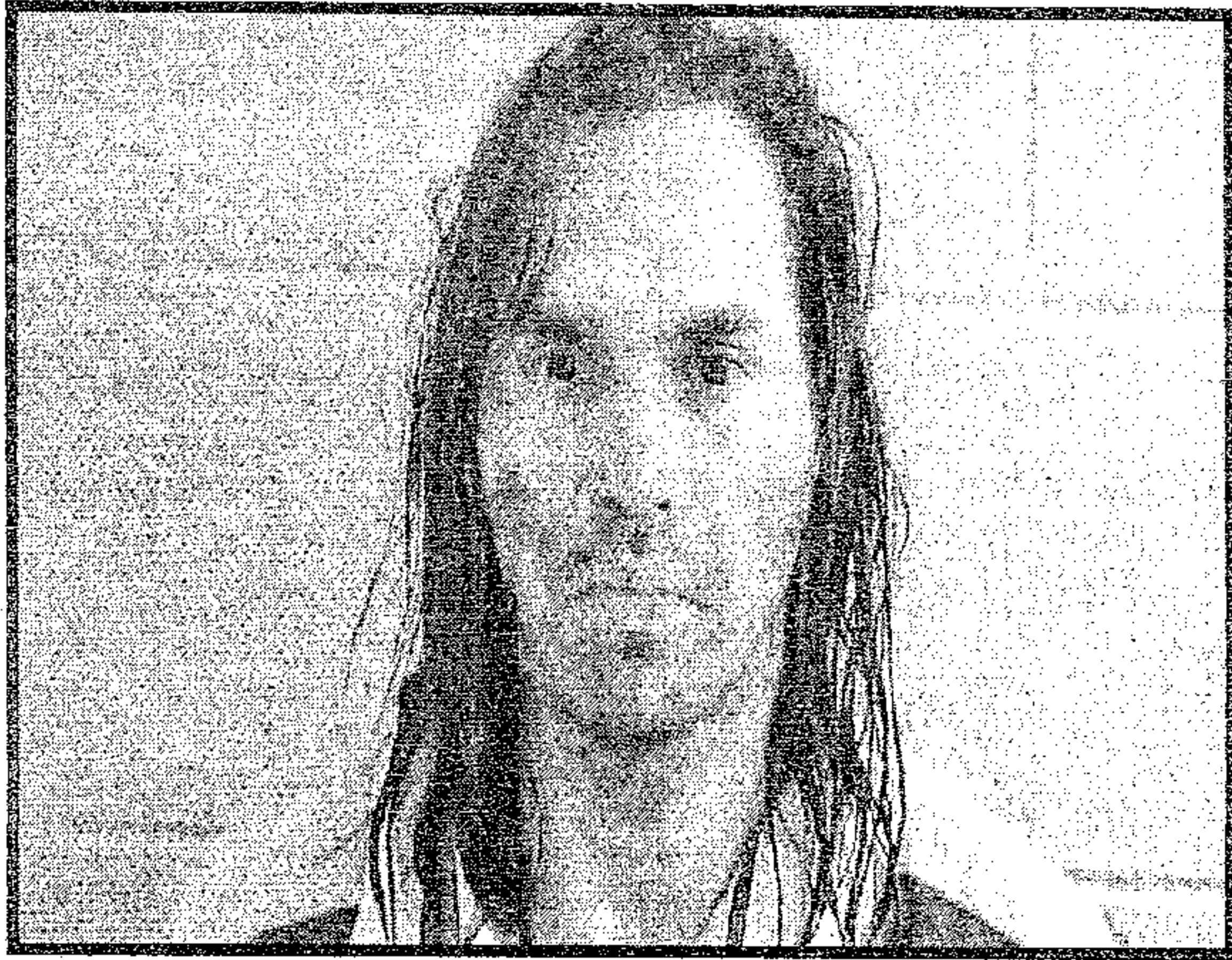

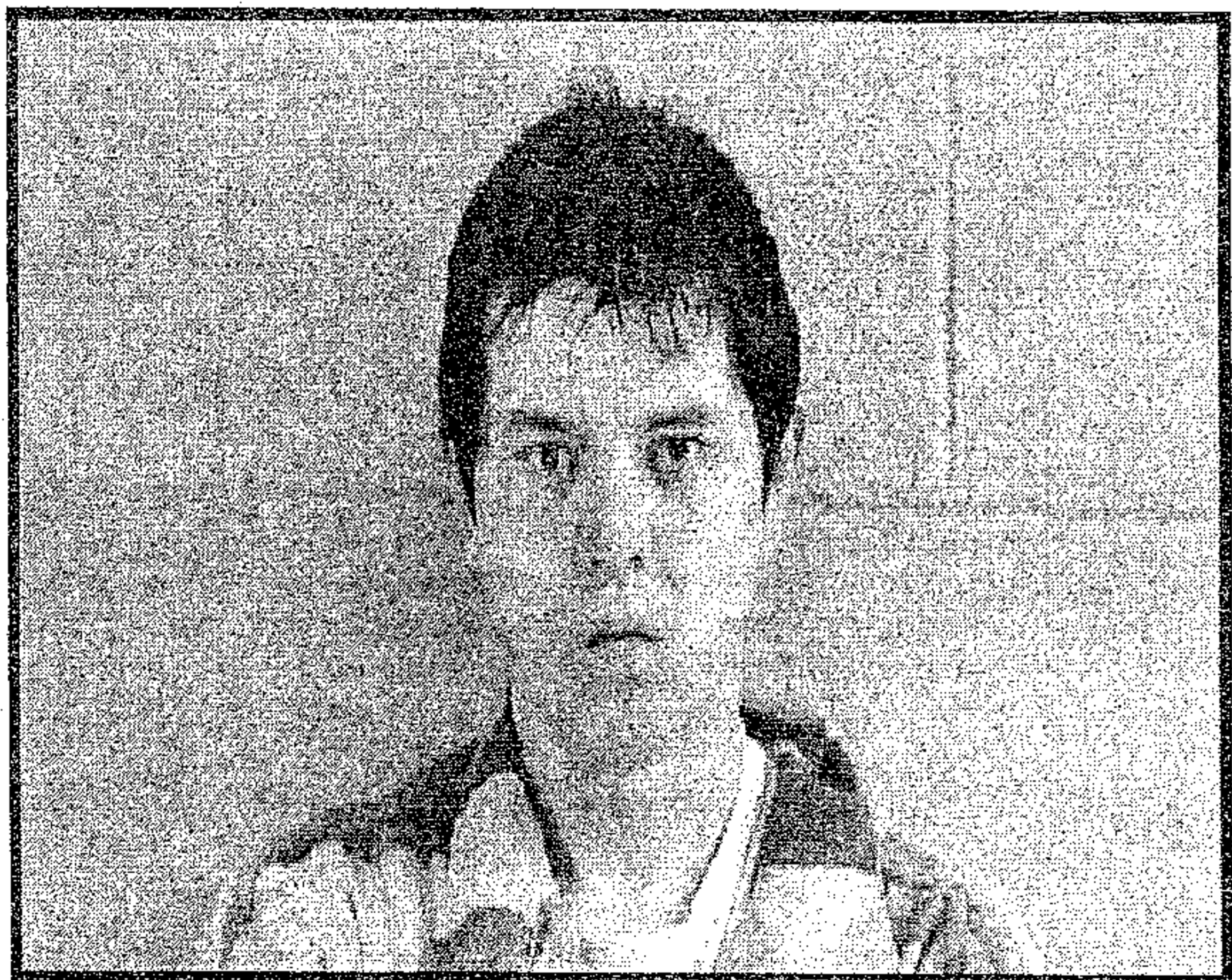

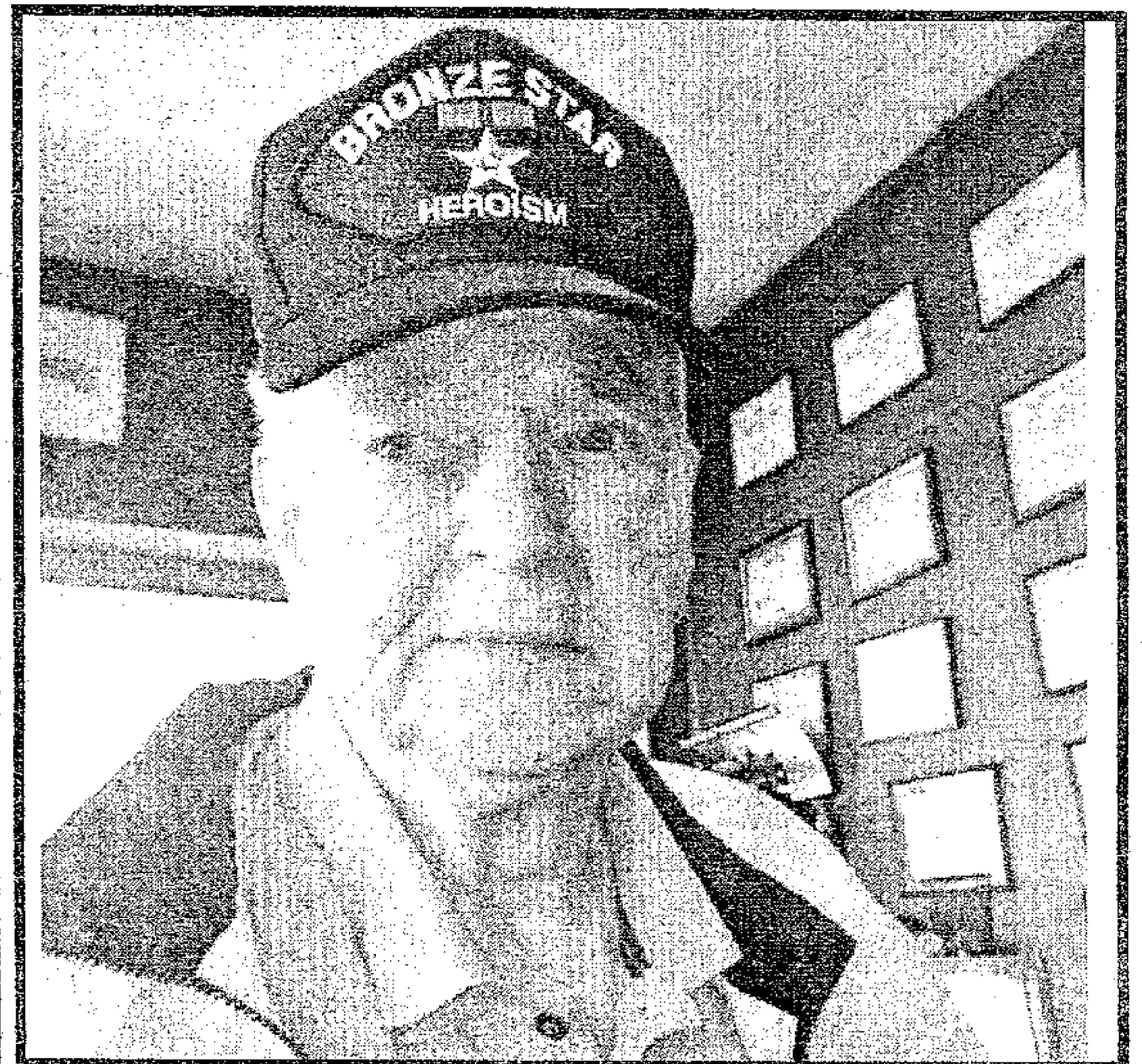
Choose Carefully
