times and placing his foot down on the one leg stand. Deputy arrested Mr. Padgett for D.U.I.

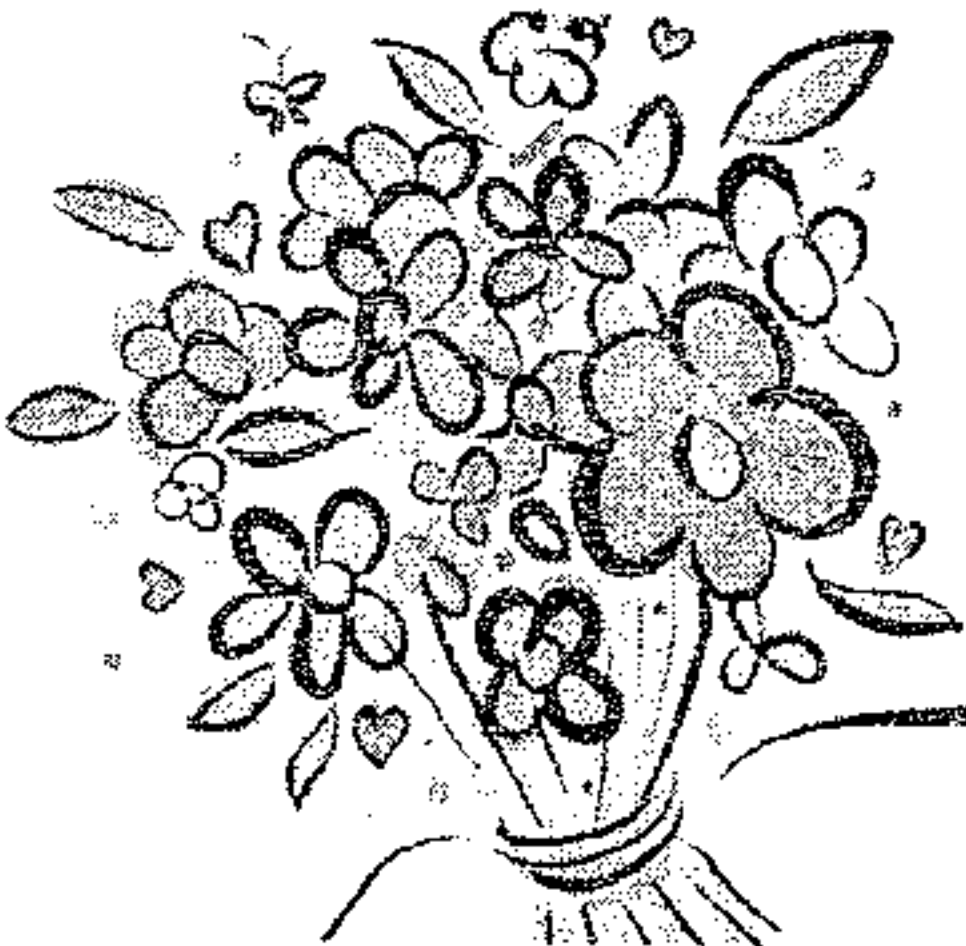
