Upon arrival, contact was made with victim who advised me that her ex boyfriend, Robert John Davis, had left about 10 minutes prior to arrival in a black SUV. Victim was crying uncontrollably and appeared to have trouble catching her breath. She stated that Davis contact-

ed her and wanted to continue their relationship and she replied no.

The victim further reported, she then saw Davis standing outside her place of employment next to her Jeep, with a baseball bat. She could hear the baseball bat striking her car through the telephone. She repeated asked Davis to leave, at which time he threatened to go to her parents house.

According to her statement, he stated he was going to burn down her house, beat her butt, and break her neck. Victim also verbally stated that she was afraid he was going to hurt or kill her, placing her in fear for her life and safety.

Two dents were observed on the driver door of the Jeep. A foot print was observed on the passenger side door.

Contact was then made with Robert John Davis at his residence of Shaw Ferry Road. He was leaving the residence with clothes matching the description given by victim.

The shoes Davis was wearing matched the print left on the

passenger door of the Jeep. A baseball bat was found inside the residence where he was staying. A black Ford Escape was also found parked outside. Due to physical evidence and victim/witness statements, Robert John Davis was found to be the primary aggressor and was taken into custody. Deputy Charlie Parker LCSO, made the arrest.
